

**RESOLUTION NO. 2025-48**

**RESOLUTION OF THE BOARD OF SUPERVISORS  
OF SAN BERNARDINO COUNTY TO  
ESTABLISH “NO PARKING” ZONE OF COMMERCIAL VEHICLES HAVING A GROSS WEIGHT  
RATING EXCEEDING 10,000 POUNDS ON PORTOLA STREET  
IN THE MUSCOY AREA**

On Tuesday January 29, 2025, on motion of Supervisor Hagman, duly seconded by Supervisor Baca, Jr. and carried, the following resolution is adopted by the Board of Supervisors of San Bernardino County, State of California.

**WHEREAS**, the Department of Public Works completed a traffic engineering investigation regarding the parking of commercial vehicles along and around Portola Street in the Muscoy area; and

**WHEREAS**, the Board of Supervisors is authorized to establish parking restriction on County roads pursuant to County Code Section 52.0128(a); and,

**WHEREAS**, the Board of Supervisors desires, based upon the traffic engineering investigation, to establish a parking restriction on Portola Street in the Muscoy area.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Supervisors of San Bernardino County as follows:

1. Due to conditions affecting the welfare of the public utilizing Portola Street in the Muscoy area, the Board of Supervisors, pursuant to a traffic engineering investigation, deems it necessary to:
  - a. Establish a “No Parking” zone of commercial vehicles having a manufacturer’s gross vehicle weight rating exceeding 10,000 pounds, pursuant to County Code § 52.0128(a), on Portola Street (669100).
2. Directs the County Road Commissioner to place appropriate signs specifying applicable prohibitions on such streets or entrances to the limited access residential communities thereof and to perform such acts as are necessary to implement the terms of the Resolution.
