IT IS HEREBY AGREED AS FOLLOWS:

WHEREAS, the County of San Bernardino (COUNTY) and the City of Needles (CITY) (COUNTY and CITY are also each referred to herein as "Party" and collectively referred to herein as "Parties") previously entered into County Contract No. 19-504 (herein after referred to as "the Agreement") wherein the parties agreed to jointly participate in a chip seal and a fog seal on Five Mile Station Road, from State Highway 95 to 1.76 miles southeast of State Highway 95, (herein after referred to as PROJECT);

WHEREAS, the COUNTY received a permit extension request from Pacific Gas & Electric (PG&E) to complete their Topock Compressor Remediation Project within COUNTY road right-of-way; and

WHEREAS, the COUNTY has approved the permit extension request from PG&E and the PROJECT will be completed by the COUNTY Department of Public Works Road Operations labor force after PG&E completes their Topock Compressor Remediation Project; and

NOW, THEREFORE, in consideration of the mutual covenants and conditions provided herein, the Parties hereto agree the AGREEMENT, County Contract No. 19-504, is amended as follows:


1. DELETE the existing paragraph 3.16 and REPLACE IT with a revised paragraph 3.16, which shall read as follows:  
  
3.16 This Agreement will be effective on the date signed by both Parties and shall conclude upon satisfaction of the terms identified in Paragraph 3.8 or June 30, 2023 (whichever occurs first).
2. All other terms and conditions of County Contract No. 19-504 remain unchanged.
3. The recitals of this Amendment No. 1 are incorporated into County Contract No. 19-504 by reference.
4. This Amendment No. 1 may be executed by the Parties in counterparts, all of which together shall constitute a single agreement.
5. This Amendment No. 1 to County Contract No. 19-504, is effective on the date it is approved and signed by both Parties.


