IT IS HEREBY AGREED AS FOLLOWS:

The San Bernardino County Fire Protection District (SBCFPD) and Corporate E-Waste Solutions (E-Waste) agree to amend Agreement No. 20-655 (Agreement) as follows:

Pursuant to Section C.2. of Agreement, the Agreement is amended to read as follows:

2. Section D. is amended to read as follows:

"D. TERM OF CONTRACT

This Agreement is effective as of September 14, 2020, and expires June 30, 2027, but may be terminated earlier in accordance with the provisions of this Agreement. The SBCFPD Fire Chief, may terminate this Agreement early without cause and for any reason with one (1) day advance notice provided to E-Waste."

3. The address for SBCFPD in Section J is deleted and replaced with the following:

San Bernardino, CA 92415."

All other terms of Agreement No. 20-655 shall remain in full force and effect.

This Amendment No. 1 to the Agreement may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterpart shall together constitute one and the same agreement. The parties shall be entitled to sign and transmit an electronic signature of this Amendment No. 1 (whether by facsimile, PDF or other email transmission), which signature shall be binding on the party whose name is contained therein. Each party providing an electronic signature agrees to promptly execute and deliver to the other party an original signed agreement upon request.
