AMENDMENT No. 1

Effective July 19, 2024, Contract 21-558 A-1 for Steven Mickel to provide necessary services as a Chaplain for the San Bernardino County Sheriff/Coroner/Public Administrator (Department or Sheriff) is hereby amended as follows.

1) By replacing Section III. TERM AND TERMINATION in its entirety, with Section III. TERM AND TERMINATION as follows:

III. TERM AND TERMINATION

This Contract shall be effective July 31, 2021 and shall remain in effect through July 30, 2025, subject to the termination provisions below. The Sheriff/Coroner/Public Administrator, Undersheriff, or Assistant Sheriff are authorized to execute amendments to this Contract to

extend the term for a maximum of one successive one-year period. Notwithstanding the foregoing, either party may terminate this Contract at any time without cause with a fourteen (14) day prior written notice to the other party. This Contract may be terminated for just cause immediately by the County. Contractor shall serve at the pleasure of the appointing authority, who shall have the full authority and discretion to exercise County rights under this paragraph.

2) By replacing subsection IV. B – SALARY ADJUSTMENTS in its entirety, with section IV. B – SALARY ADJUSTMENTS, as follows:

B. SALARY ADJUSTMENTS

Contractor shall be eligible to receive subsequent step increases of approximately 2.5% at the beginning of the pay period after each completion of 2,080 service hours hereafter, up to a maximum of \$20.44 per hour. All step increases are subject to approval of the appointing authority and based on a "meets standards" work performance evaluation. Contractor does not gain probationary or regular status during the term of this Contract. Payment for services shall be made bi-weekly during the term specified in Section III of this Contract.

3) By adding the following to Section VI. CONCLUSION:

This Contract, and if applicable, any subsequent amendments, may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterparts shall together constitute one and the same Contract. The parties shall be entitled to sign and transmit an electronic signature of this Contract (whether by facsimile, PDF or other mail transmission), which signature shall be binding on the party whose name is contained therein. Each party providing an electronic signature agrees to promptly execute and deliver to the other party an original signed Contract upon request.

Except as amended, all other terms and conditions of this contract remain as stated herein.
