Briefly describe the general nature of the contract:

Amendment No. 1 to Membership Agreement with the Board of Trustees of the Leland Stanford Junior University, on behalf of the California Perinatal Quality Care Collaborative / California Maternal Quality Care Collaborative, for access to resources to improve health outcomes in maternal and perinatal care, increasing the contract by \$95,000, from \$85,000 to \$180,000, and extending the contract term by five years, for a total contract term of October 22, 2020 through October 31, 2030.

First Amendment to Amended and Restated California Perinatal Quality Care Collaborative Membership Agreement

The Amended and Restated CPQCC Membership Agreement (the “**Agreement**”) effective as of October 22, 2020 (the “**Effective Date**”) by and between The Board of Trustees of the Leland Stanford Junior University, on behalf of the California Perinatal Quality Care Collaborative / California Maternal Quality Care Collaborative within the School of Medicine (“**CPQCC**”), and San Bernardino County on behalf of Arrowhead Regional Medical Center (“**Participant**”) is hereby amended as set forth below effective October 22, 2025 (“**First Amendment**”). [San Bernardino County is a political subdivision of the State of California operating Arrowhead Regional Medical Center, a hospital or surgery center.]

The purpose of this First Amendment is to extend the term of the Agreement and to revise or update certain other provisions of the Agreement.

1. **Terms.** Capitalized terms not defined herein shall be given the same meaning as set forth in the Agreement.
2. **Amendments.** The Agreement shall be amended as follows:
 - a. All references to “County of San Bernardino” in the Agreement are amended to read “San Bernardino County”.
 - b. Section 8.a “Term” is amended to add the following language: “After the Initial Term, this Agreement shall renew for an additional five (5) years through October 31, 2030 (“**Renewal Term**”).”
 - c. Section 9.a “Fees” and 9.b “Invoicing” shall be deleted in its entirety and replaced with the following; all other subsections of Section 9 remain unchanged from the previous agreements and amendments:

9. Fees and Payment.

- a) **Fees.** In consideration of the services provided under this Agreement, Participant agrees to pay CPQCC an annual membership fee for each participating hospital identified on Attachment E, upon invoice by CPQCC each year for the upcoming program year. The annual membership fee for 2025 is \$16,700.

Such membership fee each year thereafter shall be subject to an annual increase after reasonable notice from CPQCC to Participant. In addition, CPQCC reserves the right to impose certain reasonable late fees on Participant for late payment of the annual membership fee or late data submission of Participant Data.

- b) **Invoicing:** Once per year, CPQCC shall issue an electronic annual fee invoice to Participant at least forty-five (45) days prior to the due date indicated on the invoice to

the Participant contact(s) listed in the CPQCC database, which can be updated by the Participant online.

- c. Section 20 “Notices” is amended, in part, to update the contact information for CPQCC and the copy to for Stanford University’s Office of General Counsel:

3. **Entire Agreement.** The Amended and Restated CPQCC Membership Agreement, as previously amended, and including this First Amendment, contain the entire agreement of the Parties. It may not be changed orally, but only by an agreement in writing, signed by the Party against whom enforcement of any waiver, change, modification, extension, or discharge is sought.
4. **Binding Effect.** This First Amendment shall be binding on and inure to the benefit of the heirs, legal representatives, successors, and assigns of the Parties; it being understood, however, that the rights hereunder are personal to the Parties, and neither Party may assign its interest in or obligations under this First Amendment without the prior written consent of the other Party.
5. **Electronic Signatures.** The Parties to this First Amendment agree that a copy of the original signature (including an electronic copy) may be used for any and all purposes for which the original signature may have been used. The Parties further waive any right to challenge the admissibility or authenticity of this First Amendment in a court of law based solely on the absence of an original signature.
6. **Counterparts; Facsimiles.** This First Amendment and any subsequent amendment to it may be executed in counterparts and all of these counterparts together shall be deemed to constitute one and the same agreement. The parties shall be entitled to sign and transmit an electronic signature of this Agreement (whether by facsimile, PDF or other email transmission), which signature shall be binding on the party whose name is contained therein. Each party providing an electronic signature agrees to promptly execute and deliver to the other party an original signed Agreement upon request.
