

**RESOLUTION NO. 2021-148**

**RESOLUTION OF THE BOARD OF SUPERVISORS  
OF SAN BERNARDINO COUNTY  
TO ESTABLISH A NO PARKING OF VEHICLES/TOW-AWAY ZONE  
ON GLEN HELEN PARKWAY, LYTLE CREEK AREA**

On Tuesday August 10, 2021, on motion of Supervisor Baca Jr., duly seconded by Supervisor Rowe and carried, the following resolution is adopted by the Board of Supervisors of San Bernardino County, State of California.

**WHEREAS**, the Department of Public Works completed a traffic engineering investigation of Glen Helen Parkway in the Lytle Creek area; and,

**WHEREAS**, the Board of Supervisors is authorized to establish parking restrictions on County roads; and,

**WHEREAS**, the Board of Supervisors desires to establish a parking restriction on Glen Helen Parkway.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Supervisors of San Bernardino County as follows:

1. Due to conditions affecting the health and safety of the public utilizing Glen Helen Parkway (382400) in the Lytle Creek area, the Board of Supervisors, pursuant to a traffic engineering investigation deems it necessary and hereby resolves to:

Establish a "No Parking of Vehicles/Tow-Away Zone" pursuant to County Code Section 52.0132(a) along the north side of Glen Helen Parkway from the I-15 southbound off-ramp, west for a distance of 1,550 feet, in the Lytle Creek area.

Establish a "No Parking of Vehicles/Tow-Away Zone" pursuant to County Code Section 52.0132(a) along the south side of Glen Helen Parkway from the I-15 southbound off-ramp, west for a distance of 1,350 feet, in the Lytle Creek area.

2. The County Road Commissioner is hereby directed to perform such acts as are necessary to establish the Parking Restrictions above on Glen Helen Parkway (382400), in the Lytle Creek area.
