**WHEREAS**, the County of San Bernardino provides various group employee benefit plans including, but not limited to, medical, dental, vision, life insurance, accidental death and dismemberment, leaves and disability, and employee wellness programs for its employees (hereinafter called "Plans"); and

**WHEREAS**, the original term of the Contract between the County of San Bernardino, a political subdivision of the State of California, hereinafter referred to as "County" and Mercer Health & Benefits LLC, hereinafter referred to as "Consultant" commenced on July 1, 2018, and will expire on June 30, 2021; and

**WHEREAS**, Section D.1 of the Contract allows the extension of the Contract for one additional two year period by mutual agreement; and

**NOW, THEREFORE**, in consideration of the foregoing recitals, which are specifically incorporated into the body of this amendment and the mutual covenants, terms and conditions contained herein, the parties agree as follows:

- 1) Section D.1 is hereby amended by deleting the first paragraph of said subsection in its entirety and inserting the following in lieu thereof:

This Contract is effective as of July 1, 2018 and expires June 30, 2023, but may be terminated earlier in accordance with provisions of this Contract.


- 2) Exhibit 2 is hereby deleted in its entirety and replaced with the new Exhibit 2 which is attached hereto and incorporated herein by reference.
- 3) This Amendment may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterparts shall together constitute one and the same Amendment. The parties shall be entitled to sign and transmit an electronic signature of this Amendment (whether by facsimile, PDF or other email transmission), which signature shall be binding on the party whose name is contained therein. Each party providing an electronic signature agrees to promptly execute and deliver to the other party an original signed Amendment upon request.
- 4) All other terms and conditions of the Contract remain unchanged.
