#### AMENDMENT NO. 2

It is hereby agreed to amend Contract No. 18-291, effective May 24, 2022, as follows:

# I. CONTRACTOR SERVICE RESPONSIBILITIES

Paragraph A is amended to read as follows:

- A. Provide funding in the amount of \$443,610 to support the emergency needs voucher program that is supported by PSD through referral of at-risk children and youth for services. Through an agreement with First 5 San Bernardino, Children's Fund shall obtain \$443,610 from First 5 for the purpose of supporting the emergency needs voucher program.
- B. Provide funding in the amount of \$33,390 specifically to cover administrative fees charged by HS Auditing for voucher payment processing. Through a separate agreement, Children's Fund shall obtain \$33,390 from First 5 for the sole purpose of covering voucher payment processing fees.

C. This Contract may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterparts shall together constitute one and the same Contract. The parties shall be entitled to sign and transmit an electronic signature of this Contract (whether by facsimile, PDF or other email transmission), which signature shall be binding on the party whose name is contained therein. Each party providing an electronic signature agrees to promptly execute and deliver to the other party an original signed Contract upon request.

All other terms and conditions of Contract No. 18-291 remain in full force and effect.
