An ordinance of San Bernardino County, State of California, to amend Ordinance No. 1904 relating to the classified and unclassified service.

89969	County Labor Relations Chief	Human Resources Deputy Director


SECTION 3. This Ordinance shall take effect thirty (30) days from the date of its adoption.
