IT IS HEREBY AGREED AS FOLLOWS:

AMENDMENT No. 1

Contract No. 23-145 to provide Body Worn Camera System (BWCS) services by Axon Enterprise, Inc. to the Sheriff/Coroner/Public Administrator is hereby amended effective June 25, 2024, as follows:

1) By adding section B.52 – Campaign Contributions Disclosure as follows:

B.52 Campaign Contribution Disclosure (SB 1439)

Contractor has disclosed to the County using Attachment G - Campaign Contribution Disclosure Senate Bill 1439, whether it has made any campaign contributions of more than \$250 to any member of the Board of Supervisors or other County elected officer [Sheriff, Assessor-Recorder-Clerk, Auditor-Controller/Treasurer/Tax Collector and the District Attorney] within the earlier of: (1) the date of the submission of Contractor's proposal to the County, or (2) 12 months before the date the Contract was approved by the Board of Supervisors. Contractor acknowledges that under Government Code section 84308, Contractor is prohibited from making campaign contributions of more than \$250 to any member of the Board of Supervisors or other County elected officer for 12 months after the County's consideration of the Contract.

In the event of a proposed amendment to the Contract, the Contractor will provide the County a written statement disclosing any campaign contribution(s) of more than \$250 to any member of

the Board of Supervisors or other County elected officer within the preceding 12 months of the date of the proposed amendment.

Campaign contributions include those made by any agent/person/entity on behalf of the Contractor or by a parent, subsidiary or otherwise related business entity of Contractor.

2) By deleting section D.1, in its entirety, and replacing it with a new section D.1, as follows:

D.1 The maximum amount of payment under the Contract shall not exceed \$7,807,586, which may be funded in whole or in part with federal funds and shall be subject to the availability of funds to the County. The consideration to be paid to Contractor, as provided herein, shall be in full payment for all Contractor's services and expenses incurred in the performance hereof, including travel and per diem.

3) By deleting section D.2, in its entirety, and replacing it with a new section D.2, as follows:

D.2 Contractor shall provide County itemized monthly invoices, in arrears, and in a format acceptable to the County for Services performed under the Contract, based on the rates listed in Exhibit A-1 – Price List, and Exhibit A-2 – Price List Addendum, attached hereto and incorporated herein by this reference, within twenty (20) days of the end of the previous month. Invoices shall be issued with a net sixty (60) day payment term with corresponding Purchase Order and/or Contract number stated on the invoices. County reserves the right to audit invoices submitted by Contractor. The County shall make payment to Contractor within sixty (60) working days after receipt of invoice of the resolution of any billing dispute. All invoices shall be sent to the County via one of the following methods:

4) By deleting section L.3 – Data Path from Exhibit 3 – Statement of Work, in its entirety and replacing it with a new section L.3 – Data Path, as follows:

L.3 Data Path – Due to network bandwidth constraints and traffic concerns, the entire data path for video/audio uploads should be able to operate outside of the Sheriff's network. Data shall travel from the BWC to a secondary data transfer point, and then to the cloud without causing any interruption to Sheriff's network bandwidth. Any usage of Sheriff MDCs to achieve this connectivity and upload shall be prohibited.

Except as amended, all other terms and conditions of the Contract remain as stated therein.

ATTACHMENT G

Campaign Contribution Disclosure (SB 1439)

DEFINITIONS

Actively supporting the matter: (a) Communicate directly with a member of the Board of Supervisors or other County elected officer [Sheriff, Assessor-Recorder-Clerk, District Attorney, Auditor-Controller/Treasurer/Tax Collector] for the purpose of influencing the decision on the matter; or (b) testifies or makes an oral statement before the County in a proceeding on the matter for the purpose of influencing the County's decision on the matter; or (c) communicates with County employees, for the purpose of influencing the County's decision on the matter; or (d) when the person/company's agent lobbies in person, testifies in person or otherwise communicates with the Board or County employees for purposes of influencing the County's decision in a matter.

Otherwise related entity: An otherwise related entity is any for-profit organization/company which does not have a parent-subsidary relationship but meets one of the following criteria:

- (1) One business entity has a controlling ownership interest in the other business entity;
- (2) there is shared management and control between the entities; or
- (3) a controlling owner (50% or greater interest as a shareholder or as a general partner) in one entity also is a controlling owner in the other entity.

For purposes of (2), "shared management and control" can be found when the same person or substantially the same persons own and manage the two entities; there are common or commingled funds or assets; the business entities share the use of the same offices or employees, or otherwise share activities, resources or personnel on a regular basis; or there is otherwise a regular and close working relationship between the entities.
