RESOLUTION OF THE BOARD OF SUPERVISORS OF SAN BERNARDINO COUNTY TO ESTABLISH "NO PARKING" ZONE OF COMMERCIAL VEHICLES HAVING A GROSS WEIGHT RATING EXCEEDING 10,000 POUNDS ON PERRIS HILL ROAD IN THE SAN BERNARDINO AREA

On Tuesday November 15, 2022, on motion of Supervisor Baca Jr., duly seconded by Supervisor Rutherford and carried, the following resolution is adopted by the Board of Supervisors of San Bernardino County, State of California.

WHEREAS, the Department of Public Works completed a traffic engineering investigation regarding the parking of commercial vehicles along and around Perris Hill Road in the San Bernardino Area; and

WHEREAS, the Board of Supervisors is authorized to establish parking restriction on County roads pursuant to County Code Section 52.0128(a); and,

WHEREAS, the Board of Supervisors desires, based upon the traffic engineering investigation, to establish a parking restriction on both sides of Perris Hill Road from Pacific Street to Baseline Street in San Bernardino area, except for the portion maintained by City of San Bernardino.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of San Bernardino County as follows:

1. Due to conditions affecting the welfare of the public utilizing Perris Hill Road, in the San Bernardino area, the Board of Supervisors, pursuant to a traffic engineering investigation, hereby finds and determines it necessary to:

Establish a "No Parking" zone of commercial vehicles having a gross weight rating exceeding 10,000 pounds on both sides of Perris Hill Road (649150) from Pacific Street (629050) to Baseline Street (157700) in San Bernardino area, except for the portion maintained by City of San Bernardino.

2. Direct the County Road Commissioner to perform such acts as are necessary to implement the terms of the resolution.
