**An ordinance of the San Bernardino County Flood Control District,
State of California, to repeal Ordinance No. FCD 25-01 and to
establish fees related to products and services.**

**The Board of Supervisors of the San Bernardino County Flood Control District,
State of California, ordains as follows:**

SECTION 1. Effective July 1, 2026, Ordinance No. FCD 25-01 is repealed.

18	3) Deposits for Developer Deposit Accounts and Project Trust Accounts:			
19	An initial deposit is required for each actual cost service or process. The initial			
20	deposit is as specified in this ordinance. If no amount is specified, the initial			
21	Deposit is the San Bernardino County Flood Control District's initial estimate			
22	of the actual cost of the service or process. The San Bernardino County Flood			
23	Control District may revise its estimate at any time during the processing of			
24	the service or process. If a revised estimate is higher than a previous estimate,			
25	the San Bernardino County Flood Control District may require an additional			
26	deposit. Notice of any required additional deposit shall be mailed (including			
27	email) to the applicant. The notice shall include the date by which the deposit			
28	must be made and shall inform the applicant that unless provision for

1 payment is made by the date specified, the application will be deemed denied
2 without prejudice, without further action by the San Bernardino County
3 Flood Control District. Any such denial without prejudice is not appealable.
4 Each estimate shall be the result of a good faith attempt to determine the
5 probable actual cost of the service or process based on the nature of the
6 project, the District's experience in processing similar services or processes,
7 and applicable rates. In addition, the Flood Control Engineer or designee has
8 the authority, with agreement of the applicant, to increase or decrease the
9 required initial deposit amounts based on the complexity of the service or
10 process. Initial deposits or any additional deposits for all services or processes
11 related to a project shall be placed and combined into a Project Trust Account.
12 Such combined deposited funds will be utilized as the source of payment for
13 any flat fee service, security deposit, or actual cost service on that project.
14 In addition, deposits may also be placed in a Developer Deposit Account.
15 Deposited funds in a Developer Deposit Account may be used by an individual
16 or entity to fund various Project Trust Accounts.

17 **4) Applicant's obligation to pay actual cost:**
18 The applicant shall pay the actual cost of the project, regardless of any
19 estimate; except that the applicant is not obligated for costs incurred
20 after the applicant delivers to the San Bernardino County Flood Control
21 District either an unconditional written withdrawal of the application,
22 or a written notice to stop work which includes a waiver of any applicable
23 time limits for processing the application.

24 **i) Returned check fee:**

25 1) A fee of \$25.00 per item shall be charged for each negotiable item
26 returned unpaid by the drawn financial institution for any reason,
27 including, but not limited to, non-sufficient funds or closed accounts.

1	1) Except as otherwise provided by law, the San Bernardino County Flood Control District Board of Supervisors, by Board action, can waive, defer payment of, or refund any fee set forth in this ordinance or any other fee levied by the Flood Control District provided one of the following conditions is met:			
2		A) The service for which the fee was levied has not and will not be performed; or		
3		B) The fee was collected in error; or		
4	C) For other good cause shown, provided such waiver/refund would serve a San Bernardino County Flood Control District purpose.			
5	2) In the event of a disaster, or other good cause shown to serve a San Bernardino County Flood Control District purpose, the Chief Flood Control Engineer may defer payment of, waive, or refund any fee set forth in this ordinance or any other fee levied by the San Bernardino County Flood Control District provided all of the following conditions are met:			
6		A) Exigent conditions exist whereby obtaining Board approval of the fee waiver/refund/deferral would not be immediately feasible; and		
7		B) The San Bernardino County Flood Control District receives concurrence from the County Chief Executive Officer.		
8	3) The Chief Flood Control Engineer, or designee, may refund any fee or deposit set forth in this ordinance provided one of the following conditions is met:			
9		A) The service for which the fee or deposit was levied has not and will not be performed; or		
10		B) The fee or deposit was collected in error; or		
11	C) Unused deposit monies remain on actual cost projects when all charges for the project have been recorded.			
12	4) As set forth in California Government Code section 6103, the state and any county, city, district, or other political subdivision, are exempt from

The state may be additionally exempt from fees pursuant to California Government Code sections 6103 and 6103.7.
