**ORDINANCE NO.**

**An ordinance of San Bernardino County, State of California, to amend Sections 13.0613, 13.0614, 13.0660, 13.0617f and 13.0617c of the San Bernardino County Code relating to compensation and working terms and conditions for the Exempt Group, County-Wide Elected Officials, Public Service Employees, Student Nurses and Student Intern.**

The Board of Supervisors of the County of San Bernardino, State of California, ordains as follows:

SECTION 1. Section 13.0613 of the San Bernardino County Code is amended, to read:

**13.0613 Salaries and Working Conditions of the Exempt Group.**

(a) Exempt Group. The Exempt Group consists of employees who formulate and administer significant executive policy, employee relations responsibilities, and/or County confidential proprietary information. Positions are placed in the Exempt Group only by specific approval of the Board of Supervisors.

(b) Definitions. The following definitions apply to the terms used in Section 13.0613 unless another definition is specified.

(1) APPOINTING AUTHORITY refers to the department head of the employee’s department as specified in Section 10 of Article II of the County Charter and County Code section 12.2400. It also includes any person who is designated as acting department head, employees acting for the department head during the absence of the department head, and/or employees delegated all authority to act on behalf of the appointing authority on a regular basis.

(2) BASE RATE OF PAY or BASE HOURLY RATE means the employee’s base hourly wage, excluding differentials and other pay above the base hourly wage.

(3) BASE BIWEEKLY SALARY or BIWEEKLY BASE SALARY means

1 an employee's base hourly rate, excluding any differentials or other pay above the base  
2 hourly rate, multiplied by the base hours paid (e.g., REG, SCK, VAC, etc.) each pay  
3 period. Base hours paid does not include time without pay or disability payments such  
4 as short-term disability or workers' compensation.

5 (4) CALENDAR YEAR refers to pay period 1 through 26, or 27 when  
6 applicable, of the same year.

7 (5) COUNTY SERVICE or CONTINUOUS SERVICE refers to the total  
8 length of service from an employee's most recent beginning (hire) date in a regular  
9 position with no separation from County employment.

10 (6) COUNTY-WIDE ELECTED OFFICIAL refers to a County officer who  
11 is elected to a County-wide office pursuant to the law. County-wide elected officials  
12 consist of the Assessor/Recorder; Auditor-Controller/Treasurer/Tax Collector;  
13 Sheriff/Coroner/Public Administrator; and the District Attorney.

14 (7) DATE OF HIRE or HIRE DATE refers to the effective date of the most  
15 recent date of hire in a regular position.

16 (8) DIRECTOR OF HUMAN RESOURCES refers to the incumbent in  
17 the Director of Human Resources position. It also includes any person who has been  
18 designated as acting Director of Human Resources, employees acting for the Director  
19 during the absence of the Director of Human Resources, and/or employees delegated  
20 authority approval on a regular basis by the Director of Human Resources.

21 (9) FISCAL YEAR ordinarily refers to pay period 15 of one year through  
22 pay period 14 of the following year.

23 (10) PAID HOURS refers to hours actually worked or the use of accrued  
24 leave time such as vacation, paid time off, sick, holiday, or compensatory time. It does  
25 not include unpaid hours or disability payments (excluding Labor Code section 4850 time)  
26 such as short-term disability or workers' compensation.

27 (11) PAID STATUS refers to any pay period in which an employee codes  
28 paid hours.

1 (12) REGULAR POSITION refers to a position authorized by the Board  
2 of Supervisors that may be budgeted at either a full-time or part-time level, and that may  
3 be in either the classified or unclassified service. It does not include recurrent, extra-help,  
4 ordinance, contract and other contingent positions.

5 (13) REGULAR STATUS refers to the completion of a required  
6 probationary and/or trainee period in a regular classified position in the employee's  
7 current or prior position, as applicable.

8 (14) SERVICE HOURS refers to paid hours from an employee's most  
9 recent date of hire in a regular position and during an employee's regular tour of duty, up  
10 to 80 hours per pay period. Time without pay, disability payments (excluding Labor Code  
11 section 4850 time), medical emergency leave and overtime hours do not count as service  
12 hours.

13 (c) Salary Schedules, Wage Increases, Classifications, and Salary Rates, and  
14 Step Advancements.

15 (1) Salary Schedules. The salary schedules for Exempt Group and all  
16 non-represented employees are as on file with the Clerk of the Board of Supervisors.

17 (2) Wage Increases. The following wage increases shall be included in  
18 the salary schedules for Exempt Group employees and all non-represented employees,  
19 as are on file with the Clerk of the Board of Supervisors:

20 Effective February 24, 2024, the County shall provide all classifications in  
21 the Exempt Group with a three percent across the board salary increase.

22 Effective February 22, 2025, the County shall provide all classifications in  
23 the Exempt Group with a three percent across the board salary increase, subject to the  
24 following:

25 If the County's Discretionary "Property Related Revenue", as defined in the  
26 "Discretionary General Funding and Restricted Funds" section of the County's Budget  
27 Book, are less than a two percent increase in 2023-24 compared to 2022-23 and/or if  
28 statewide 2011 Realignment Sales Tax Collections from Fiscal Year 2023-24,

1 representing collections from September 2023 through August 2024, decline by more  
2 than four percent compared to 2022-23, then the County may, upon approval of the Board  
3 of Supervisors, defer this three percent increase until August 23, 2025.

4                 Effective February 21, 2026, the County shall provide all classifications in  
5 the Exempt Group with a three percent across the board salary increase, subject to the  
6 following:

7                 If the County's Discretionary "Property Related Revenue", as defined in the  
8 "Discretionary General Funding and Restricted Funds" section of the County's Budget  
9 Book, are less than a two percent increase in 2024-25 compared to 2023-24 and/or if  
10 statewide 2011 Realignment Sales Tax Collections from Fiscal Year 2024-25,  
11 representing collections from September 2024 through August 2025, decline by more  
12 than four percent compared to 2023-24, then the County may, upon approval of the Board  
13 of Supervisors, defer this three percent increase until August 22, 2026.

14                 (3) Revenue Sharing. For every one percent (1.00%) in "Property  
15 Related Revenue" growth received in Fiscal Year 2023-24 above four percent (4.00%),  
16 as defined in the "Discretionary General Funding and Restricted Funds" section of the  
17 County's Budget Book, the County will provide a one-half percent (0.50%) equity  
18 adjustment on February 22, 2025, up to a maximum equity of one percent (1.00%).

19                 If Statewide 2011 Realignment Sales Tax Collections from Fiscal Year  
20 2024-25, representing collections from September 2024 through August 2025, are greater  
21 than a zero percent (0.00%) increase, then for every one percent (1.00%) in Property  
22 Related Revenue growth received in 2024-25 above four percent (4.00%), the County will  
23 provide a one-half percent (0.50%) equity adjustment on February 21, 2026, up to a  
24 maximum equity of one percent (1.00%).

(D) Notwithstanding the salary as established by this chapter, the Board of Supervisors may establish salary, benefits, and other terms and conditions of employment by contract for the classifications listed in this section.

(5) Salary Rates and Step Advancements.

(A) Eligibility for Step Advancement. Employees shall be hired at

1 Step 1 of the established base salary range, except as otherwise provided in this  
2 subdivision. Variable entrance steps may be established if justified by recruitment needs  
3 through Step 8 with the approval of the appointing authority and through the top step with  
4 the approval of the Director of Human Resources or designee.

5           Within the base salary range, all step advancements will be made at  
6 the beginning of the pay period in which the employee completes the required number of  
7 service hours. However, when an employee reaches the required number of service  
8 hours with 80 hours in each pay period, the step advancement will be made at the  
9 beginning of the next pay period. Approval for advancement shall be based upon  
10 completion of the required length of service hours in the classification, satisfactory work  
11 performance, and appointing authority recommendation.

12           Completed service hours shall be defined as regularly scheduled  
13 hours in a paid status, up to 80 hours per pay period. Overtime hours, disability payments,  
14 medical emergency leave, and time without pay shall not count toward step  
15 advancements. Unless otherwise approved by the Board of Supervisors, step  
16 advancements within a base salary range shall be based upon a one-step increment,  
17 approximately two and one-half percent. The employee shall be eligible for step  
18 advancements after completion of increments of 1,040 hours until the top step of the  
19 range is reached.

20           An appointing authority may request, in limited exceptional  
21 circumstances and with adequate justification, the adjustment of the salary step or salary  
22 rate of an employee to maintain salary equity within the system, to prevent undue  
23 hardship or unfairness due to the application of any rule or policy, or to correct any salary  
24 inequity, subject to the recommendation of the Director of Human Resources and the final  
25 approval of the Chief Executive Officer or his/her designee. The Director of Human  
26 Resources may authorize the adjustment of the salary step or salary rate of an employee  
27 to correct any payroll error or omission, including any such action which may have arisen  
28 in any prior fiscal year.

1 (B) Implementation of Classification Study Results.

2 (I) Upgrading. An upgrading is the reclassification of a  
3 position from one classification to another classification having a higher base salary  
4 range. Whenever an incumbent employee is upgraded as a result of such reclassification,  
5 pursuant to the Personnel Rules, such employee's step placement in the new salary  
6 range shall be governed by the subdivision on "Promotions."

7 (II) Downgrading. A downgrading is the reclassification of  
8 a position from one classification to another classification having a lower base salary  
9 range. When a position is downgraded, the incumbent employee may continue at the  
10 same salary rate where the salary rate is within the new base salary range. Where an  
11 incumbent receives a salary rate greater than the maximum of the new base salary range,  
12 the Director of Human Resources may authorize continuation of the same salary rate to  
13 the incumbent employee that the employee received prior to the downgrading of the  
14 position by placing the employee on an "X" step, provided that the employee shall receive  
15 no future salary rate increases until the salary range maximum of the new classification  
16 exceeds the "X" step.

17 (C) Salary Rate Adjustment. A salary rate (equity) adjustment is  
18 a change in the salary range assignment of an existing classification as a result of a  
19 compensation study. Step placement for incumbent employees whose classification is  
20 assigned to a higher base salary range shall be determined as follows, unless this process  
21 is waived by the Chief Executive Officer:

22 (I) If the employee's original base rate of pay is less than  
23 Step 1 of the newly designated pay range, the employee shall be placed on Step 1 of the  
24 new range. The employee shall be eligible to advance to the next step upon receiving a  
25 satisfactory rating after completion of 1,040 hours, in accordance with the requirements  
26 of Subsection 13.0613(c)(4)(A). Subsequent step advances shall be administered in  
27 accordance with Subsection 13.0613(c)(4)(A).

28 (II) If the employee's original base rate of pay falls within

1 the newly designated pay range, and the salary adjustment granted is at least two salary  
2 ranges, the employee shall be placed upon the step in the new range that is approximately  
3 a five percent salary increase, not to exceed the maximum step of the new range. If the  
4 employee's original base rate of pay falls within the newly designated pay range, and the  
5 salary adjustment granted is less than two salary ranges, the employee shall be placed  
6 upon the step in the new range that is approximately a two and one-half percent salary  
7 increase, not to exceed the maximum step of the new range. The employee shall be  
8 eligible to advance to the next step upon receiving a satisfactory rating after completion  
9 of 1,040 hours, in accordance with the requirements of Subsection 13.0613(c)(4)(A).  
10 Subsequent step advances shall be administered in accordance with Subsection  
11 13.0613(c)(4)(A).

12 (D) Demotion. A demotion is the appointment of an employee  
13 from an incumbent position to a position in a different classification for which the maximum  
14 rate of pay is lower. An employee demoted for disciplinary reasons shall be placed on  
15 the step within the base salary range of the class to which the employee demoted as  
16 provided in the order of demotion.

17 An employee demoted for non-disciplinary reasons who returns to  
18 their former classification during the probationary period or within 2,080 service hours of  
19 promotion, shall be returned to the same salary step within the base salary range for the  
20 former classification that the employee was on prior to promotion. No credit shall be  
21 granted for hours worked at the promoted level for the next step advance due date.

22 An employee demoted for non-disciplinary reasons shall be placed  
23 on a step closest to, but not less than, their current base rate of pay on the salary range  
24 of the classification to which the employee demotes, not to exceed the top step of the  
25 applicable range, with the approval of the appointing authority and the Director of Human  
26 Resources.

27 An employee who demotes for non-disciplinary reasons to a trainee  
28 classification for which the journey level classification is higher than the classification they



1 demoted from, shall be placed on a step closest to, but not less than, their current base  
2 rate of pay on the salary range of the classification to which the employee demoted.  
3 Employees whose current base rate of pay exceeds the top step of the salary range to  
4 which the employee demoted shall be placed on the "X" step and retain their current base  
5 rate of pay. Provided that the "X" step continues to be above the top step of the demoted  
6 classification range, the employee shall receive no future salary rate increases until the  
7 employee has promoted to the journey level classification.

8 An employee who demotes for non-disciplinary reasons to a trainee  
9 classification for which the journey level classification is lower than the classification they  
10 demoted from shall retain the same salary rate, provided that the salary rate does not  
11 exceed the top step of the journey level classification. If the salary rate is higher than the  
12 top step of the journey level classification, the employee shall be placed at the top step  
13 of the base salary range of the lower journey level classification.

14 (E) Promotion. A promotion is the appointment of an employee  
15 from one classification to a classification having a higher base salary range. A promoted  
16 employee shall receive at least the entrance rate of the new range or a two-step or five  
17 percent salary increase, (i.e., mathematically closest to five percent) whichever is greater,  
18 provided that no employee is thereby advanced in step nor advanced above the top step  
19 of the higher base salary range. At the discretion of the appointing authority and with the  
20 approval of the Director of Human Resources, an employee may be placed at any step  
21 within the higher base salary range. Promotions shall be effective only at the beginning  
22 of a pay period unless the Director of Human Resources approves an exception.

23 (d) Job Sharing and Part-time Employment. The County will make reasonable  
24 accommodation for employees who desire to share their positions with other qualified  
25 employees or eligible persons or to work on a part-time basis. Jobs may be shared on  
26 an hourly or daily basis. All benefits for job sharing and part-time employees shall be pro-  
27 rated on regularly scheduled hours except as may otherwise be provided. Benefits not  
28 subject to proration include the following leaves: blood donation, examination time, and

1 bereavement. Further, where a specific benefit provides a minimum hour requirement  
2 (e.g., must be full-time, or scheduled hours) job sharing and part-time employees shall be  
3 required to meet the minimum hour requirement in order to receive the benefit.

4 (e) Hours of Work.

5 (1) Employees shall be required to work during such hours as necessary  
6 to carry out the duties of their position as designated by the appointing authority, and such  
7 hours may be varied so long as the work requirements and efficient operations of the  
8 County are assured.

9 (2) The nature of Fair Labor Standards Act (FLSA) exempt employment  
10 for certain affected Exempt Group classifications is such that intermittent, occasional  
11 overtime is needed to fulfill the responsibilities and requirements of the position. Usually,  
12 additional time and effort are proportionate to the importance and level of the responsible  
13 position. These factors of time and effort are incorporated when the compensation level  
14 of FLSA-exempt positions is established. In those instances in which a position's work  
15 extends well beyond the normal hours of employment, the Chief Executive Officer may  
16 authorize additional compensation in the form of cash payment or compensating time off,  
17 generally on a pre-approved and prescheduled basis. Circumstances for such  
18 compensation would include implementation of the intent of a Board of Supervisors  
19 approved program or emergency response.

20 (3) For FLSA-covered employees in the Exempt Group classifications,  
21 overtime is determined by the legal requirements of the FLSA. For FLSA-covered  
22 employees, the following overtime provisions apply.

23 (A) Definition. OVERTIME shall be defined as all hours actually  
24 worked in excess of 40 hours a work period. For purposes of defining overtime, paid  
25 leave time, excluding sick leave as provided in Subsection 13.0613(e)(3)(B), shall be  
26 considered as time actually worked. Overtime shall be reported in increments of full 15  
27 minutes and is non-accumulative and non-payable when incurred in units of less than 15  
28 minutes. Overtime shall not affect leave accruals.

1 (B) Sick leave that is not pre-approved and sick leave used by  
2 employees on leave restriction shall not be considered as time actually worked for the  
3 purpose of calculating overtime. PRE-APPROVED shall mean notice to management at  
4 least 48 hours prior to the beginning of the leave.

5 (C) Overtime Compensation. Any employee authorized by the  
6 appointing authority or authorized representative to work overtime shall be compensated  
7 at premium rates, i.e., one and one-half times the employee's regular rate of pay.  
8 Payment for overtime compensation shall be made on the first payday following the pay  
9 period in which such overtime is worked, unless overtime compensation cannot be  
10 computed until some later date, in which case, overtime compensation will be paid on the  
11 next regular payday after such computation can be made.

12 In lieu of cash payment, upon request of the employee and approval  
13 of the appointing authority, an employee may accrue compensating time off at premium  
14 hours. Cash payment at the employee's regular rate of pay shall automatically be paid  
15 for any compensating time which exceeds 80 hours, for any such time which has not been  
16 taken within 26 pay periods after being accrued, or for any hours on record immediately  
17 prior to promotion, demotion or termination of employment.

18 (D) Variable Work Schedule. An appointing authority, with  
19 agreement of an affected employee, may arrange for that individual to take such time off  
20 as necessary to ensure that an employee's actual time worked does not exceed 40 hours  
21 within a given work period.

22 (E) Work Period. The work period for purposes of overtime  
23 commences at 12:01 a.m. Saturday and ends at 12:00 midnight the following Friday of  
24 each week. The pay period and workweek may be adjusted in accordance with FLSA  
25 requirements.

26 (f) Insurance Programs.

27 (1) Medical and Dental Coverage Insurance.

28 (A) All eligible employees scheduled to work 40 hours or more per

1 pay period in a regular position must enroll in a medical and dental plan offered by the  
2 County. Employees who fail to elect medical and dental plan coverage will be  
3 automatically enrolled in the medical broad network HMO plan and dental HMO plan with  
4 the lowest biweekly premium rates available in the geographical location of the  
5 employee's primary residence. Medical and dental plan coverage will become effective  
6 on the first day of the pay period following the first pay period in which the employee is  
7 scheduled to work 40 hours or more and be in paid status.

8 (B) To continue enrollment in County-sponsored medical and  
9 dental plan coverage, an employee must remain in a regular position scheduled to work  
10 for a minimum of 40 hours per pay period and be in paid status or be on an approved  
11 leave for which continuation of medical and dental coverage is expressly provided under  
12 this subdivision, or be eligible for and have timely paid the premium for COBRA  
13 continuation coverage.

14 (C) Eligible employees may elect to enroll their dependents upon  
15 initial eligibility for medical and dental insurance. Thereafter, newly eligible dependents  
16 may be enrolled within 60 days of obtaining dependent status, such as birth, adoption,  
17 marriage, or registration of domestic partnership.

18 (D) Notification of a mid-year qualifying event must be submitted  
19 to Human Resources in accordance with procedures adopted by Human Resources.  
20 Employees are responsible for notifying the County within 60 days of dependent's change  
21 in eligibility for the County plans.

22 (E) Dependent(s) must be removed mid-plan year when a  
23 dependent(s) becomes ineligible for coverage under the insurance plan eligibility rules,  
24 for example, divorce, over-age dependent, or termination of domestic partnership.

25 (F) Enrollment elections must remain in effect for the remainder  
26 of the plan year unless an employee experiences an IRS qualifying event.

27 (G) Premiums for coverage will be automatically deducted from  
28 the employee's pay warrant. Failure to pay premiums will result in loss of coverage for

1 the employee and/or the dependents. If the employee does not have sufficient earnings  
2 to cover the deduction for premiums, the employee must make alternative payment  
3 arrangements that are acceptable to Human Resources.

4 (H) Employees eligible for medical plan coverage who are also  
5 enrolled in a comparable group medical plan sponsored by another employer or are  
6 covered by a spouse, domestic partner, or parent who is also employed with the County  
7 may elect to discontinue enrollment in County-sponsored medical plan (opt-out or waive).

8 (I) Employees who, prior to July 9, 2005, elected to opt-  
9 out of County-sponsored medical plan coverage and continue to opt-out will receive the  
10 following biweekly amount: Employees scheduled for 61 to 80 hours per pay period shall  
11 receive \$161.54 per pay period. Employees scheduled for 40 to 60 hours per pay period  
12 shall receive \$80.77 per pay period. To receive these amounts, the employee must be in  
13 paid status.

14 (II) Employees scheduled to work 61 to 80 hours who, prior  
15 to July 9, 2005, elected to waive medical plan coverage to a spouse, domestic partner,  
16 or parent employed by the County and continue to waive will receive \$230.00 per pay  
17 period; employees scheduled for 40 to 60 hours who continue to waive shall receive  
18 \$115.00 per pay period.

19 (III) New opt-outs or waives (i.e., new employees and  
20 current employees who opted-out or waived effective July 9, 2005, and any time  
21 thereafter) scheduled for 61 to 80 hours per pay period will receive \$40.00 per pay period;  
22 new opt-outs or waives scheduled for 40 to 60 hours shall receive \$20.00 per pay period.

23 (I) Employees eligible for County-sponsored dental plan  
24 coverage who are also enrolled in a comparable group dental plan sponsored by another  
25 employer or are covered by a spouse, domestic partner, or parent who is also employed  
26 with the County may elect to discontinue enrollment in their County-sponsored dental  
27 plan.

28 (J) The rules and procedures for electing to opt-out of or waive

1 County-sponsored medical and dental plan coverage are established and administered  
2 by Human Resources.

3 (I) Employees may elect to opt-out of or waive County  
4 medical and/or dental plan coverage(s) within 60 calendar days of the effective date of  
5 gaining other employer group coverage. Proof of initial gain of other employer group  
6 coverage is required at the time that opt-out or waive is elected.

7 (II) Employees may also elect to opt-out of or waive  
8 County medical and/or dental plan coverage during an annual open enrollment period.  
9 All employees who are newly opting-out or waiving during an open enrollment period must  
10 provide verification of other group coverage.

11 (III) Except as required at the initial opt-out/waive election,  
12 employees are not required to provide verification of continued coverage unless  
13 requested by the plan administrator.

14 (IV) Employees who voluntarily or involuntarily lose their  
15 other employer group medical and/or dental plan coverage must enroll in a County-  
16 sponsored medical and/or dental plan within 60 calendar days. Enrollment in the County-  
17 sponsored plan will be provided in accordance with the requirements of the applicable  
18 plan.

19 (V) There must be no break in the employee's medical  
20 and/or dental plan coverage between the termination date of the other employer group  
21 coverage and enrollment in a County sponsored medical and/or dental plan. Terms and  
22 conditions of the applicable plan will determine the required retroactive enrollment period  
23 and premiums required to implement coverage. Failure to notify the County of loss of  
24 group coverage within 60 calendar days will require the employee to pay their insurance  
25 premiums retroactively on an after-tax basis.

26 (K) For employees assigned to work in the Needles, Trona, and  
27 Baker work locations, the County will establish a Needles Subsidy. To be eligible for the  
28 Needles Subsidy the employee must be enrolled in a medical plan and receive the MPS.

1 The Needles Subsidy will be paid by the employee's department and will be equal to the  
2 amount of the premium difference between the indemnity medical plan offered in these  
3 specific work locations and the HMO medical plan with the most comparable benefit  
4 design (e.g., similar copayment amounts, out-of-pocket maximums, etc.) provided by the  
5 County. The applicable subsidy amount shall be paid directly to the provider of the  
6 County-sponsored medical plan in which the eligible employee has enrolled. This  
7 Needles Subsidy will be established each year when premiums change for the County-  
8 sponsored medical plans. The subsidy will be discontinued when the HMO plan used in  
9 the comparison above in this paragraph becomes available to the employees.

10 (2) Term Life Insurance.

11 (A) County Paid Life Insurance. The County will pay the premium  
12 for a term life policy, the amount of which is based on the eligible employee's scheduled  
13 hours. Employees scheduled from 40 to 60 hours per pay period shall receive \$25,000.00  
14 in coverage. An employee scheduled from 61 to 80 hours shall receive \$50,000.00 in  
15 coverage. Life insurance will become effective on the first day of the pay period following  
16 the employee's first pay period in which the employee is in paid status. For pay periods  
17 in which the employee is not in paid status, the employee shall have the option of  
18 continuing life insurance coverage at the employee's expense.

19 (B) Voluntary Life Insurance. In accordance with the procedures  
20 established by Human Resources, eligible employees may purchase, through payroll  
21 deductions, term life insurance subject to carrier requirements. New employees shall  
22 become initially eligible to participate in this program on the first day of the pay period  
23 following the pay period in which the employee is in paid status. Participation will continue  
24 as long as premiums are paid timely. If the employee does not have sufficient earnings  
25 to cover the deduction for premiums, the employee must make alternative payment  
26 arrangements that are acceptable to Human Resources.

27 (4) Group Universal Life. Eligible employees may purchase, through  
28 payroll deductions, group universal life insurance subject to carrier requirements and

1 approval. The benefit levels for such insurance shall be equivalent to no more than three  
2 times the employee's annual base earnings. Employees who purchase group universal  
3 life insurance shall be provided a County contribution towards the biweekly premium  
4 based on the following schedule:

Benefit Group	County Contribution
Benefit Group A	100 percent of the premium for benefit level equal to the annual base salary
Benefit Group B	50 percent of the premium for benefit level equal to the annual base salary or 100 percent of the premium for benefit level equal to one-half of the annual base salary
Benefit Group C	25 percent of the premium for benefit level equal to the annual base salary
Benefit Group D	25 percent of the premium for benefit level equal to the annual base salary

10  
11  
12 If the employee does not have sufficient earnings to cover the deduction for  
13 premiums, the employee must make alternative payment arrangements that are  
14 acceptable to Human Resources.

15 (5) Accidental Death and Dismemberment Insurance. Exempt Group  
16 employees may purchase amounts of accidental death and dismemberment insurance  
17 coverage for themselves and dependents through payroll deduction. New employees  
18 shall become initially eligible to participate in these programs on the first day of the pay  
19 period following the first pay period in which the employee is in paid status. Participation  
20 will continue as long as premiums are paid timely. If the employee does not have  
21 sufficient earnings to cover the deduction for premiums, the employee must make  
22 alternative payment arrangements that are acceptable to Human Resources. The  
23 benefits will be provided subject to carrier requirements and will be administered by  
24 Human Resources.

25 (6) Long-Term Disability Insurance. The County will provide Exempt  
26 Group employees with long-term disability insurance subject to carrier requirements and  
27 approval. The benefit levels are subject to carrier requirements. Integration of leave  
28 balances (e.g., sick, vacation, etc.), either partially or fully, are allowed in conjunction with



1 long-term disability benefits.

2 (7) Short-Term Disability Insurance. The County will provide an  
3 employer paid short-term disability insurance plan for Exempt Group employees. This  
4 benefit shall apply to Exempt Group employees in regular positions who are regularly  
5 scheduled to work 40 hours or more per pay period. The short-term disability insurance  
6 plan benefit coverage shall be governed by the plan document that has been approved  
7 and adopted by the Board of Supervisors for Exempt Group employees and is subject to  
8 carrier requirements and approval. The short-term disability insurance plan benefit  
9 coverage shall include a provision for a seven consecutive calendar day waiting period  
10 from the first day of disability before benefits begin. Benefits shall be 55 percent of base  
11 salary up to a weekly maximum established by a formula that incorporates the State of  
12 California for the State Disability Insurance fund maximum. Benefit payments terminate  
13 when the employee is no longer disabled or after receiving 180 days of benefits at which  
14 time the employee would be eligible for long-term disability benefits if still medically  
15 disabled.

16 (8) Vision Care Insurance. Subject to carrier requirements, the County  
17 will pay the premiums for vision care insurance for employees who are in paid status and  
18 their eligible dependents.

19 (g) Leave Provisions.

20 (1) Sick Leave. Sick leave with pay is an insurance or protection  
21 provided by the County to be granted in circumstances of adversity to promote the health  
22 of the individual employee. It is not an earned right to time off from work. SICK LEAVE  
23 is defined to mean the authorized absence from duty of an employee because of physical  
24 or mental illness, injury, pregnancy, confirmed exposure to a serious contagious disease,  
25 for a medical, optical, or dental appointment, for certain purposes related to being a victim  
26 of domestic violence, sexual assault or stalking, or other purpose authorized herein.

27 (A) Definition.

28 (I) FAMILY MEMBER. A FAMILY MEMBER, as defined

1 by Labor Code section 245.5, is a parent, child, spouse, registered domestic partner,  
2 grandparent, grandchild, sibling, or any person designated by the employee at the time  
3 the employee requests paid sick days. An employee shall not identify more than one  
4 “designated person” as a family member in a 12-month period from the first date of  
5 designation. PARENT means a biological, foster, adoptive, or stepparent, a legal  
6 guardian, or a person who stood in loco parentis when the employee was a minor child  
7 of the employee, or the employee’s spouse or registered domestic partner. CHILD means  
8 a biological, foster, or adopted child, a stepchild, a legal ward, a child of a domestic  
9 partner, or a child to whom the employee stands in loco parentis. DOMESTIC PARTNER  
10 is defined by Family Code section 297.

11 (II) EXTENDED FAMILY. EXTENDED FAMILY is defined  
12 as, parent/sibling-in-law, aunt, uncle, niece, nephew, or any step relations as defined  
13 herein.

14 (B) Accumulation. Employees in regular positions shall accrue  
15 sick leave for each payroll period completed, prorated on the basis of 3.69 hours per pay  
16 period, except as provided in Subsection 13.0613(g)(14). Earned sick leave shall be  
17 available for use the first day following the payroll period in which it is earned. Employees  
18 in regular positions paid less than 80 hours per pay period or job-shared positions shall  
19 receive sick leave accumulation on a pro rata basis. There shall be no limit on sick leave  
20 accumulation.

21 (C) Compensation. Approved sick leave with pay shall be  
22 compensated at the employee’s base rate of pay. The minimum charge against  
23 accumulated sick leave shall be 15 minutes.

24 (D) Administration.

25 (I) Investigation. It shall be the responsibility and duty of  
26 each appointing authority to investigate each request for sick leave and to allow sick leave  
27 with pay where the application is determined to be proper and fitting, subject to approval  
28 of the Director of Human Resources.

1 (II) Notice of Sickness. In 24-hour departments, the  
2 appointing authority or designee should be notified at least two hours prior to the start of  
3 the employee's scheduled tour of duty of a sickness on the first day of absence and must  
4 be notified at least one hour prior to the start of the employee's scheduled tour of duty.  
5 In other departments, the appointing authority or designee must be notified within one-  
6 half hour after the start of the employee's scheduled tour of duty of a sickness on the first  
7 day of absence.

8 It is the responsibility of the employee to keep the appointing  
9 authority informed as to continued absence beyond the first day for reasons due to  
10 sickness or occupational disability. Failure to make such notification shall result in denial  
11 of sick leave with pay. If the employee receives a doctor's off-work order and provides  
12 notice of same to the appointing authority, the employee is not required to contact the  
13 department daily. If the employee does not have an off-work order or has not notified the  
14 appointing authority that one has been issued, the employee shall be required to contact  
15 the department daily in accordance with the timeframe above.

16 (III) Review. The Director of Human Resources may  
17 review and determine the justification of any request for sick leave with pay and may, in  
18 the interest of the County, require information from a doctor to support a claim for sick  
19 leave pay.

20 (IV) Proof. A doctor's certificate or other adequate proof  
21 shall be provided by the employee in all cases of absence due to illness if requested by  
22 the appointing authority. All requests for proof of illness shall be made in compliance with  
23 the Labor Code and other law.

24 (V) Improper Use. Evidence substantiating the use of sick  
25 leave for willful injury, gross negligence, intemperance, trivial indispositions, instances of  
26 misrepresentation, or violation of the rules defined herein will result in denial of sick leave  
27 with pay and shall be construed as grounds for disciplinary action up to and including  
28 termination.

1 (E) Sick Leave for Other than Personal Illness/Injury.

2 (I) Family Sick Leave. A maximum of one-half of the  
3 employee's annual accrual of earned sick leave per calendar year may be used for  
4 attendance upon family members who require the attention of the employee. Upon  
5 approval of the appointing authority, the employee may use part of this annual allowance  
6 for attendance upon members of the employee's extended family residing in the  
7 employee's household who require the attention of the employee.

8 (II) Bereavement. A maximum of three days earned sick  
9 leave may be used per occurrence for bereavement due to the death of an employee's  
10 family member as defined in section 13.0613(g)(1)(A)(I), except for a person "designated"  
11 by the employee for sick leave purposes, and for any member of the employee's extended  
12 family as defined in section 13.0613(g)(1)(A)(II) or any relative who resided with the  
13 employee.

14 (III) Birth/Adoption. A maximum of 40 hours earned sick  
15 leave may be used per occurrence for arrival of an adoptive child at the employee's home.  
16 An employee may utilize on an annual basis no more than 40 hours of accumulated sick  
17 leave per calendar year for the birth of his or her child.

18 (IV) Medical, Optical or Dental Appointments. The  
19 employee may use sick leave for medical, dental or optical appointments; however, every  
20 effort should be made to schedule the appointments at a time of day that will minimize  
21 the employee's time off work.

22 (F) Return-to-Work Medical Clearance.

23 (I) Under any of the following circumstances, all  
24 employees who have been off work due to an illness or injury will report to the San  
25 Bernardino County Center for Employee Health and Wellness for a medical evaluation of  
26 condition and authorization to return to work before returning to work.

27 (i) Employees whose treating physician or other  
28 qualified medical provider has ordered job modification(s) as a condition for either

1 continuing to work or for returning to work after an illness or injury. This applies to both  
2 occupational and non-occupational illness or injury.

3 (ii) Employees who have been off work due to  
4 communicable diseases such as, but not limited to, chicken pox and measles.

5 (iii) Employees who have been absent on account  
6 of serious medical condition, when so directed by appointing authority.

7 (II) Employees are required to attend return-to-work  
8 medical appointments at the Center for Employee Health and Wellness on their own time;  
9 however, mileage for attending such appointments are eligible for reimbursement  
10 pursuant to the expense reimbursement provision, Subsection 13.0613(j).

11 (III) It is the responsibility of the employee to obtain written  
12 notice from the medical provider of authorization to return to work with or without job  
13 modification. To ensure all necessary and relevant medical information is provided, the  
14 County shall make available forms to be completed by the medical provider. It is the  
15 responsibility of the employee to provide verbal notice to his or her appointing authority  
16 immediately upon receipt of the medical provider's authorization to return to work, and no  
17 later than 24 hours after receipt of the notice. The appointing authority or designee will  
18 schedule an appropriate medical evaluation for the employee with the Center for  
19 Employee Health and Wellness prior to the employee's return to work. The employee  
20 shall provide the medical provider's written notice of authorization to return to work to the  
21 Center at or prior to the employee's scheduled appointment time.

22 (IV) Exceptions to the above requirements may be made  
23 on a case-by- case basis by the Center for Employee Health and Wellness.

24 (V) The employee is obligated to attend the appointment  
25 as scheduled under the conditions outlined above. If the employee fails to adhere to the  
26 procedure, the employee is required to use sick leave or leave without pay for any work  
27 hours missed. If required notice has been provided, and there is a delay between the  
28 employee's appointment with the Center and the start of his or her scheduled tour of duty

1 on the day that he or she was released to return to work, the County will pay for work  
2 hours missed, without charge to the employee's leave balances.

3 (VI) The final decision on the employee's ability to return to  
4 work rests with the medical provider at the Center. In the event the employee is not  
5 released to return to work by the medical provider at the Center, the employee's status  
6 would continue on sick leave or, where there is no balance, leave without pay.

7 (G) Workers' Compensation. Employees shall receive full salary  
8 in lieu of Workers' Compensation benefits and paid sick leave for the first 40 hours  
9 following an occupational injury or illness, if authorized off work by order of an accepted  
10 physician under the Workers' Compensation sections of the California Labor Code.  
11 Thereafter, accumulated paid leave may be prorated to supplement such temporary  
12 disability compensation payments, provided that the total amount shall not exceed the  
13 regular gross salary of the employee. Employees eligible for salary continuation pursuant  
14 to Labor Code section 4850 are not entitled to this paid time.

15 (H) Employees covered by Labor Code section 4850 who are  
16 injured in the line of duty are entitled to full salary in lieu of Workers' Compensation  
17 benefits and sick leave for a period not to exceed one year. After the employee has used  
18 one full year of such "4850 time", said employee may use accumulated paid leave with  
19 pay with the approval of the appointing authority to augment temporary disability  
20 payments if said employee is still temporarily disabled by order of an accepted physician  
21 under the Workers' Compensation sections or until said employee is retired.

22 (I) Separation. Unused sick leave shall not be payable upon  
23 separation of the employee, except as provided in the Retirement Medical Trust Fund,  
24 Subsection 13.0613(k)(4) and as provided below.

25 Upon the death of an active employee with five or more years of  
26 continuous service from the most recent date of hire in a regular position, the estate of  
27 the deceased employee will be paid the cash value for the unused sick leave balances  
28 according to the sick leave conversion formula below only up to 1,000 hours, and will not

1 go into the Trust.

480 hours or less	30 percent
481 to 600 hours	35 percent
601 to 720 hours	40 percent

7 (J) Sick Leave Conversion. While employed by the County,  
8 employees who have contributed to a public sector retirement(s) for over five years and  
9 have not withdrawn the contribution from the system(s) may exchange accrued sick leave  
10 hours in excess of 200 hours for vacation time on the following basis:

Sick Leave Balance at Time of Conversion	Sick Leave to Vacation Leave Conversion Ratio
201 to 599 hours	3 sick hours to 1 hour vacation
600 to 799 hours	2.5 sick hours to 1 hour vacation
800 or more hours	2 sick hours to 1 hour vacation

15 Any such exchange must be made in ten-hour increments of accrued  
16 sick leave under the procedures established by the Director of Human Resources.  
17 Employees may elect this exchange once per calendar year.

18 (2) Vacation Leave.

19 (A) Definition. VACATION is a right, earned as a condition of  
20 employment, to a leave of absence with pay for the recreation and well-being of the  
21 employee. If an employee has exhausted sick leave, vacation leave may be used for sick  
22 leave purposes upon a special request of the employee and with the approval of the  
23 appointing authority.

24 (B) Accumulation. Employees in regular positions scheduled to  
25 work 80 hours per pay period shall accrue, on a pro-rata basis, vacation leave for  
26 completed pay periods. Such vacation leave shall be available for use on the first day  
27 following the pay period in which it is earned, provided an employee has worked six pay  
28 periods from the employee's hire date. Employees in regular positions paid less than 80

1 hours per pay period or job shared positions shall receive vacation leave accumulation  
2 on a pro-rata basis.

3 Length of Service from Hire Date	Annual Vacation Allowance
4 Hire date through 8,320 service hours	80 hours
5 Over 8,320 and through 18,720 service hours	120 hours
6 Over 18,720 service hours	160 hours

7 The maximum vacation leave accrual balance that may be carried  
8 over to a future calendar year shall be 480 hours. However, the maximum vacation leave  
9 accrual balance that may be carried over into a future calendar year for an employee with  
10 a balance of more than 480 hours at the end of calendar year 2010 shall be such  
11 employee's vacation leave balance at the end of pay period 26 of calendar year 2010.  
12 Thereafter, the maximum vacation accrual balance for those employees with a balance  
13 greater than 480 hours at the end of calendar year 2010 shall be adjusted annually at the  
14 end of each calendar year and shall never be increased. Any vacation leave accrual  
15 balance in excess of the employee's maximum leave accrual balance at the end of the  
16 calendar year shall be cashed out and paid in accordance with Subsection  
17 13.0613(g)(2)(E)(II).

18 (C) Administration.

19 (I) Vacation periods should be taken annually with the  
20 approval of the appointing authority at such time as will not impair the work schedule or  
21 efficiency of the department but with consideration given to the well-being of the  
22 employee.

23 (II) The minimum charge against accumulated vacation  
24 leave shall be 15 minutes. Vacation leave shall be compensated at the employee's base  
25 rate of pay, except as otherwise provided in this Plan.

26 (III) When a fixed holiday falls within a vacation period, the  
27 holiday time shall not be charged against an employee's earned vacation benefits.

28 (IV) Employees not planning to return to County  
employment at the expiration of a vacation leave, except those retiring, shall be



1 compensated in a lump sum payment for accrued vacation and shall not be carried on  
2 the payroll. Retiring employees may elect to use vacation leave to enhance retirement  
3 benefits or be compensated in a lump sum payment for accrued vacation leave.

4 (D) Prior Service. New employees hired into the County in regular  
5 positions who have been employed by a public jurisdiction or private sector in a  
6 comparable position or a position which has prepared such employees for an assignment  
7 to a position in the Exempt Group may receive credit for such previous experience in the  
8 former agency(s) in determining their vacation accrual rate. Such determination as to the  
9 comparability of previous experience and amount of credit to be granted rests solely with  
10 the Director of Human Resources or designee. Requests for prior service credit should  
11 be made at the time of hire or as soon as possible thereafter but in no event later than  
12 one year from the employee's hire date.

13 (E) Conversion of Vacation Leave to Cash.

14 (I) Elective Conversion. An employee may sell back  
15 vacation leave at the base hourly rate of the employee as hereinafter provided, upon  
16 approval of the appointing authority. Eligible employees may exercise these options  
17 under procedures established by the Director of Human Resources. In lieu of cash, the  
18 employee may designate that part or all of the value of vacation leave be contributed to  
19 the County's 401(k) Defined Contribution Plan or 457(b) Deferred Compensation Plan. In  
20 order to sell back vacation leave prior to termination or retirement, an employee may  
21 exercise the following options:

22 Option 1. Future Accruals. An employee must make an  
23 irrevocable election during the month of December, specifying the number of hours to be  
24 sold back from the next calendar year's vacation leave accrual. Such election must be  
25 made in increments of not less than ten hours and may not exceed 160 hours. All  
26 designated hours remaining in the last pay period of the calendar year will automatically  
27 be converted into cash in the last pay period of the calendar year.

28 Option 2. Existing Accruals. Existing accruals may be cashed

1 out in whole hour increments with a minimum cash out of ten hours and will be subject to  
2 a ten percent penalty.

3 (II) Automatic Conversion. At the end of the last pay  
4 period of the calendar year, an employee shall automatically have any vacation leave  
5 accruals in excess of the employee's maximum vacation leave accrual balance converted  
6 to cash. Such automatic vacation leave cash out shall be paid in pay period 1 of the next  
7 calendar year.

8 (3) Holiday Leave.

9 (A) Fixed Holidays. All employees in regular positions except as  
10 modified in Subdivision (i) shall be entitled to the following holidays:

11 January 1

12 Third Monday in January

13 Third Monday in February

14 Last Monday in May

15 June 19

16 July 4

17 First Monday in September

18 Second Monday in October

19 November 11

20 Thanksgiving Day

21 Day after Thanksgiving

22 December 24

23 December 25

24 December 31

25 (B) Floating Holidays. Employees in regular positions shall be  
26 entitled to a total of eight hours floating holiday time annually provided that the employee  
27 is not on unpaid leave for the entire pay period and is in paid status for the pay period  
28 where the floating holiday time is to accrue. Eight hours floating holiday time shall be

1 accrued during the first pay period prior to the third Monday in January.

2 Floating holidays accrued shall be available for use on the first day  
3 following the pay period in which they are accrued, with the approval of the appointing  
4 authority. Appointing authorities have the right to schedule employees' time off for  
5 accrued holidays to meet the needs of the service but with consideration given to the well-  
6 being of the employee. Employees in regular positions budgeted less than 80 hours per  
7 pay period or job-shared positions shall receive floating holiday accruals on a pro-rata  
8 basis.

9 (C) Maximum Holiday Leave Accrual Balance

10 (I) The maximum holiday leave accrual balance that may  
11 be carried over to a future calendar year shall be 112 hours. However, the maximum  
12 holiday leave accrual balance that may be carried over into a future calendar year for an  
13 employee with a balance of more than 112 hours at the end of calendar year 2010 shall  
14 be such employee's holiday leave balance at the end of pay period 26 of calendar year  
15 2010. Thereafter, the maximum holiday accrual balance for those employees with a  
16 balance greater than 112 hours at the end of calendar year 2010 shall be adjusted  
17 annually at the end of each calendar year and shall never be increased.

18 (II) Effective pay period 14 of calendar year 2022, the  
19 maximum holiday leave accrual balance will increase to 120 hours. The maximum  
20 holiday leave balance that may be carried over to a future calendar year shall be 120  
21 hours. However, employees with a grandfathered balance of more than 120 hours shall  
22 carry over their maximum grandfathered accrual balance in accordance with Subsection  
23 13.0613(g)(3)(C)(I). Any holiday leave accrual balance in excess of the employee's  
24 maximum holiday leave accrual balance at the end of the calendar year shall be cashed  
25 out and paid in accordance with Subsection 13.0613(g)(3)(G)(II).

26 (D) When a fixed holiday falls within a vacation period, the holiday  
27 time shall not be charged against an employee's earned vacation benefits.

28 (E) Whenever an employee is required to work on a fixed holiday

1 or the fixed holiday falls on an employee's regularly scheduled day off, the employee shall  
2 accrue, on an hour-for-hour basis, up to a total of eight hours floating holiday time.

3 (F) When a fixed holiday falls on a Saturday, the previous Friday  
4 will be observed as the fixed holiday except that when the preceding Friday is also a fixed  
5 holiday, the preceding Thursday will be observed as the fixed holiday. When a fixed  
6 holiday falls on a Sunday, the following Monday will be observed as the fixed holiday  
7 except that when the following Monday is also a fixed holiday, the following Tuesday will  
8 be observed as the fixed holiday.

9 (G) Conversion of Holiday Leave to Cash.

10 (I) Elective Conversion. An employee may sell back  
11 holiday time at the base hourly rate of the employee as hereinafter provided, upon  
12 approval of the appointing authority. Eligible employees may exercise this option under  
13 procedures established by the Director of Human Resources. In lieu of cash, the  
14 employee may designate that part or all of the value of holiday time to be contributed to  
15 the County's 401(k) Defined Contribution Plan or 457(b) Deferred Compensation Plan.

16 In order to sell back holiday time prior to termination or  
17 retirement, an employee may exercise the following options:

18 Option 1. Future Accruals. An employee must make an  
19 irrevocable election during the month of December, specifying the number of hours to be  
20 sold back from the next calendar year's holiday time accrual. Such election must be made  
21 in increments of not less than eight hours and may not exceed the annual amount to be  
22 accrued for the next calendar year. All designated hours remaining in the last pay period  
23 of the calendar year will automatically be converted into cash in the last pay period of the  
24 calendar year.

25 Option 2. Existing Accruals. Existing accruals may be cashed  
26 out in whole hour increments with a minimum cash out of eight hours and will be subject  
27 to a ten percent penalty.

28 (II) Automatic Conversion. At the end of the calendar year,

1 an employee shall automatically have any holiday leave accruals in excess of the  
2 employee's maximum holiday leave accrual balance converted to cash. Such automatic  
3 holiday leave cash out shall be paid in pay period 1 of the next calendar year.

4 (H) Grandfathered Holiday Time. An employee promoted from  
5 the Safety Management and Supervisory Unit to the Exempt group who has any  
6 grandfathered holiday time at the time of promotion, will be allowed to retain such  
7 grandfathered holiday time. Such time may be used or compensated at the time of  
8 retirement or separation under the same terms and conditions as are applicable to Safety  
9 Management and Supervisory Unit employees.

10 (4) Special Leaves of Absence Without Pay.

11 (A) General Provisions. A special leave of absence without pay  
12 may be granted to an employee who:

13 (I) Is medically incapacitated to perform the duties of the  
14 position;

15 (II) Desires to engage in a relevant course of study which  
16 will enhance the employee's value to the County;

17 (III) Takes a leave of absence pursuant to the Federal  
18 Family Medical Leave Act (FMLA), the California Family Rights Act (CFRA), and/or  
19 Pregnancy Disability Leave (PDL) provisions of the Fair Employment and Housing Act  
20 (FEHA);

21 (IV) For any reason considered appropriate by the  
22 appointing authority and the Director of Human Resources.

23 (B) Exempt Group employees eligible to receive the automobile  
24 allowance, portable communication device allowance, bilingual compensation, or special  
25 assignment compensation will have these benefits suspended while on unpaid leave and  
26 upon exhausting short-term disability insurance benefits. These benefits will cease the  
27 day following the end of the individual's short-term disability insurance benefits.  
28 Employees off work without pay for disciplinary reasons shall not receive the above listed

1 benefits until they return to full time status.

2 (C) Type of Leave of Absences. There are four types of leaves of  
3 absences. All requests must be in writing and require the approval of the appointing  
4 authority or designee and the Director of Human Resources or designee. Upon request,  
5 the appointing authority or designee and the Director of Human Resources or designee  
6 may grant successive leaves of absence. All benefits shall be administered in  
7 accordance with the appropriate section of this code.

8 (I) Leave of Absence with Right to Return. Leaves of  
9 absence with right to return may be granted to employees in regular positions for a period  
10 not exceeding one year. The employee remains in his or her position.

11 (II) Family Leave. Leaves of absence will be granted in  
12 accordance with the FMLA, the CFRA, and/or the PDL provisions of FEHA. This leave  
13 can be concurrent with use of paid leave or leave of absence without pay with right to  
14 return.

15 An employee on an approved leave of absence without pay  
16 under this provision will continue to receive the benefits outlined in Subsection  
17 13.0613(k)(1)(B)(III) for a period of six pay periods. Certification from a health care  
18 provider is required for all instances of medical leave under this provision. Employees  
19 are required to inform supervisors of the need for leave at least 30 days before  
20 commencement where possible.

21 In instances where the leave is for the birth or placement of a  
22 child and both husband and wife are County employees, both employees are limited to a  
23 total of 12 weeks between them.

24 (III) Leave of Absence without Right to Return.

25 (i) Definition. Leaves of absence without right to  
26 return may be granted to employees with regular status for a period not exceeding one  
27 year. Employees without right to return shall be removed from their position. Retirement  
28 contributions shall remain in the system and cannot be requested for distribution until the

1 expiration of the leave. The employee shall be eligible to purchase medical benefits  
2 pursuant to federal Consolidated Omnibus Reconciliation Act of 1985 (COBRA).

3 (ii) Return Process. An employee may return to the  
4 same department in the classification from which the employee took the leave of absence  
5 with the approval of the appointing authority and the Director of Human Resources.  
6 Alternatively, the employee may apply through Human Resources by the last day of the  
7 leave of absence. The employee will be placed on the eligible list for the classification  
8 from which he or she took the leave of absence without examination. Placement on the  
9 eligible list will be administered in accordance with the requalification provisions of the  
10 Personnel Rules. If the employee does not return to a regular position within 90 calendar  
11 days of the expiration of such a leave the employee shall be terminated from County  
12 service. If reemployed, the employee shall be required to serve a new probationary  
13 period. The Director of Human Resources or designee has the discretion to waive the  
14 requirement to serve a new probationary period.

15 (iii) Benefits Upon Return. An employee who  
16 returns to a regular position within 90 days after the expiration of the leave of absence  
17 without right to return shall retain his or her hire date for purposes of leave accruals and  
18 step advances; except that the employee will not receive service credit for the period of  
19 time the employee is on the leave of absence without right to return. To be reemployed  
20 and retain the above benefits, the employee must be appointed to a position no later than  
21 90 calendar days after the date of expiration of the leave of absence. The 90 days shall  
22 run concurrently with the first 90 days of the one-year period provided in the  
23 reemployment subdivision.

24 (IV) Long-Term Medical Leave of Absence.

25 (i) Definition. An employee with regular status who  
26 suffers from a serious condition may be placed on a medical leave of absence for up to  
27 one year, only after FMLA, CFRA and/or PDL have been exhausted. However, if an  
28 employee meets the service requirements for eligibility for a disability retirement, the long-

1 term medical leave of absence may be extended. The employee is responsible for  
2 providing documentation from a qualified health practitioner prior to approval. The County  
3 retains the right to request medical documentation regarding the employee's continued  
4 incapacity to return to work.

5 The employee will be removed from his or her position  
6 so that the department may fill behind the employee. Retirement contributions shall  
7 remain in the system and cannot be requested for distribution until the expiration of the  
8 leave. The employee shall be eligible to purchase benefits pursuant to the federal  
9 Consolidated Omnibus Reconciliation Act of 1985 (COBRA).

10 Upon the employee's ability to return to work or the  
11 expiration of the leave of absence, whichever comes first, the employee will have the right  
12 to return to the classification within the department from which he or she took a leave of  
13 absence when a funded vacancy for which the employee meets the qualifications is  
14 available. If the employee does not return to work by the expiration date of the leave, or  
15 the soonest date after that for which the department has a vacancy (but in no event later  
16 than 90 days following the expiration of the medical leave of absence), the employee  
17 relinquishes the right to return.

18 (ii) Upon return from a medical leave of absence,  
19 the employee shall retain hire date for purposes of leave accruals and step advances;  
20 except that the employee will not receive service credit for the period of time the employee  
21 is on the medical leave of absence.

22 (5) Medical Emergency Leave. The particulars of the Medical  
23 Emergency Leave policy are as follows:

24 (A) The employee must have regular status with the County or  
25 one year of continuous service in a regular position with the County.

26 (B) The employee must meet all of the following criteria before he  
27 or she becomes eligible for Medical Emergency Leave donation: (1) be on an approved  
28 medical leave of absence for at least 30 calendar days (160 working hours) exclusive of



1 an absence due to a work related injury/illness; (2) submit a doctor's off work order  
2 verifying the medical requirement to be off work for a minimum of 30 calendar days (160  
3 working hours); (3) have exhausted all useable leave balances prior to initial eligibility for  
4 Medical Emergency Leave donations—subsequent accruals will not affect eligibility; and  
5 (4) have also recorded at least 40 hours of sick leave without pay during the current period  
6 of disability.

7 (C) An employee is not eligible for Medical Emergency Leave if  
8 he or she is receiving Workers' Compensation wage replacement (e.g., Coding TTD,  
9 etc.). An employee eligible for State Disability Insurance and/or short-term disability must  
10 agree to integrate these benefits with Medical Emergency Leave.

11 (D) Vacation, holiday, administrative leave or annual leave, as  
12 well as compensatory time, may be donated by employees only on a voluntary and  
13 confidential basis, in increments of eight hours (or in the case of holiday leave four hours)  
14 not to exceed a total of 50 percent of a donor's annual vacation, holiday, administrative  
15 leave, annual leave or compensatory time accrual per employee. The donation may be  
16 made for a specific employee on the time frames established by the Human Resources  
17 Department. The employee (donee) using/coding the Medical Emergency Leave will be  
18 taxed accordingly.

19 (E) The donation is to be utilized for the employee's Medical  
20 Emergency Leave only; the donation to one employee is limited to a total of 1,040 hours  
21 per fiscal year. The maximum of 1,040 hours shall be prorated for those scheduled less  
22 than 40 hours per week. Example: An employee who is regularly scheduled 20 hours per  
23 week is eligible for a maximum donation of 520 hours of Medical Emergency Leave.

24 (F) Medical emergency leave shall be administered in  
25 accordance with procedures approved by Human Resources.

26 (6) Compulsory Leave. If, in the opinion of the appointing authority,  
27 employees are unable to perform the duties of their position for physical or psychological  
28 reasons, they may be removed from duty without pay or may use appropriate accrued

1 paid leave for which they are eligible. In addition, such employees may be required to  
2 submit to an examination by either a physician or other competent authority designated  
3 by the Director of Human Resources or by their own physician or practitioner, as  
4 appropriate. If the examination report of the competent authority (e.g., physician,  
5 appropriate practitioner) shows the employee to be in an unfit condition to perform the  
6 duties required of the position, the appointing authority shall have the right to compel such  
7 employee to take sufficient leave of absence with or without pay, to transfer to another  
8 position without reduction in compensation, and/or follow a prescribed treatment regimen  
9 until medically qualified to return to unrestricted duty. An employee who has been  
10 removed from duty for physical or psychological reasons by the appointing authority, and  
11 was required to submit to an examination, may not return to duty until such time as  
12 medical clearance has been obtained.

13 Employees shall be required to meet all qualifications for employment (e.g.,  
14 licensure, certification, etc.). Employees who become disqualified to perform the duties  
15 of their position (e.g., fail to maintain required licenses) shall be immediately removed  
16 from duty without pay unless permitted to use appropriate accrued paid leave for which  
17 they are eligible and may be subject to appropriate disciplinary action.

18 (7) Military Leave. As provided in the California Military and Veterans  
19 Code section 395 et seq., and any amendment thereto, and the Federal Uniformed  
20 Services Employment and Reemployment Rights Act of 1994, a County employee,  
21 regular, extra-help, per diem, or recurrent may be entitled to the following rights  
22 concerning military leave:

23 (A) Definition. MILITARY LEAVE is defined as the performance  
24 of duty on a voluntary or involuntary basis in a uniformed service under competent  
25 authority and includes active duty, active duty for training, initial active duty for training  
26 (weekend drills), full-time National Guard duty, and a period for which an employee is  
27 absent for the purpose of an examination to determine the fitness of the person to perform  
28 any such duty.

1 (B) Notice and Orders. All employees shall provide advance  
2 notice of military service unless military necessity prevents the giving of notice or the  
3 giving of notice is impossible or unreasonable. Where available, copy of military orders  
4 must accompany the request for leave.

5 (C) Temporary Active Duty. Any employee who is a member of  
6 the reserve corps of the Armed Forces, National Guard, or Naval Militia shall be entitled  
7 to temporary military leave of absence for the purpose of active military training,  
8 encampment, naval cruises, special exercises or like activities provided that the period of  
9 ordered duty does not exceed 180 calendar days, including time involved in going to and  
10 returning from such duty. While on paid status, an employee on temporary military leave  
11 shall receive the same vacation, holiday, and sick leave, step advances, and benefits that  
12 would have been enjoyed had the employee not been absent, providing such employee  
13 has been employed by the County for at least one year immediately prior to the date such  
14 leave begins. In determining the one-year employment requirement, all time spent in  
15 recognized military service, active or temporary, shall be counted. An exception to the  
16 above is that an uncompleted probationary period must be completed upon return to the  
17 job. Any employee meeting the above one-year employment requirement shall be entitled  
18 to receive his or her regular salary or compensation, pursuant to Subsection  
19 13.0613(g)(7)(E).

20 (D) Full-Time Active Duty. Employees who resign from positions  
21 to serve in the Armed Forces for more than 180 days, shall have a right to return to former  
22 classification upon serving written notice to the appointing authority, no later than 90 days  
23 after completion of such service. Returning employees are subject to a  
24 physical/psychological examination. Should such employee's former classification have  
25 been abolished, then the employee shall be entitled to a classification of comparable  
26 functions, duties, and compensation if such classification exists, or to a comparable  
27 vacant position for which the employee is qualified.

28 The right to return to former classification shall include the right to be

1 restored to such civil service status as the employee would have if the employee had not  
2 so resigned; and no other person shall acquire civil service status in the same position so  
3 as to deprive such employee of this right to restoration.

4 Eligible employees are also entitled to the reemployment and benefit  
5 rights as further described in the Uniformed Services Employment and Reemployment  
6 Rights Act, 38 U.S.C. sections 4301 to 4333. Specifically, a returning employee will  
7 receive restoration of original hire and benefit date, salary step, vacation accrual rate, sick  
8 leave balance (unless the employee has received payment for unused sick leave in  
9 accordance with provisions contained herein), the retirement plan contribution rate, and  
10 retirement system contributions (provided the employee complies with any requirements  
11 established by the Retirement Board). However, such employee will not have accrued  
12 vacation, sick leave, or other benefit while absent from County employment, except as  
13 provided in the temporary duty provision.

14 (E) Compensation. This provision does not include an  
15 employee's attendance for inactive duty, commonly referred to as weekend reserve  
16 meetings, muster duty, or drills. Employees must use their own time to attend such  
17 meetings. Should the meetings unavoidably conflict with an employee's regular working  
18 hours, the employee is required to use vacation or holiday leave, leave without pay, or  
19 make up the time. Employees who are called in for a medical examination to determine  
20 physical fitness for military duty must also use vacation leave, leave without pay, or make  
21 up the time. Employees cannot be required to use their accrued leave. Any employee  
22 meeting the requirements in (C) and (D) shall be entitled to receive their regular salary or  
23 compensation for the first 30 calendar days of any such leave. Pay for such purposes  
24 shall not exceed 30 days in any one fiscal year and shall be paid only for the employee's  
25 regularly scheduled workdays that fall within the 30 calendar days.

26 (F) Extension of Benefits. The County recognizes the increased  
27 requirements of the military due to the current threats facing the United States of America  
28 and, as such, has established a program under which employees may be eligible for an

1 extension of benefits. Employees who are called to active duty as a result of the activation  
2 of military reservists beginning in September 2001, and who are eligible to receive the 30  
3 calendar days military leave compensation, and are on an involuntary order as defined  
4 by Enclosure 4 of the Department of Defense Instruction 1215.06 shall receive the  
5 difference between their base County salary and their military salary starting on the thirty-  
6 first calendar day of military leave. The difference in salary shall continue for the period  
7 approved by the Board of Supervisors. During this period, the County will continue to  
8 provide the employee the benefits and all leave accruals as were provided prior to such  
9 active duty. Retirement contributions and service credit will be granted if the employee  
10 had enough pay to cover the entire retirement system contribution. If the employee does  
11 not receive enough pay to cover the retirement system contribution, no contribution or  
12 credit will be given. Employees should note that the accidental death and  
13 dismemberment (AD&D) plan contains a war exclusion.

14                   If the employee becomes eligible for full County payment for the first  
15 thirty days of military leave provided in (C) of this subsection, the extended payments  
16 provided under this section shall be suspended and shall be continued after the 30 days  
17 compensation has been completed. No compensation shall be paid beyond the thirty  
18 days leave period, unless such compensation is expressly approved by the Board of  
19 Supervisors. The County may unilaterally extend the benefits of this subsection upon the  
20 approval of the Board of Supervisors.

21                   (8) Political Leave. Any employee who is a declared candidate for public  
22 office (i.e., a candidate who has filed the appropriate documents) shall have the right to  
23 a leave of absence without pay with or without right to return for a reasonable period to  
24 campaign for the election. Such leave is subject to the conditions governing special  
25 leaves of absence without pay contained herein.

26                   (9) Jury Duty Leave. Employees in regular positions who are  
27 ordered/summoned to serve jury duty including Federal Grand Jury duty shall be entitled  
28 to base pay for those hours of absence from work, provided the employee waives fees

1 for service, other than mileage. Such employees will further be required to deliver a “Jury  
2 Duty Certification” form at the end of the required jury duty to verify such service. When  
3 practicable, the appointing authority will convert an employee’s regular tour of duty to a  
4 day shift tour of duty during the period of jury duty. Employees required to serve on a jury  
5 must report to work before and after jury duty provided there is an opportunity for at least  
6 one hour of actual work time. Employees volunteering to serve on a Grand Jury shall be  
7 granted a leave of absence without pay to perform the duties of a member of the Grand  
8 Jury, in the same manner as provided in Subsection 13.0613(g)(4).

9 (10) Examination Time. Employees having regular status in regular  
10 positions at the time of application, or employees who do not have regular status but have  
11 previously held regular status and continuously remained a County employee, shall be  
12 entitled to a reasonable amount of time off with pay for the purpose of attending all  
13 examination processes (e.g., selection interviews, etc.) required for selection to a different  
14 County position. Employees are responsible for notifying and obtaining approval from  
15 their immediate supervisor prior to taking such leave. Examination time off shall not be  
16 charged against any accumulated leave balances and shall be compensated at the  
17 employee’s base hourly rate.

18 (11) Witness Leave. Employees in regular positions shall be entitled to a  
19 leave of absence from work when subpoenaed to testify as a witness, such subpoena  
20 being properly issued by a court, agency, or commission legally empowered to subpoena  
21 witnesses. This benefit shall not apply in any case in which the subpoenaed employee  
22 is a party to the action or the subpoena has arisen out of the employee’s scope of  
23 employment. Witness leave shall not be charged against any accumulated leave  
24 balances and shall be compensated at the employee’s base hourly rate. This benefit will  
25 be paid only if the employee has demanded witness fees at the time of service of the  
26 subpoena, and such fees are turned over to the County.

27 (12) Blood Donations. Employees in regular positions who donate blood  
28 without receiving compensation for such donation, may have up to two hours off with pay

1 to recover with prior approval of the immediate supervisor for each such donation. This  
2 benefit shall not be charged to any accumulated leave; provided, however, if the  
3 employee is unable to work, any time in excess of two hours may be charged to  
4 accumulated sick leave or be taken as leave without pay. Evidence of each donation  
5 must be presented to the appointing authority to receive this benefit.

6 Employees in regular positions who are apheresis donors may have up to  
7 four hours off with pay to recover with prior approval of the immediate supervisor for each  
8 such donation, provided no compensation is received for such donation. This benefit  
9 shall not be charged to any accumulated leave; provided, however, if the employee is  
10 unable to work any time in excess of four hours may be charged to accumulated sick  
11 leave or be taken as leave without pay. Evidence of each apheresis donation must be  
12 presented to the appointing authority to receive this benefit.

13 (13) Bereavement Leave. Employees in regular positions may use up to  
14 two days paid leave, not charged to the employee's personal leave balances, per  
15 occurrence for bereavement due to the death of an employee's family member as defined  
16 in Subsection 13.0613(g)(1)(A)(I) except for a person "designated" by the employee for  
17 sick leave purposes. One additional day shall be granted if the employee travels over  
18 1,000 miles from his or her residence to the bereavement service(s). This additional day  
19 shall not be charged to the employee's personal leave balances. The appointing authority  
20 may request verification of distance traveled. All employees are entitled to a total of 5  
21 days of unpaid bereavement leave. The five days of leave shall include paid leave under  
22 this section, and use of sick leave as defined in section 13.0613(g)(1)(E)(II) above.

23 An employee who has been with the County for 30 days or more may utilize  
24 Bereavement Leave for each occurrence of reproductive loss. Reproductive loss includes  
25 failed adoption, failed surrogacy, miscarriage, stillbirth, and unsuccessful assisted  
26 reproduction as defined by California Government Code section 12945.6. The leave may  
27 be non-consecutive, but must be taken within 3 months of the event as defined by  
28 California Government Code section 12945.6(a)(7). If an employee experiences more

1 than one reproductive loss event in a 12-month period, Bereavement Leave for  
2 reproductive loss shall not exceed 20 days within a 12-month period.

3 (14) Leave Accruals While on Disability Leave. Employees receiving the  
4 benefits of workers' compensation or short-term disability leave receive partial  
5 replacement of their income through these benefits. Employees on these types of  
6 disability leaves may choose to fully integrate, partially integrate, or not integrate personal  
7 leave time with these disability payments.

8 The maximum amount the employee receives from integrating leave time  
9 with disability payments shall not exceed 100 percent of the employee's base salary. Paid  
10 personal leave time coded on the employee's time and labor report will be limited to the  
11 amount of leave necessary to integrate benefits to the level designated by the employee.  
12 When the exact amount is not known, a good faith estimate may be made and the amount  
13 will be adjusted later as necessary. If any overpayments are made, the employee will be  
14 required to repay that amount. An employee who knowingly receives payment in excess  
15 of his or her regular base salary is required to report it to his or her Departmental payroll  
16 clerk.

17 Employees who are fully integrating accrued leave time with disability  
18 benefits and shall be eligible to receive full accruals of vacation and sick leave.  
19 Employees who are not fully integrating shall earn pro-rated vacation and sick leave  
20 accruals based upon paid leave time coded on the time and labor report only.

21 Employees who are fully integrating paid leave time with disability benefit(s)  
22 will be eligible for fixed holiday pay provided that they are on the payroll for the entire pay  
23 period and have no unapproved leave for the pay period. Employees who are partially  
24 integrating or not integrating paid leave time with disability benefits will be paid for  
25 holidays in accordance with the holiday leave provisions in Subsection 13.0613(g)(3).

26 (h) Relocation. Employees who are required by order of their appointing  
27 authority to change their principal place of residence because of a reassignment to meet  
28 the needs of the service or because of layoff will be granted time off with pay not to exceed



1 two work days and up to \$400.00 reimbursement toward the actual cost of relocating their  
2 personal furnishings and belongings.

3 (i) Special Assignment Compensation. Increases in pay may be granted to  
4 recognize the temporary assignment of additional responsibilities that are significant in  
5 nature and beyond the normal scope of the position. No award shall be made in any  
6 situation related to a vacation, short-term illness or other relief which is six weeks or less.  
7 The duration of such assignments is not intended to exceed one calendar year except in  
8 unusual circumstance approved by both the appointing authority and the Director of  
9 Human Resources. Employees will normally not be in a probationary status. The  
10 employee shall be required to meet standards for satisfactory performance.

11 Compensation shall be awarded in pay period increments and shall be in the form  
12 of a specified percentage of the employee's base pay. The Director of Human Resources  
13 will determine the amount in increments of one-half percent from a minimum of two and  
14 one-half percent up to a maximum of seven and one-half percent. The additional  
15 compensation will be computed at the specified percentage of the current base pay of the  
16 employee for each pay period. Such increases in pay shall not affect an employee's step  
17 advancement in the base range pursuant to the salary rates and step advancements  
18 subdivision.

19 Requests for special assignment compensation may be initiated by the appointing  
20 authority or an employee via the appointing authority. The appointing authority and the  
21 employee bear mutual responsibility for initiating the compensation request in a timely  
22 manner and adhering to the compensation provisions defined in this provision. It is  
23 important to obtain Human Resources Department review of the request in advance of  
24 the date the employee begins the assignment, since there is no guarantee that the  
25 request will be approved. Special assignment compensation is to be effective only with  
26 the Director of Human Resources written approval, assignment of the greater level of  
27 duties, and signed acceptance by the employee.

28 This provision shall not be utilized to circumvent or provide additional

1 compensation over and above that which may be provided in the subsection on  
2 assignment to vacant higher position and the Personnel Rules. These aforementioned  
3 provisions are mutually exclusive concepts and as such there shall be no dual or multiple  
4 requests based on the same facts.

5 (j) Expenses Incurred in Conducting County Business and Expense  
6 Reimbursement.

7 (1) General Provisions. Employees in the Exempt Group shall be  
8 reimbursed for all expenses incurred in connection with the conduct of County business,  
9 including, but not limited to, travel, lodging, meals, laundering, gratuities, and other related  
10 costs. Payment for actual expenses is subject to the approval of the appointing authority.  
11 The Chief Executive Officer, Assistant Executive Officers, and County officers with  
12 department head status may incur necessary County expenses involved with activities  
13 and functions of their departments and arrange for the County to be billed directly for such  
14 expenses.

15 The purpose of this subdivision is to define the policy and procedures by  
16 which employees shall report and be reimbursed for necessary expenses incurred on  
17 behalf of San Bernardino County, except as may be otherwise provided in this code.

18 (2) Responsibilities. It shall be the responsibility of each appointing  
19 authority or designee to investigate and approve each request for expense  
20 reimbursement. It shall be the responsibility of each employee to obtain prior approval  
21 from the appropriate appointing authority or designee to incur a business expense or to  
22 exceed maximum allowable amounts provided in Section (7) below.

23 Prior approval may be in the form of standing orders issued by the  
24 appointing authority. Failure to obtain prior approval may result in denial of any expense  
25 claim (or excess amount) not pre-approved.

26 (3) Travel Authorization.

27 (A) Travel outside the State of California must be approved by the  
28 Chief Executive Officer or designee. Requests for such travel shall be submitted to the

1 County Administrative Office on a travel request form.

2 (B) The appointing authority or designee shall initiate travel  
3 requests. The Chief Executive Officer and Auditor-Controller/Treasurer/Tax Collector  
4 shall be notified in writing of all such designees.

5 (C) The appointing authority or designee is authorized to approve  
6 necessary travel within the State of California and use of transportation mode consistent  
7 with this subdivision.

8 (4) Authorization for Attendance at Meetings.

9 (A) Appointing authorities may authorize attendance at meetings  
10 at County expense when the program material is directly related to an important phase of  
11 County service and holds promise of benefit to the County as a result of such attendance.

12 (B) Authorization for attendance at meetings without expense  
13 reimbursement, but on County time, may be granted when the employee is engaged on  
14 the County's behalf, but from which the gain will inure principally to the benefit of the  
15 employee and only incidentally to the County.

16 (5) Records and Reimbursements.

17 (A) Requests for expense reimbursements should be submitted  
18 once each month and within one year of the date that the expense was incurred.

19 (B) Receipts or vouchers which verify the claimed expenditures  
20 will be required for all items of expense, except:

21 (I) Subsistence, except as otherwise provided in this  
22 subdivision;

23 (II) Private mileage (e.g., mileage to the airport);

24 (III) Telephone or other communication-related charges  
25 including Wi-Fi and internet access fees if needed to conduct County business;

26 (IV) Other authorized expenses of less than \$1.00.

27 (C) Claims for expense reimbursement totaling less than \$1.00 in  
28 any fiscal year shall not be paid.

1 (D) Reimbursement shall not be made for any personal expenses  
2 such as, but not limited to, entertainment, barbering, personal grooming, alcoholic  
3 beverages, etc.

4 (E) Except as otherwise provided in this subdivision, expense  
5 reimbursements shall be made on an actual cost basis.

6 (F) If the receipt is unavailable, the employee may submit a  
7 signed statement with an explanation of expenses (i.e., itemized list of expenses with  
8 location, date, dollar amount, and reason for expenses) and an explanation as to why the  
9 receipt is unavailable.

10 (G) Expense reimbursements may be made via electronic fund  
11 transfer into the financial institution of the employee's choice or by pay card. Employees  
12 who fail to make arrangements for direct deposit shall receive reimbursements via pay  
13 card.

14 (6) Transportation Modes.

15 (A) The general rule for selection of a mode of transportation is  
16 that mode which represents the lowest expense to the County. Where an employee is  
17 given the choice between several means of travel (e.g., use of County vehicle vs. own  
18 personal vehicle, flying vs. driving, etc.) and the employee chooses the option that is more  
19 costly, the employee shall only be reimbursed for the lesser cost option. For example, if  
20 an employee chooses to drive his or her own vehicle when offered a County vehicle, the  
21 employee shall not be entitled to any reimbursement. Similarly, if the cost of flying on an  
22 airplane is less than the cost of driving, the employee shall only be reimbursed for the  
23 amount the County would have paid for the flight.

24 (B) Travel via Private Automobile.

25 (I) Reimbursement for use of privately-owned  
26 automobiles to conduct County business shall be at the IRS allowable rate.  
27 Reimbursement at this rate shall be considered as full and complete payment for actual  
28 necessary expenses for the use of the private automobile, insurance, maintenance and

1 all other transportation related costs. The County does not provide any insurance for  
2 private automobiles used on County business. The owner of an automobile is responsible  
3 for the personal liability and property damage insurance when the vehicle is used on  
4 County business.

5 (II) When employees, traveling on official County  
6 business, leave directly from their principal place of residence rather than from their  
7 assigned work location, mileage allowed to the first work contact point shall be the  
8 difference between the distance from the residence to the assigned work location and the  
9 distance from the residence to the first work contact point. If the first work contact point  
10 is closer than the assigned work location, no mileage shall be allowed. If the employee  
11 departs from the last work contact point directly to the residence, the same principle  
12 governs.

13 (III) Employees may have multiple assigned work  
14 locations. Mileage allowed is based on the assigned work location for that day. When  
15 employees have more than one assigned work location in a standard tour of duty, mileage  
16 shall be allowed between assigned work locations. In no case will mileage be allowed  
17 between the employee's residence and the assigned work location.

18 (C) Travel via Air.

19 (I) Commercial Aircraft. When commercial aircraft  
20 transportation is approved, the "cost of public carrier" shall mean the cost of air coach  
21 class rate including tax and security surcharges. Travel via charter aircraft shall be limited  
22 to emergencies, or when other types of transportation are impractical or more expensive.  
23 Specific prior approval for travel via charter aircraft must be obtained from the Chief  
24 Executive Officer or designee.

25 (II) Private Aircraft. When private aircraft transportation is  
26 approved by the Chief Executive Officer or designee, reimbursement will be as follows:

27 (i) Reimbursement for use of aircraft owned or  
28 rented and flown by County personnel will be for equivalent road miles at the first mile

1 rate of the current private automobile use reimbursement schedule. Landing or tie-down  
2 fees will be reimbursed similar to auto parking charges.

3 (ii) Reimbursement for trips to and from the  
4 following destinations will be limited to the cost of public carrier except when justified by  
5 unusual circumstances as determined by the Chief Executive Officer or designee:  
6 Sacramento, San Francisco, Oakland and San Jose.

7 (iii) Authorized charter flights with a licensed charter  
8 service providing the aircraft and pilot will be reimbursed at actual cost. Charter flights  
9 must be individually approved by the Chief Executive Officer or designee prior to  
10 departure.

11 (iv) The employee or owner of the aircraft must  
12 maintain on file, with the County's Risk Management Department, a current policy for  
13 aviation comprehensive general liability insurance, which includes the County as an  
14 additional insured and covers all operations performed by or on behalf of the employee  
15 or owner of the aircraft for bodily injury and property damage with a combined single limit  
16 of not less than \$1,000,000.00, per occurrence and \$2,000,000.00, general aggregate.

17 (D) Travel via Rental Vehicles. Reimbursement will be provided  
18 for the cost of a rental vehicle used for business purposes if such use is approved by the  
19 appointing authority. Rental vehicles are covered for liability and vehicle physical damage  
20 under the County's self-insurance program. Reimbursement will not be provided for the  
21 additional costs incurred if any employee purchased any additional insurance or signs a  
22 collision damage waiver (CDW) when renting a vehicle for County business. Requests  
23 for reimbursement for gasoline for rental vehicles must be accompanied by a copy of the  
24 rental agreement or rental receipt and gasoline receipt.

25 (E) Travel via Ride-Share Service, Taxi, or Public/Mass Transit.  
26 Reimbursement will be provided for the cost of using a ride-share service, (e.g., Uber or  
27 Lyft), taxi, or public/mass transit (e.g., bus, streetcar, and ferry) if such expenses are  
28 incurred for County business and approved by the appointing authority.

1 (F) Incidental Travel Expenses. Reimbursement will be provided  
2 for the cost of incidental travel expenses such as bridge tolls, road tolls and parking fees  
3 if such expenses are incurred as part of County business and approved by the appointing  
4 authority. Valet parking will not be reimbursed unless self-parking is not available or  
5 security is a concern.

6 (7) Subsistence.

7 (A) Subsistence allowances for lodging and meals shall not be  
8 allowed without prior approval of the appointing authority or designee as necessary for  
9 the purpose of conducting County business. Meal and lodging selections should  
10 represent a reasonable cost to the County and be generally consistent with the rates  
11 established by the General Services Administration (GSA). Excess charges greater than  
12 the allowances listed below in Subdivisions (B) and (C) may be authorized under special  
13 conditions, such as a convention or conference requirement (e.g., lodging at the hotel  
14 where the conference is held) or if County business requires lodging and meals in an area  
15 of unusually high cost (i.e., Non-Standard Areas as established by the GSA). Employees  
16 may be reimbursed for expenses in high cost areas for the actual cost incurred, but  
17 generally not to exceed the per diem amounts established by the GSA for that area and  
18 month. Receipts are mandatory to obtain reimbursement for all lodging expenses, and  
19 except as provided below, for all meal expenses claimed.

20 (B) An employee may be reimbursed for lodging expenses at  
21 actual cost, generally not to exceed the standard lodging per diem rate as established by  
22 the GSA, except as otherwise provided in Subdivision (A) above.

23 (C) Except as otherwise provided in Subdivision (A) above,  
24 reimbursements for meal expenses for up to three separate meals per day may be  
25 provided as follows:

26 (I) With receipts. An employee may be reimbursed for  
27 meal expense at actual cost not to exceed eleven dollars (\$11.00) for breakfast; fifteen  
28 dollars (\$15.00) for lunch; and twenty-four dollars (\$24.00) for dinner, all plus tax and up

1 to 15 percent gratuity.

2 (II) Without receipts. An employee may be reimbursed for  
3 meal expense at per diem rates not to exceed six dollars (\$6.00) for breakfast; nine dollars  
4 (\$9.00) for lunch; and nineteen dollars (\$19.00) for dinner, all plus tax and up to 15 percent  
5 gratuity.

6 (D) Where the cost of a meal is included as part of a registration  
7 charge for an event (e.g., continental breakfast at a conference or training seminar) or in  
8 the cost of lodging, an employee may not claim reimbursement for that meal.

9 (8) Expense Advances. Advancement of funds for business expenses  
10 can be obtained from the Auditor-Controller/Treasurer/Tax Collector's Office through  
11 submission of the appropriate form. Advancements shall not exceed the per diem  
12 allowances set forth herein. The minimum amount to be advanced is \$50.00.

13 (9) County Credit Cards. The appointing authority may issue a County  
14 credit card to an employee and require business expenses be paid for with said card. If  
15 unauthorized charges are placed on the card, the employee shall be required to  
16 reimburse the County.

17 (k) Medical Insurance and Retirement System Contributions.

18 (1) Medical Insurance Contributions.

19 (A) Section 125 Premium Conversion Plan.

20 (I) Eligible employees shall be provided with a Section  
21 125 premium conversion plan. The purpose of the plan is to provide employees a choice  
22 between paying premiums with either pre-tax salary reductions or after-tax payroll  
23 deductions for medical insurance, dental insurance, vision insurance, voluntary life (to the  
24 Internal Revenue Service (IRS) specified limit) and accidental death and dismemberment  
25 insurance premiums currently maintained for Exempt Group employees or any other  
26 programs(s). The amount of the pre-tax salary reduction or after-tax payroll deduction  
27 must be equal to the required insurance premium.

28 (II) Medical and dental coverage elections shall not reduce



1 earnable compensation for purposes of calculating benefits or contributions for the  
2 SBCERA.

3 (III) To be eligible for the Section 125 premium conversion  
4 plan, an employee must be eligible to participate in medical, dental, vision, AD&D, and/or  
5 life insurance and have a premium deduction for these benefit plans.

6 (IV) Election of pre-tax salary reductions and after-tax  
7 payroll deductions shall be made within 60 days of the initial eligibility period in a manner  
8 and on such forms designated by Human Resources. Failure to timely submit appropriate  
9 paperwork will result in after-tax payroll deductions for all eligible premiums for the  
10 remainder of the plan year.

11 (V) Once a salary reduction has begun, in no event will  
12 changes in elections be permitted during the plan year except to the extent permitted  
13 under IRS rulings and regulations, and consistent with the County's Section 125 plan  
14 document. The employee must submit request for a change due to a mid-year qualifying  
15 event within 60 days of the qualifying event.

16 (B) Medical and Dental Subsidies.

17 (I) The County has established a medical premium  
18 subsidy (MPS) to offset the cost of medical and dental plan premiums charged to eligible  
19 employees. The MPS shall be applied first to medical plan premiums and then to dental  
20 plan premiums. The applicable MPS amount shall be paid directly to the providers of the  
21 County-sponsored medical and dental plans in which the eligible employee has enrolled.  
22 In no case, shall the MPS exceed the total cost of the medical and dental insurance  
23 premium for the coverage selected.

24 Effective February 10, 2024, the following MPS amounts apply:

Coverage Type	Scheduled for 40 to 60 Hours	Scheduled for 61 to 80 Hours
Employee Only	\$155.38	\$310.75
Employee + 1	\$249.94	\$499.87
Employee + 2	\$351.02	\$702.03

1 Effective July 13, 2024, the MPS amounts for employees scheduled for 61 to 80  
2 hours, will increase for each tier (i.e., Employee-Only, Employee + 1, Employee + 2) by  
3 100% of the benefit plan year premium increase of the County's Blue Shield Signature  
4 HMO. This new MPS amount shall be the new basis for subsequent years. For example,  
5 if the 2024/2025 Benefit Plan Year premium for the Employee-Only tier increases by \$20  
6 per pay period, the MPS amount will increase by \$20 per pay period (i.e., 100% of \$20)  
7 and the total MPS for the Employee-Only tier will be \$330.75. Employees scheduled for  
8 40 to 60 hours will receive an amount equal to one-half of the MPS for employees  
9 scheduled for 61 to 80 hours.

10 Effective July 12, 2025, the MPS amounts for employees scheduled for 61 to 80  
11 hours, will increase for each tier (i.e., Employee-Only, Employee + 1, Employee + 2) by  
12 100% of the benefit plan year premium increase of the County's Blue Shield Signature  
13 HMO. This new MPS amount shall be the new basis for subsequent years.

14 Employees scheduled for 40 to 60 hours will receive an amount equal to one-half  
15 of the MPS for employees scheduled for 61 to 80 hours.

16 Effective July 11, 2026, the MPS amounts for employees scheduled for 61 to 80  
17 hours, will increase for each tier (i.e., Employee-Only, Employee + 1, Employee + 2) by  
18 100% of the benefit plan year premium increase of the County's Blue Shield Signature  
19 HMO. This new MPS amount shall be the new basis for subsequent years.

20 Employees scheduled for 40 to 60 hours will receive an amount equal to one-half  
21 of the MPS for employees scheduled for 61 to 80 hours.

22 (II) The County has established a dental premium subsidy  
23 (DPS) for all employees who are enrolled in both County-sponsored medical and dental  
24 coverage whose premium costs for medical and dental exceeds the MPS. The amount  
25 of the DPS shall be up to \$9.46, but not to exceed the combined total of the employee's  
26 out-of-pocket premium expenses.

27 (III) Eligibility for MPS and DPS While on Leave.

28 (i) FMLA/CFRA. Employees who are on approved

1 leave, pursuant to FMLA/CFRA law and whose paid hours in a pay period are less than  
2 the required number of hours designated in Subsection 13.0613(f)(1) above will continue  
3 to be enrolled in a County-sponsored medical plan and receive MPS and DPS in  
4 accordance with applicable law.

5 (ii) Pregnancy Disability Leave (PDL). An  
6 employee on an approved pregnancy disability leave is eligible for continuation of MPS  
7 and DPS in accordance with PDL, Government Code section 12945.

8 (iii) Workers' Compensation. Employees who are  
9 on an approved leave based on an approved workers' compensation claim shall continue  
10 to receive the MPS and DPS for up to a total of 20 pay periods while off work due to that  
11 work injury as long as the employee pays his or her portion of the premiums on time. If  
12 any subsequent workers' compensation claims occur during the initial 20 pay periods, the  
13 remaining MPS eligibility from the original claim shall run concurrent with any additional  
14 approved workers' compensation claims that occur during the initial claim. For example,  
15 if the employee is receiving the MPS and DPS for 20 pay periods for an injury and after  
16 ten pay periods another workers' compensation claim is approved and the employee is  
17 eligible to receive the MPS and DPS for an additional 20 pay periods, ten pay periods will  
18 run concurrent with the initial claim, for a total of 30 pay periods. Employees who are still  
19 on workers' compensation after the expiration of the initial 20 pay periods shall continue  
20 to receive MPS and DPS provided the employee is in paid status.

21 (iv) Short Term Disability. Employees who are on  
22 short-term disability (STD) insurance provided by the County or State Disability Insurance  
23 (SDI) shall continue to receive the MPS and DPS provided the employee is in paid status.

24 (v) Per Episode of Illness or Injury. Employees who  
25 are on an approved medical leave of absence and whose paid hours in a pay period are  
26 less than the required number of hours will continue to receive the benefits of this  
27 Subdivision for up to six pay periods per episode of illness or injury.

28 (2) Retirement System Contributions.

1 (A) County Contributions. The County shall pay all required  
2 employer contributions to the San Bernardino County Employee's Retirement Association  
3 (SBCERA).

4 (B) Employee Contributions. All employee Retirement System  
5 contribution obligations shall be "picked up" for tax purposes only pursuant to this section.  
6 The Auditor-Controller/Treasurer/Tax Collector has implemented the pickup of such  
7 retirement system contributions under Internal Revenue Code subsection 414(h)(2).

8 The County shall make member contributions under this subdivision  
9 on behalf of the employee which shall be in lieu of the employee's contributions and such  
10 contributions shall be treated as employer contributions for purposes of reporting and  
11 wage withholding under the Internal Revenue Code and the Revenue and Taxation Code.  
12 The amounts picked up under this subdivision shall be recouped through offsets against  
13 the salary of each employee for whom the County picks up member contributions. These  
14 offsets are akin to a reduction in salary and shall be made solely for purposes of income  
15 tax reporting and withholding. The member contributions picked up by the County under  
16 this subdivision shall be treated as compensation paid to County employees for all other  
17 purposes. County-paid employer contributions to SBCERA under this subdivision shall  
18 be paid from the same source of funds used in paying the salaries of the affected  
19 employees. No employee shall have the option to receive the retirement system  
20 contribution amounts directly instead of having them paid to SBCERA.

21 Until retirement or separation, all contributions picked up under this  
22 subdivision will be considered for tax purposes as employer-paid contributions.

23 (C) Special Provisions.

24 (I) Except as provided below, employees who have 30  
25 years of service credit shall not be paid in cash seven percent of earnable compensation.  
26 Employees with at least 25 years of service as set forth in Government Code section  
27 31625.3 as of June 18, 2011, and who either already have or thereafter attain 30 years  
28 of service credit as set forth in Government Code section 31625.3 shall have one

1 opportunity during the employee's employment to receive cash payments of seven  
2 percent of earnable compensation for up to 26 consecutive pay periods.

3 (II) Employees who are over the age of 60 at the time of  
4 hire, and who are in a regular position, and who choose not to be a member of SBCERA,  
5 shall be enrolled in the County's 401(k) Salary Savings Plan. The County shall contribute  
6 the applicable percent of the employee's biweekly salary as defined in Subsection  
7 13.0613(q) to the Plan, and the employee shall contribute a minimum of three percent of  
8 biweekly salary to the plan, not to exceed the annual limits of the Plan as defined in the  
9 Internal Revenue Code.

10 (D) Survivor Benefits. Survivor Benefits are payable to employed  
11 general retirement members with at least 18 months continuous retirement membership  
12 pursuant to Government Code section 31855.12. An equal, non-refundable employer  
13 and employee biweekly contribution will be paid to SBCERA as provided in the annual  
14 actuarial study.

15 (E) Special Provisions for Exempt Safety Employees. The  
16 following Subdivision shall apply to all members of the Exempt Group who are safety  
17 members of SBCERA as defined in Government Code section 31469.3, on October 1,  
18 2003.

19 For Tier 1 safety members of SBCERA, the County adopted a  
20 resolution making Government Code section 31664.1 applicable to safety members,  
21 effective October 1, 2003. The County also adopted a resolution pursuant to Government  
22 Code section 31678.2, applying the formula set forth in Government Code section  
23 31664.1 applicable to all prior safety service credit for every eligible employee under this  
24 Subdivision.

25 For Tier 2 safety members, the applicable retirement formula is as  
26 provided by applicable law.

27 (3) Flexible Spending Account (FSA) for Medical Related Expenses.

28 (A) General. The County has established a Medical Expense

1 Reimbursement Plan, also known as a Flexible Spending Account (FSA). This plan has  
2 been established in accordance with the provisions of Internal Revenue Code section  
3 125. Human Resources will serve as the FSA Plan administrator and will administer the  
4 FSA in accordance with the County's plan document. The FSA's plan year will coincide  
5 with the County's benefit plan year.

6 (B) Eligible employees may contribute to the FSA, on a pre-tax  
7 basis, an amount up to the Internal Revenue Code's annual maximum. This annual  
8 contribution is made by the employee via equal biweekly payroll deductions. The County  
9 will also contribute up to \$40.00 per biweekly pay period, matching Exempt employee  
10 contributions dollar for dollar. Effective February 1, 2020, the County will contribute up to  
11 an additional \$10.00 per biweekly pay period, matching Exempt employee contribution  
12 dollar for dollar, for employees who select the County-sponsored Blue Shield Access +  
13 HMO Plan or the Kaiser Choice HMO Plan and elect to enroll in the FSA. FSA participants  
14 must elect to enroll each year in order to continue participation. Upon enrolling in the  
15 FSA, employees may not change their designated biweekly contribution amount or  
16 discontinue making contributions for the remainder of the plan year except as permitted  
17 by the Internal Revenue Code. Any unused amounts remaining in an employee's FSA  
18 account at the end of the Plan year shall be forfeited except as permitted by the Internal  
19 Revenue Code and the County's plan document. Contributions made to the FSA may be  
20 used for receiving non-taxable reimbursements of eligible medical expenses not covered  
21 by insurance. Eligible reimbursable expenses are those medical expenses that qualify  
22 as determined under Internal Revenue Code section 213.

23 (4) Retirement Medical Trust Fund. A Retirement Medical Trust Fund  
24 (RMT) has been established. Exempt Group employees with five or more years of  
25 participation in SBCERA are eligible to participate. The trust is a Voluntary Employee  
26 Benefit Association (VEBA) and will comply with all the provisions of Internal Revenue  
27 Code section 501(c)(9).

28 The Retirement Medical Trust Fund will be administered by Human

1 Resources as the plan administrator in accordance with the plan document and applicable  
2 law.

3 (A) Sick Leave Conversion Eligibility. Exempt Group employees  
4 with five or more years of participation in SBCERA are eligible to participate in the Trust.  
5 The purchase of additional retirement credit or other retirement service credit and/or  
6 participation in other public sector retirement systems may be counted towards the five  
7 year service requirement provided that the employee has not withdrawn their  
8 contributions from the system(s) and the employee is also a member of SBCERA.

9 Employees who wish to receive credit for participation in other public  
10 retirement systems must provide the Plan Administrator written evidence of participation  
11 and that contributions made to the system(s) have not been withdrawn. Requests for  
12 prior service credit should be made at the time of hire or as soon as possible thereafter  
13 but in no event later than one year from the employee's hire date.

14 (B) Sick Leave Conversion Formula. At separation from County  
15 service for reasons other than death, all eligible employees will be required to contribute  
16 the cash value of their unused sick leave balances to the Trust at the rate of 80 percent  
17 of the cash value of unused sick leave hours, up to a maximum of 1,500 hours.

18 (C) County Contribution. The County will contribute to the RMT  
19 as follows:

Years of Service	Percentage of Base Salary*
Exempt – 5-9 years	2.00%
Exempt – 10-15 years	2.75%
Exempt – 16 or more years	3.75%

23 \*For purposes of the RMT contribution, base salary is as defined in the RMT plan  
24 document.

25 Employees who wish to receive credit for participation in other public  
26 retirement systems must provide the Plan Administrator written evidence of participation  
27 and that contributions made to the system(s) have not been withdrawn. Requests for  
28

1 prior service credit should be made at the time of hire or as soon as possible thereafter  
2 but in no event later than one year from the employee's hire date.

3 (l) Tuition Reimbursement and Membership Dues. The County shall establish  
4 an individual, departmental fund in the amount of \$1,000.00 for each fiscal year for each  
5 regular employee in the Exempt Group to reimburse employees for tuition costs incurred  
6 for job-related education or career development or to reimburse membership dues in  
7 professional organization(s), provided each expenditure enhances furtherance of County  
8 or continuing educational goals.

9 Requests for reimbursement must be approved in advance by the appointing  
10 authority and shall not be paid in increments less than \$10.00 per fiscal year. The  
11 individual department fund is in addition to department budgeted and mandated training  
12 and memberships. The County shall also pay, in addition to the individual department  
13 fund, the membership dues to the State Bar of California for all licensed attorneys in the  
14 Exempt Group whose job duties require admission in the State Bar.

15 Employees who successfully complete job-related education or courses may  
16 submit a request to be reimbursed beyond the limit of \$1,000.00 to their department head  
17 or appointing authority for review. The department head or appointing authority must then  
18 request and receive approval from the County Administrative Office to reimburse beyond  
19 the limit of \$1,000.00 per fiscal year per employee. In order to be eligible for tuition  
20 reimbursement under this provision, the employee must take such course work outside  
21 regular work hours and shall do no productive work for the County while attending the  
22 courses.

23 If the reimbursement is approved and paid to the employee, and the employee  
24 leaves the County prior to completing two years of County service after completing the  
25 job-related education or coursework, the employee will reimburse the County according  
26 to the following schedule:

Job-related education/course completion date	Reimbursement
Within 9 months	100%



1	After 9 months, through 18 months	50%
2	After 18 months, through 24 months	25%
3	After 24 months	0%

4 Benefits under the Tuition Reimbursement and Membership Dues Subdivision  
5 shall be pro-rated for job share and part-time employees.

6 (m) Tuition Loan Repayment. The County shall establish a Tuition Loan  
7 Repayment Program to assist the Exempt group with student loan obligations and  
8 encourage continued County employment.

9 (1) Eligibility requirements - all requirements must be met before the  
10 employee is deemed eligible for loan repayment assistance:

11 (A) The employee is employed in a regular full time exempt  
12 classification.

13 (B) The employee fully completes the County's Student Loan  
14 Repayment Application.

15 (C) The employee submits proof of the following:

16 (I) A qualifying degree.

17 (II) Current statements from an unpaid loan.

18 (III) The employee is in paid status in the pay period the  
19 repayment is made.

20 (IV) The employee is not participating in another tuition loan  
21 repayment program. This does not include participation in any loan forgiveness program.

22 (V) Employee's last Work Performance Evaluation rating is  
23 a "meets standards" or above and not on a work performance improvement plan.

24 (VI) Employee is not on a current leave restriction plan.

25 (2) Terms of Loan Repayment Assistance: Employees with 2 or more  
26 years of continuous service with the County may apply for tuition loan repayment.  
27 Continuous service is defined as the total length of service from an employee's most  
28 recent beginning (hire) date in a regular position with no separation from County

1 employment. Employees must complete a new application and submit supporting  
2 documentation for each disbursement for loan repayment. Any additional annual incentive  
3 will require completion of new one-year continuous periods of Qualifying Service on and  
4 after the date of the implementation of this provision. In no event will the payments be  
5 combined. If the application meets County requirements, the payment shall be as follows:

6 (A) After completion of 2 continuous years with the County: A  
7 single payment of up to \$1,000.

8 (B) After completion of 3 continuous years with the County: A  
9 single payment of up to \$1,500.

10 (C) After completion of 4 continuous years with the County: A  
11 single payment of up to \$2,000.

12 (D) After completion of 5 continuous years with the County: A  
13 single payment of up to \$2,500.

14 (E) After completion of 6 continuous years with the County: A  
15 single payment of up to \$3,000.

16 Payment shall not exceed the total amount of \$10,000 per employee.  
17 Eligible employees may receive the payment within thirty days after approval of the  
18 required documentation.

19 (3) Restrictions

20 (A) Employee must have one or more qualifying student loans  
21 (including private loans provided they qualify pursuant to all applicable State and Federal  
22 laws, rules, and regulations).

23 (B) Degree must have been completed and employee must be in  
24 active repayment of the loan.

25 (C) Loans must not be in default status. Employees must provide  
26 a written statement from their lender(s) substantiating that the loan(s) are not in default,  
27 dated within ten business days of the application for payment.

28 (D) Payments made on loans in the year prior to the repayment

1 request that are less than the maximum yearly repayment amount will be eligible for the  
2 lesser amount paid only.

3 (E) Employees who separate from County employment are not  
4 entitled to prorated payments.

5 (F) The lender information must be verified annually, and must  
6 not be older than ten days prior to the application for payment.

7 (G) If loans have been consolidated, proof of consolidation must  
8 be provided.

9 (H) Employees must show proof of loan payments for each of the  
10 prior twelve consecutive months.

11 (4) Program Details

12 (A) Payment will be made directly to the employee through  
13 EMACS. Payment will be subject to all required payroll deductions, and participants will  
14 be responsible for any and all applicable taxes resulting from the payments they receive.

15 (B) Qualifying Student Loan shall mean a loan (or the portion of a  
16 loan, if consolidated) taken and used to cover the cost of an eligible qualifying degree.  
17 The determination of whether or to what extent a loan is a Qualifying Student Loan shall  
18 be made based on guidelines established by the Human Resources Department.

19 (C) Notwithstanding the foregoing, reimbursement under this  
20 Section shall be made subject to any additional conditions approved by the appointing  
21 authority.

22 (n) Conditions of Employment. Unless in the classified service, employees in  
23 this group serve at the pleasure of their appointing authority.

24 Should a classified employee's position be abolished, the County will make  
25 reasonable efforts to place the employee in a comparable County position based upon  
26 the employee's skills, knowledge and abilities, as well as consideration for the employee's  
27 length of service with the County. If reasonable efforts to place an exempt classified  
28 employee in a comparable County position are unsuccessful, the employee shall be

1 subject to lay-off by written notification by the appointing authority or the Chief Executive  
2 Officer, which notification shall be given at least ten working days prior to the effective  
3 date of the layoff. An Exempt Group classified employee does not have any bumping  
4 rights to other County positions.

5 (o) Automobiles.

6 (1) Except for members of the Board of Supervisors, all county  
7 Employees in Benefit Groups A and B, Assistant Sheriffs and Sheriff's Deputy Chiefs,  
8 and the District Attorney Chief Investigator in a paid status are eligible for a Category I  
9 County vehicle under this subdivision with the approval of the Chief Executive Officer.

10 Such employees may use such vehicles for occasional personal use  
11 provided they reimburse the County at the current motor pool variable rate per mile for  
12 such use. All automobile users shall be taxed for such personal use in accordance with  
13 state and federal tax law and regulation.

14 Effective August 10, 2024, all county employees in Benefit Groups A and B  
15 will no longer be eligible for a Category I County vehicle except employees in the following  
16 classifications, Chief Probation Officer, Assistant Chief Probation Officer, Undersheriff,  
17 Assistant Sheriff Sheriff's Deputy Chief and District Attorney Chief Investigator.

18 (2) All County employees in Benefit Groups A and B, Assistant Sheriffs  
19 and Sheriff's Deputy Chiefs, the District Attorney Chief Investigator, and ~~effective January~~  
20 ~~14, 2023,~~ the Assistant Chief Probation Officer in a paid status shall receive a biweekly  
21 automobile allowance in the amount of \$461.54 with no mileage reimbursement, provided  
22 they are not assigned a County vehicle pursuant to Subsection 13.0613(o)(1) above ~~and~~  
23 ~~they provide a private vehicle for their own use on County business.~~ An employee who  
24 becomes eligible or ineligible for this benefit in the middle of a pay period will receive a  
25 prorated sum of automobile allowance. Employees selecting this allowance shall be  
26 required to have a vehicle available at all times for use on County business. This  
27 allowance shall be considered complete reimbursement for the acquisition, insurance,  
28 maintenance, repair, upkeep, fuel, and all other costs for the required vehicle. At no time

1 shall an employee receive both a County vehicle and the automobile allowance.

2 (p) Administrative Leave. Effective pay period 1 of each year, an employee in  
3 a regular position who is in paid status will be provided with 80 hours of administrative  
4 leave time for the employee's use. An eligible employee in a regular position who is part-  
5 time or job-sharing shall be eligible for a prorated number of administrative leave hours  
6 based on regularly scheduled hours. Employees newly entering the Exempt Group after  
7 the beginning of pay period 1 shall receive a prorated number of hours. Such proration  
8 shall be based upon the remaining number of pay periods in the calendar year nearest  
9 the employee's appointment. Employees not in paid status in pay period 1 shall receive,  
10 upon return to paid status, a prorated number of Administrative Leave hours based on  
11 the number of pay periods remaining in the calendar year.

12 Administrative leave may be cashed out at the employee's then current base rate  
13 of pay in increments of one hour, upon the approval of the appointing authority, during  
14 the calendar year. Any Administrative Leave accrual balances in effect at the end of the  
15 last pay period paid in the calendar year will automatically be paid at the employee's then  
16 current base rate of pay. Employees may designate that cash outs of Administrative  
17 Leave be contributed to the County's 401(k) Plan or 457(b) Deferred Compensation Plan.  
18 Upon termination of employment, unused Administrative Leave will be paid at the current  
19 rate of pay.

20 The County-wide elected officials are not eligible to receive administrative leave.

21 (q) Contributions to Salary Savings Plan.

22 (1) Biweekly contributions of Exempt Group employees to the County's  
23 401(k) Defined Contribution Plan will be matched by a County contribution on the basis  
24 of two times the employee's contribution. The biweekly contributions of Exempt Group  
25 employees in Benefit Groups A, B, and C of up to four percent of biweekly base salary  
26 will be matched by a County contribution of two times the employee's contribution, not to  
27 exceed eight percent of an employee's biweekly base salary. The biweekly contributions  
28 of Exempt Group employees in Benefit Group D to the County's 401(k) Defined

1 Contribution Plan of up to three percent of biweekly base salary will be matched by a  
2 County contribution of two times the employee's contribution. The County contribution  
3 shall not exceed six percent of an employee's biweekly base salary.

4 (2) Biweekly contributions of Exempt Group employees in Benefit  
5 Groups A and B to the County's 457(b) Deferred Compensation Plan up to one percent  
6 of biweekly base salary will be matched by a County contribution on the basis of one  
7 times the employee's contribution. The County contribution shall not exceed one percent  
8 of the employee's biweekly base salary. The County contribution shall be deposited in  
9 the County's 401(a) Defined Contribution Plan.

10 (3) Biweekly contributions of Exempt Group employees in Benefit  
11 Groups C and D to the County's 457(b) Deferred Compensation Plan up to one percent  
12 of biweekly base salary will be matched by a County contribution of one-half times the  
13 employee's contribution. The County contribution shall not exceed one-half percent of  
14 the employee's biweekly base salary. The County contribution shall be deposited in the  
15 County's 401(a) Defined Contribution Plan.

16 (r) Employment Interview Expenses and Moving Reimbursement.

17 (1) Interview Expense Reimbursement. For employees in Benefit Group  
18 C and above, the appointing authority may approve reimbursement of interview expenses  
19 incurred by external candidates upon proof/receipts provided. Such reimbursement is  
20 restricted to airfare, auto mileage, meals, overnight stay, and airport transit. Employees  
21 must submit a request for reimbursement for employment interview expenses within 90  
22 days of hire date to be eligible for the reimbursement. Requests submitted for  
23 reimbursement after 90 days from hire date will be denied, unless waived by the  
24 appointing authority.

25 (2) Moving Expense Reimbursement.

26 (A) The Chief Executive Officer may approve moving expenses  
27 up to but not exceeding \$10,000.00 for any employee new to County employment for  
28 whom the Chief Executive Officer or the Board of Supervisors is the appointing authority

1 or any department head. The Chairperson of the Board of Supervisors may approve such  
2 moving expenses for the Chief Executive Officer. Reimbursement of moving expenses  
3 in excess of \$10,000.00 must be approved by the Board of Supervisors.

4 (B) The appointing authority may approve moving expenses up to  
5 but not exceeding \$5,000.00 for employees new to County employment in Benefit Group  
6 B or Benefit Group C, not covered by Subsection 13.0613(r)(2)(A), for moving expenses  
7 authorized, incurred and documented as a result of accepting the position.

8 (C) For employees in Benefit Group D the following provision  
9 applies. To assist with the recruitment and appointment of qualified individuals to hard-  
10 to-recruit positions/classifications, upon request of the appointing authority, the Director  
11 of Human Resources may authorize reimbursement of a new employee's relocation-  
12 related expenses incurred as a result of accepting employment with the County, as  
13 follows:

Miles Relocated	Maximum Reimbursement
250*—1,000 miles	\$1,000.00
1,001—2,000 miles	\$2,000.00
More than 2,000 miles	\$2,500.00

17 \*The 250-mile distance shall only apply if the relocation is from outside San Bernardino  
18 County.

19 (D) Reimbursement may be provided to employees covered in  
20 Subsections 13.0613(r)(2)(B) and 13.0613(r)(2)(C) upon initial employment with the  
21 County, provided that the employee: (1) is appointed to a regular position; (2) submits  
22 original receipts documenting expenses incurred; and (3) agrees to remain employed in  
23 the regular position for at least 12 months. Such employees must submit a request for  
24 reimbursement for moving expenses within 90 days of hire date to be eligible for the  
25 reimbursement. Requests submitted for reimbursement after 90 days from hire date will  
26 be denied, unless waived by the appointing authority.

27 If the employee voluntarily resigns employment prior to completion  
28 of 12 months' service, the employee shall be required to reimburse the County for any

1 payment made under this subdivision.

2 (s) Peace Officer Standards and Training Pay.

3 (1) General. Peace Officer Standards and Training (POST) certificates  
4 are awarded to peace officers who achieve increasingly high levels of education, training,  
5 and experience in his or her pursuit of professional excellence. POST base rate of pay  
6 adjustments will be uniformly maintained for all County employees.

7 (2) Qualification. An Exempt Group law enforcement employee, ~~other~~  
8 ~~than the elected Sheriff,~~ in the Sheriff's Department or District Attorney's Office who  
9 obtains an Advanced Certificate shall have his or her base rate of pay increased in  
10 accordance with the table and procedures set forth below. An Exempt Group law  
11 enforcement employee, ~~other than the elected Sheriff,~~ in the Sheriff's Department or  
12 District Attorney's Office who obtains a Supervisory Certificate, or a higher POST  
13 certificate, or a master's degree earned through attendance at an accredited university or  
14 college, shall have his or her base rate of pay increased in accordance with the table and  
15 procedures set forth below. If an employee obtains a Supervisory Certificate and has his  
16 or her base rate of pay increased as set forth below, and thereafter obtains a higher POST  
17 certificate or a master's degree, the employee will receive no further increase in his or her  
18 base rate of pay.

19 (3) Rates.

20 (A) The rates for POST pay are as follows:

28 (B) Effective January 21, 2017, the County added the flat dollar



1 amounts in the table above to the then existing base rate of pay to establish a higher base  
2 rate of pay for the employees described in this section who obtained an Advanced  
3 Certificate and/or a Supervisory Certificate, or a higher POST certificate, or a master's  
4 degree. Once the new higher base rate of pay was established, the County established  
5 a new POST Pay of two percent. Effective January 16, 2021, the County shall establish  
6 a new POST Pay of three percent. The initial granting of this POST increase to three  
7 percent is subject to the discretion of the Chief Executive Officer based on the availability  
8 of financial resources. Effective January 29, 2022, the County shall establish a new  
9 POST Pay of four percent. Effective January 28, 2023, the County shall establish a new  
10 POST Pay of five percent. Effective January 27, 2024, the County shall establish a new  
11 POST Pay of six percent. Effective January 25, 2025, the County shall establish a new  
12 POST Pay of seven percent.

13 (C) Effective July 18, 2020, the County shall establish a new  
14 POST base pay for employees who obtain a Management POST Certificate. This POST  
15 base pay shall be approximately \$1.79 per hour above POST base pay effective July 18,  
16 2020, for a Supervisory Certificate or a master's degree. The initial establishment of this  
17 new POST base pay for a Management POST certificate is subject to the discretion of  
18 the Chief Executive Officer based on the availability of financial resources.

19 (4) Procedure. The employee shall submit a written request for POST  
20 pay to the department with an attached copy of the appropriate POST certificate or official  
21 transcript from the accredit university or college. This POST pay shall start the first full  
22 pay period following receipt by the County of a valid POST certificate or official transcript.  
23 The County shall submit to POST in an expeditious manner, applications by affected  
24 employees for the certificates described above.

25 (t) Dependent Care Assistance Plan. The purpose of this Section 125  
26 Dependent Care Assistance Plan (DCAP) is to permit eligible employees to make an  
27 election to pay for certain dependent care expenses with salary reduction from  
28 compensation contributed to the plan before federal income or social security taxes are

1 paid to the IRS (“Salary Reduction”) in accordance with Internal Revenue Code sections  
2 125 and 129 and regulations issued pursuant thereto. The DCAP shall be construed to  
3 comply with said code sections and to meet the requirements of any other applicable  
4 provisions of law. The DCAP will be administered by Human Resources in accordance  
5 with the DCAP plan document and applicable law.

6 (1) To be eligible for this benefit, an employee must be in a regular  
7 position.

8 (2) Enrollment in the plan is required every plan year and is limited to  
9 the annual open enrollment period or no later than 60 days following the date of becoming  
10 eligible due to a mid-year change in status event. Failure to submit a participation  
11 agreement within the time frame shall result in an election to not participate in the plan.

12 (3) An employee must elect to contribute to the DCAP through salary  
13 reduction on forms approved by Human Resources. An employee election to participate  
14 shall be irrevocable for the remainder of the plan year. Once a salary reduction has  
15 begun, in no event will changes in elections be permitted during the plan year except to  
16 the extent permitted under IRS rulings and regulations and with the plan document.

17 (4) Pursuant to Internal Revenue Code section 125, any amounts  
18 remaining in the employee’s account at the end of a plan year must be forfeited except  
19 as permitted by the Internal Revenue Code and the plan document.

20 (u) Vacant Higher Position. Employees directed to continuously perform duties  
21 in a vacant higher level regular position for which funds have been appropriated, shall be  
22 entitled to a salary rate increase to the higher level for the time actually worked in excess  
23 of 160 hours, unless specifically waived by the employee; provided, however:

24 (1) The appointing authority certifies to the Director of Human  
25 Resources, in writing at the time of appointment, that the employee meets minimum  
26 qualifications and is assigned and held responsible to fully perform all of the duties  
27 normally associated with the higher level position without limitation as to difficulty or  
28 complexity of assignments or consequence of action and that the employee shall be

1 required to meet standards for satisfactory performance normally required at the higher  
2 level position; and

3 (2) A written request for salary rate increase to the higher level is  
4 directed to the Director of Human Resources for approval; such increase to the higher  
5 level shall be determined as if the assignment had been a promotion.

6 It shall be the responsibility of the appointing authority to initiate such  
7 requests and to provide a copy of such request to the employee. Written requests may  
8 also be made by the employee through the appointing authority in the same manner.  
9 Requests for a salary rate increase should be initiated during the first 30 calendar days  
10 of such assignment. Requests for retroactive payment of a salary increase must be filed  
11 as soon as possible, but not later than one calendar year after assignment of the higher  
12 level duties and must be approved by the Director of Human Resources. Failure to meet  
13 this time limitation shall waive any and all rights to retroactive pay.

14 The duration of such assignments to vacant higher positions are not  
15 intended to exceed one calendar year except in unusual circumstances approved by both  
16 the appointing authority and the Director of Human Resources or designee. Such  
17 assignments in all circumstances are temporary assignments and at the conclusion of  
18 such assignments the respective employee shall be returned to his or her previous  
19 classification. Appointments to regular positions of trainees or underfills are exempt from  
20 the provisions of this section. Further, this section does not apply to a situation in which  
21 there is no vacant higher-level position for which funds have been appropriated. Addition  
22 of duties of a higher-level classification to any employee's regular position shall be  
23 governed by the Special Assignment Compensation section or the Personnel Rules on  
24 Classification, as appropriate. For purposes of this section, a vacant position is defined  
25 as an authorized regular position for which funds have been appropriated and which may  
26 be: (1) An unoccupied position due to attrition and for which the appointment process has  
27 been initiated; (2) A position from which the incumbent is on extended leave of absence;  
28 or (3) A new position authorized by the Board of Supervisors for which the appointment

1 process has been initiated.

2 (v) Personnel Rules. Notwithstanding any other provision in the County Code  
3 or the Personnel Rules, those serving in classified service positions have appeal rights  
4 under the Personnel Rules, except as otherwise provided herein. Any such appeals shall  
5 be heard by a hearing officer selected from the Civil Service Commission Hearing Officer  
6 list and appointed by the Civil Service Commission or, upon mutual agreement of the  
7 appellant and the County, shall be heard by the Civil Service Commission. If the appeal  
8 is heard by a hearing officer, the Civil Service Commission shall either accept or reject  
9 the hearing officer's findings and recommendations within 30 days of receipt by the  
10 Commission.

11 The only grounds for rejection of the hearing officer's decision must be for one of  
12 the following and the rejection must include specific detail in writing:

13 (1) The recommendation was procured by corruption, fraud, or other  
14 undue means;

15 (2) There was corruption on the part of the hearing officer;

16 (3) The rights of a party were substantially prejudiced by the misconduct  
17 of the neutral hearing officer;

18 (4) The hearing officer exceeded his or her powers;

19 (5) The rights of a party were substantially prejudiced by the refusal of  
20 the hearing officer to postpone the hearing upon sufficient cause being shown therefore,  
21 or by the refusal of the hearing officer to properly include or exclude evidence material to  
22 the controversy.

23 Should such be the case, the Commission must state in writing specific  
24 reason(s) for the decision (1, 2, 3, 4, or 5) and subsequently conduct and complete a full  
25 and fair evidentiary hearing on the appeal within 30 days of rejecting the hearing officer's  
26 findings and recommendations unless the hearing cannot for good cause be completed  
27 within 30 days.

28 Those serving in unclassified positions do not have civil service appeal

1 rights as they serve at the pleasure of the appointing authority. Positions in the Exempt  
2 Group shall not have rights to the classification appeal procedures under the Personnel  
3 Rules.

4 (w) Reemployment.

5 (1) A regular employee who has separated County employment, and  
6 who is subsequently rehired in the same classification in a regular position within one  
7 year (i.e., beginning the first day of work by the 365th calendar day), may receive  
8 restoration of salary step, vacation accrual rate, and sick leave balance, unless the  
9 employee has received payment for unused sick leave in accordance with the Retirement  
10 Medical Trust Subdivision, subject to the approval and conditions established by the  
11 appointing authority and the Director of Human Resources. Such employees begin  
12 accruing vacation and sick leave and may utilize the same immediately. Restoration of  
13 retirement contribution rate shall be in accordance with applicable State law and in  
14 compliance with any requirements established by SBCERA. The employee shall be  
15 required to serve a new probationary period, unless waived by the Director of Human  
16 Resources. The employee shall be provided a new date of hire for purposes of County  
17 seniority.

18 (2) A regular employee who has separated County employment and  
19 who is subsequently rehired to a regular position in the same job family within one year,  
20 (i.e., beginning the first day of work by the 365th calendar day), may receive restoration  
21 of vacation accrual rate, sick leave, and retirement contribution rate in the same manner  
22 as described above. Such employees begin immediately accruing vacation and sick  
23 leave and may utilize the same immediately. The employee shall be required to serve a  
24 new probationary period, unless waived by the Director of Human Resources. The  
25 employee shall be provided a new date of hire for purposes of County seniority.

26 (3) A regular employee who has separated County employment, and  
27 who is subsequently rehired to a regular position in another job family within a 90 calendar  
28 day period, must begin the first day of work within 90 calendar days and beginning the

1 first day of work by the ninety-first day, may receive restoration of salary step (in the  
2 instance of rehire in a classification at the same pay range as the position originally held),  
3 vacation accrual rate, sick leave and retirement contribution rate in the same manner as  
4 described above. The employee shall be required to serve a new probationary period,  
5 unless waived by the Director of Human Resources. The employee shall be provided a  
6 new date of hire for purposes of County seniority.

7 (4) Reemployment from Layoff. A regular employee who has been laid  
8 off from County employment and is subsequently rehired to a regular position shall be  
9 reemployed in the same manner as described in the reemployment subdivision.  
10 Restoration of retirement contribution rate shall be in accordance with applicable state  
11 law and in compliance with any requirements established by SBCERA.

12 (5) For purposes of this subdivision, a regular employee shall mean an  
13 employee in a regular position who held regular status in any classification during the  
14 previous period of County employment.

15 (x) Recruitment and Referral Bonus Programs.

16 (1) General. The County shall make available to appointing authorities'  
17 recruitment and referral incentive (bonus) programs to assist in the recruitment and  
18 appointment of qualified individuals into hard-to-recruit regular positions in the Exempt  
19 Group, in accordance with the guidelines established herein.

20 (2) Program Applicability. Appointing authorities may request  
21 authorization to apply the recruitment and/or referral incentive program(s) to assist in  
22 filling regular positions in their departments. To apply, said position/classification must  
23 have had historical/demonstrable recruitment difficulty. The Director of Human  
24 Resources shall have the sole authority to determine the applicability and duration of  
25 these program(s) to each requested position/classification and shall certify applicability of  
26 the program(s) for each position, by assignment, department, and beginning and ending  
27 dates. Such determinations shall not be subject to any review or appeal.

28 (3) Recruitment Bonus. An employee hired into a regular

1 position/classification certified for participation in this program shall be eligible to receive  
2 recruitment bonuses in accordance with the following:

3 (A) Bonus Amount and Method of Payment.

4 (I) The eligible employee hired into a position/  
5 classification that is a department head or for whom the Chief Executive Officer or Board  
6 of Supervisors is the appointing authority shall receive \$2,500.00 upon hire and an  
7 additional \$2,500.00 upon completion of 2,080 service hours in the position/classification  
8 for which the original bonus was granted.

9 (II) The eligible employee hired into a position/  
10 classification in Benefit Group B or Benefit Group C, not covered by Subsection  
11 13.0613(x)(3)(A)(I), shall receive \$1,500.00 upon hire and an additional \$1,500.00 upon  
12 completion of 2,080 service hours in the position/classification for which the original bonus  
13 was granted.

14 (III) The eligible employee hired into a position/  
15 classification in Benefit Group D shall receive no less than \$500.00 and no more than  
16 \$1,000.00 upon hire and an additional \$1,000 upon completion of 2,080 service hours in  
17 the position/classification for which the original bonus was granted.

18 (IV) Each bonus payment shall be considered taxable  
19 income and subject to withholding.

20 (B) Limitations and Exclusions.

21 (I) No bonus will be paid for any candidate whose name  
22 was placed on the eligible list for positions in the classification prior to the beginning date  
23 certified by the Director of Human Resources for that classification to be eligible for  
24 participation in the referral bonus program. Similarly, no bonus will be paid for any  
25 candidate whose name was placed on the eligible list for positions in the classification  
26 after the ending date certified by the Director of Human Resources for that classification  
27 to be eligible for participation in the referral bonus program.

28 (II) The bonus payment shall not be considered in

1 determining regular rate of pay for purposes of computing overtime compensation.

2 (III) The appointing authority shall have sole responsibility  
3 and authority to determine eligibility for the second installment of the recruitment bonus.  
4 Such determination shall not be subject to review or appeal.

5 (4) Referral Bonus. Any employee in a regular position who refers a  
6 qualified candidate for a position/classification certified for participation in this program  
7 who is subsequently hired into the regular position may receive a referral bonus in  
8 accordance with the following:

9 (A) Method of Referral. To be eligible for the recruitment bonus,  
10 the County application for employment must contain the name of the referring employee  
11 on the application.

12 (B) Bonus Amount and Method of Payment. The referring  
13 employee shall receive a bonus of \$250.00 for each referred candidate actually hired into  
14 an eligible regular position. An additional \$500.00 shall be paid upon that new employee's  
15 completion of 2,080 service hours. Said bonus shall be considered taxable income and  
16 subject to withholding.

17 (C) Limitations and Exclusions.

18 (I) No bonus will be paid for any candidate whose name  
19 was placed on the eligible list for positions in the classification prior to the beginning date  
20 certified by the Director of Human Resources for that classification to be eligible for  
21 participation in the referral bonus program. Similarly, no bonus will be paid for any  
22 candidate whose name was placed on the eligible list for positions in the classification  
23 after the ending date certified by the Director of Human Resources for that classification  
24 to be eligible for participation in the referral bonus program.

25 (II) Individuals assigned to employee recruitment as a  
26 primary function of their position shall not be eligible to receive this bonus.

27 (III) In cases where more than one employee is named as  
28 a "referring party," the referral bonus shall be equally split between the referring



1 employees.

2 (IV) In cases where the referred employee resigns,  
3 transfers out of the eligible position, or is terminated prior to completion of 2,080 service  
4 hours, the additional \$500.00 shall not be paid.

5 (V) The referral bonus payment shall not be considered in  
6 determining regular rate of pay for purposes of computing overtime compensation.

7 (VI) The appointing authority shall have sole responsibility  
8 and authority to determine eligibility for the second installment of the referral bonus. Such  
9 determination shall not be subject to review or appeal.

10 (y) County Counsel Legal Service Classification.

11 (1) Application. This section shall apply to all Deputy County Counsel  
12 classifications.

13 (2) Service. The term "service" means service which the appointing  
14 authority finds to be good or superior in work performance and conduct.

15 (3) Hiring. With the approval of the County Counsel, experienced  
16 attorneys may be hired in a classification and at a variable entrance rate commensurate  
17 with demonstrated experience, ability, and the needs of the County. Attorneys without  
18 experience may be hired as a Deputy County Counsel I at the appropriate entrance step  
19 of the applicable salary range.

20 (4) Deputy County Counsel I. After a period of 1,040 hours of service  
21 and a satisfactory rating in a Deputy County Counsel I classification, the Deputy County  
22 Counsel I shall be promoted to a Deputy County Counsel II classification. The Deputy  
23 County Counsel I shall be terminated if it is found that such promotion is not merited.

24 (5) Deputy County Counsel II. After a period of 1,040 hours of service  
25 and a satisfactory rating in the Deputy County Counsel II classification, an attorney shall  
26 be advanced one step increment. After an additional period of 1,040 hours of service and  
27 a satisfactory rating, the Deputy County Counsel II shall be promoted to a Deputy County  
28 Counsel III classification, or the Deputy County Counsel II shall be terminated if it is found

1 that such promotion is not merited. An attorney hired as a Deputy County Counsel II at  
2 some step other than step 1 because of experience, ability, or needs of the County may,  
3 after 1,040 hours of service and a satisfactory rating, be promoted to a Deputy County  
4 Counsel III classification upon the recommendation of the appointing authority.

5 (6) Deputy County Counsel III. After a period of 1,040 hours of service  
6 and a satisfactory rating in the Deputy County Counsel III classification, an attorney shall  
7 be advanced one step increment. After an additional period of 1,040 hours of service and  
8 a satisfactory rating, the Deputy County Counsel III shall be promoted to a Deputy County  
9 Counsel IV classification or the Deputy County Counsel III shall be terminated if it is found  
10 that such promotion is not merited. An attorney hired as a Deputy County Counsel III at  
11 some step other than step 1 because of experience, ability, or needs of the County may,  
12 after 1,040 hours of service and a satisfactory rating, be promoted to a Deputy County  
13 Counsel IV classification upon the recommendation of the appointing authority.

14 (7) Deputy County Counsel IV. After a period of 1,040 hours of service  
15 and a satisfactory rating in the Deputy County Counsel IV classification, an attorney shall  
16 be advanced one step increment. Step advancements shall be in one step increments  
17 after completion of each additional period of 1,040 hours of service and satisfactory  
18 ratings until the top step for the classification is reached.

19 (8) Attorneys shall only attain regular status at the Deputy County  
20 Counsel IV level. An attorney hired as a new employee in the Deputy County Counsel III  
21 or Deputy County Counsel IV classification shall serve a combined probationary and  
22 training period of 2,080 hours of service. Those promoted to Deputy County Counsel IV  
23 from Deputy County Counsel III shall acquire regular status in the higher classification.

24 (9) Deputy County Counsel V. A Deputy County Counsel IV at the top  
25 step of the Deputy County Counsel IV level may be promoted to a Deputy County Counsel  
26 V. Eligibility for promotion to Deputy County Counsel V shall be pursuant to criteria  
27 approved by the appointing authority. Employees promoted to Deputy County Counsel  
28 V shall not obtain regular status as a Deputy County Counsel V as such employee shall

1 serve in a probationary status for the duration of the appointment as a Deputy County  
2 Counsel V and may be removed from a Deputy County Counsel V classification by the  
3 appointing authority at any time without any right to review or appeal. Additionally, there  
4 shall be an annual review by the appointing authority of the performance of each Deputy  
5 County Counsel V, and it shall be discretionary with the appointing authority whether to  
6 continue each employee's Deputy County Counsel V status. An employee who is  
7 removed as a Deputy County Counsel V shall be returned to Deputy County Counsel IV  
8 status.

9 (10) Exceptional Service. An additional two range increase or an  
10 additional four range increase in salary may be paid to attorneys for outstanding ability or  
11 work for a period not to exceed 2,080 hours if such increase is: (1) jointly recommended  
12 by the appointing authority and the Chief Executive Officer or his/her designee. Such  
13 additional compensation may be renewed each year and shall be designated Exceptional  
14 Service Compensation. Employees in the classification of Deputy County Counsel V shall  
15 not be eligible for compensation under this subdivision.

16 (11) Removal from Operation of Section. Upon request of the appointing  
17 authority and the approval of the Civil Service Commission, an attorney may be removed  
18 from the operation of this section.

19 (z) Bilingual Compensation. Upon the approval of the Director of Human  
20 Resources or designee, employees in the Executive Assistant category of the Exempt  
21 Group required by the appointing authority or designee to perform bilingual translation  
22 involving the use of English and a second language (including American Sign Language)  
23 as a condition of employment, shall be eligible for bilingual compensation in the amount  
24 of \$45.00 per pay period. Such compensation shall apply regardless of the total time  
25 required per day for such translation. Such employees must be certified as competent in  
26 translation skills by Human Resources to be eligible for compensation.

27 (aa) (Repealed by Ord. 4270, passed - -2015).

28 (bb) (Repealed by Ord. 4270, passed - -2015).

1 (cc) Portable Communication Device Allowance. All County employees in  
2 Benefit Groups A and B in a paid status, shall receive a biweekly portable communication  
3 device allowance in the amount of \$92.31. An employee who becomes eligible or  
4 ineligible for this benefit in the middle of the pay period will receive a prorated amount.

5 The employee shall purchase a portable communication device capable of sending  
6 and receiving cellular telephone calls, and capable of sending and receiving e-mails to  
7 and from the County e-mail system. The County shall pay for any license and set up  
8 expense for the device if any, and the employee shall pay for the equipment and monthly  
9 voice and data plans.

10 (dd) Probationary Period. Unless a longer probationary period is otherwise  
11 provided, all classified employees in the Exempt Group shall serve a probationary period  
12 of one year or 2,080 hours.

13 (ee) (Repealed by Ord. 4306, passed - -2016).

14 (ff) Perfect Attendance. Employees in regular, full-time positions in Benefit  
15 Groups C and D who do not utilize any sick leave or Paid Time Off (PTO) for sick leave  
16 purposes, any leave (e.g., vacation) in lieu of sick leave, or benefits in lieu of sick leave  
17 (e.g., workers' compensation, short-term disability partial/full integration, etc.), in a payroll  
18 calendar year (i.e., pay period one through pay period 26 or 27, when applicable, of the  
19 same year), and who do not record any sick leave without pay or absent without pay,  
20 medical emergency leave, or military leave as provided by law during that year, shall  
21 accrue 16 hours of perfect attendance leave, for use in the next calendar year. Failure to  
22 utilize perfect attendance leave within the calendar year shall result in forfeiture of the  
23 same. Perfect attendance leave may not be cashed out.

24 (gg) Healthy Lifestyles Program. The healthy lifestyle program is available to  
25 employees in the Exempt Group. Under this program, Exempt Group employees are  
26 eligible for reimbursement for health club/fitness memberships up to \$324.00 on an  
27 annual basis. Exempt Group employees are also eligible for an annual physical  
28 examination through the Arrowhead Regional Medical Center.

1 (hh) Voluntary Time Off. The Voluntary Time Off (VTO) Program is intended to  
2 provide Exempt Group employees a means of taking unpaid (i.e., non-compensated) time  
3 off work, without losing the following benefits: medical premium subsidy, dental premium  
4 subsidy, opt-out/waive amount, vision care, retirement medical trust employer  
5 contribution, and life insurance which depend on the employee being in a paid status.  
6 The following conditions apply:

7 (1) VTO may be taken in the same manner as vacation time except that  
8 VTO must be used in one-hour increments and is limited to 80 hours per calendar year.

9 (2) When VTO is taken, leave accruals continue as if the employee was  
10 on paid time. VTO time counts as time worked toward satisfying the minimum hour  
11 requirement to receive benefits, such as medical premium subsidy, dental premium  
12 subsidy, opt-out/waive amount, County-paid life insurance, and County-paid vision care.

13 (3) VTO does not count as hours worked for purposes of computing  
14 overtime, if applicable. County contribution to the retirement system under the retirement  
15 system contributions subsection will only be paid if the employee is in a paid status in any  
16 pay period in which VTO is used and the employee receives enough earnings to pay his  
17 or her retirement contribution in that pay period.

18 Pursuant to applicable law, Tier 1 retirement system members are eligible  
19 for full service credit for the pay period in which VTO is used and the employer contribution  
20 would be based on the employees' normal compensation earnable.

21 Pursuant to applicable law, Tier 2 retirement system members are eligible  
22 for a reduced service credit amount for the pay period in which VTO was used and the  
23 employer contribution would be based on the employees' actual earnings for that pay  
24 period.

25 (4) VTO may not be used for situations that would otherwise require  
26 leave without pay, such as an employee on short-term disability, or in conjunction with  
27 leave without pay.

28 (5) VTO is an entirely voluntary program. No employee may be required

1 to take VTO.

2 (6) VTO may be taken by request of the employee and upon approval of  
3 the appointing authority.

4 (ii) Retirement Incentive. Eligible employees in identified classifications that  
5 meet the requirements for a service retirement from the San Bernardino County  
6 Employees' Retirement Association (SBCERA) and who retired on or before June 30,  
7 2009, are eligible to receive a retirement incentive in the amount of \$250.00 for each  
8 completed quarter of a year of current continuous service in a regular position with the  
9 County, payable in five annual payments after retirement. Such annual payments shall  
10 be made in July of each year. The Chief Executive Officer may exclude from eligibility  
11 classifications or positions assigned to organizational units that must remain filled.

12 Unless waived by the Chief Executive Officer, vacant positions created by those  
13 employees receiving the retirement incentive shall not be filled for a period of five years.  
14 Alternatively, departments may fill vacated positions if other positions with an equivalent  
15 cost savings remain vacant for a period of five years.

16 Payments to an eligible employee under this program who returns to work for the  
17 County in any capacity after retiring shall be temporarily suspended until the employee  
18 again separates from employment with the County.

19 (jj) (Repealed by Ord. 4306, passed - -2016).

20 (kk) Retention Pay (formerly Longevity Pay). Exempt Group employees, except  
21 those persons who qualify for Probation Retention pay under Subsection 13.0613(oo),  
22 shall be eligible for retention pay above the base rate of pay, as indicated below, based  
23 on total hours of completed continuous service with the County. Retention pay shall be  
24 paid on all paid hours up to an employee's standard hours and shall not be considered  
25 when determining the appropriate rate of pay for a promotion or demotion.

1 For purposes of retention pay only, a year of completed County service is defined  
2 as 2,080 service hours with the County.

3 (II) Certified Public Accountant Stipend. The County shall establish a \$750.00  
4 annual Certified Public Accountant (CPA) Stipend for employees in the following  
5 classifications who attain and maintain a valid CPA license:

- 6 • Administrative Analyst I
- 7 • Administrative Analyst II
- 8 • Administrative Analyst III
- 9 • ARMC Chief Financial Officer
- 10 • Assistant Auditor-Controller/Treasurer/Tax Collector
- 11 • Assistant Executive Officer
- 12 • Auditor-Controller/Treasurer/Tax Collector Division Chief
- 13 • Auditor-Controller/Treasurer/Tax Collector Manager
- 14 • Chief Administrative Analyst
- 15 • Chief Deputy Treasurer
- 16 • County Chief Financial Officer
- 17 • Deputy Executive Officer
- 18 • HS Auditing Chief
- 19 • Principal Administrative Analyst
- 20 • Public Health Chief Financial Officer
- 21 • Public Works Chief Financial Officer
- 22 • Sheriff's Financial Manager

23 The annual CPA stipend shall be paid in a lump sum to eligible employees in  
24 regular positions who are licensed CPAs and are in paid status in the pay period that  
25 includes July 1 of each year. An eligible employee in a regular position who is part-time  
26 or job-sharing shall be eligible for a prorated lump-sum payment based on regularly  
27 scheduled hours. An employee who is licensed as a CPA after July 1, or who is appointed  
28 after July 1, shall receive a prorated CPA stipend payment at the time of licensure or

1 appointment, as applicable. Such proration shall be based upon the remaining number  
2 of pay periods in the fiscal year nearest his or her appointment.

3 Eligible employees who are not in paid status (i.e., not coding paid hours) in the  
4 pay period that includes July 1 shall receive a prorated CPA stipend payment upon return  
5 to paid status. Such proration shall be based upon the remaining number of pay periods  
6 in the fiscal year nearest their return to paid status. However, an employee who is not in  
7 paid status during the entire fiscal year (i.e., not in paid status from pay period 15 of one  
8 year through pay period 14 of the following year) shall not receive the annual CPA stipend  
9 for the fiscal year(s) during which he or she was not in paid status at all. For example, if  
10 an employee is not in paid status from June 2016 through September 2017, and then  
11 returns to paid status in October 2017, the employee shall receive a prorated CPA stipend  
12 payment for FY 2017/2018 upon their return to paid status but shall not receive the FY  
13 2016/2017 stipend because the employee was not in paid status for the entire 2016/2017  
14 fiscal year. Any employee separating from County employment at the conclusion of a  
15 leave of absence shall not receive the CPA stipend.

16 (mm) Auditing Pay Differential. Employees in the classifications designated  
17 below who are required by the appointing authority to directly oversee the auditing  
18 functions shall receive a differential of two percent above the employee's base rate of pay  
19 for all hours actually worked, up to 80 hours per pay period:

- 20 • HS Auditing Chief
- 21 • Auditor-Controller/Treasurer/Tax Collector Manager
- 22 • Auditor-Controller/Treasurer/Tax Collector Division Chief

23 Audits must have resulted in the preparation of reports indicating the audits were  
24 conducted in accordance with the AICPA, IIA, IFAC, GAGAS, SSAE or PCAOB or other  
25 comparable national or international organization or state or federal regulation standards  
26 and/or regulations. Eligibility for this differential is at the discretion of the appointing  
27 authority.

28 (nn) Behavioral Health Medical Director Differential. The Behavioral Health



1 Medical Director shall receive a five percent differential above the employee's base rate  
2 of pay provided such employee is certified as a Diplomate by the American Board of  
3 Psychiatry and Neurology. The differential shall be paid for all hours actually worked up  
4 to 80 hours per pay period.

5 (oo) Probation Retention Pay. The Chief Probation Officer, Assistant Chief  
6 Probation Officer and Deputy Chief Probation Officers who fall within the definition of  
7 "safety member" under Government Code section 31469.4 and have completed 15 or  
8 more years of continuous completed service hours in a regular position shall receive  
9 Probation Retention pay above their base rate of pay, as indicated below, based on the  
10 total hours of continuous completed service in a regular position with the County.  
11 Probation Retention pay shall be paid on all paid hours up to an employee's standard  
12 hours and shall be excluded when determining the appropriate rate of pay for promotion  
13 or demotion. Employees who qualify for Probation Retention pay shall begin to receive  
14 the pay following completion of the required service hours.

18 For purposes of Probation Retention pay, a year of completed continuous service  
19 hours is defined as 2,080 service hours with the County.

20 (pp) Captains who are released from active duty but are required by the Sheriff's  
21 Department or District Attorney to provide notice where they can be reached and to be  
22 able to return to active duty when required by the department shall be assigned to  
23 administrative duty. While on administrative duty, an employee shall be free to use the  
24 time for his or her own purposes.

25 Administrative duty requires that employees so assigned shall: (1) leave a  
26 telephone number where they can be reached or wear a communicating device; and (2)  
27 be able to return to active duty within an hour.

28 Assignment of administrative duty and approval of compensation shall be made by

1 the appointing authority based upon the needs of the department. Administrative duty  
2 shall be compensated at the rate of three hundred ninety dollars (\$390.00) per pay period.  
3 Captains assigned administrative duty shall receive the pay if the employee works a  
4 minimum of twenty-four (24) hours during the pay period that the employee is assigned  
5 to administrative duty. Said compensation is exclusive of any other compensation and  
6 shall not count as hours worked.

7 (qq) The County agrees to provide an annual uniform and clothing allowance in  
8 the sum of nine hundred dollars (\$900.00) to the classifications of Sheriff's Captain,  
9 Sheriff's Deputy Chief, Assistant Sheriff, and Undersheriff in regular positions on payroll  
10 in a paid status as of pay period 24 to compensate for costs associated with uniform and  
11 clothing purchase, maintenance, cleaning and replacement.

12 Employees on a leave of absence without pay in pay period 24 shall receive the  
13 uniform allowance upon return to paid status, provided, however, that an employee who  
14 is not in paid status during the entire year (i.e., not in paid status from pay period 24 of  
15 one year through pay period 23 of the following year) shall not receive the annual Uniform  
16 Allowance for the year(s) during which he/she was not in paid status. For example, if an  
17 employee is not in paid status from October 2018 through January 2020, and then returns  
18 to paid status in February 2020, the employee shall receive the allowance payment for  
19 2019 upon return to paid status but shall not receive the 2018 allowance because the  
20 employee was not in paid status from pay period 24/2018 through pay period 23/2019.  
21 Any employee separating from County employment at the conclusion of a leave of  
22 absence shall not receive the uniform allowance.

23 (rr) Direct Deposit (Electronic Funds Transfer). All employees must make and  
24 maintain arrangements for the direct deposit of paychecks and reimbursements into the  
25 financial institution of their choice via electronic fund transfer. Employees who have not  
26 made such arrangements by the end of the 4th pay period after their date of hire shall be  
27 subject to disciplinary action. In cases where an employee is unable to make  
28 arrangements for electronic fund transfer, the Director of Human Resources may allow

1 an exception to this subsection. Any exceptions granted may be reviewed periodically  
2 for continuation, subject to the approval of the Director of Human Resources.

3 Employees who fail to make arrangements for direct deposit shall receive  
4 paychecks and reimbursements via pay card.

5 (ss) Modified Benefit Option (MBO).

6 (1) General Provisions.

7 (A) All full-time employees in regular Exempt Group positions  
8 shall be provided an opportunity to convert from a regular position with traditional benefits  
9 (i.e., traditional benefit option) to a regular position with modified benefits and a wage  
10 differential.

11 (B) Employees may choose to enroll in the MBO at hire or during  
12 the annual open enrollment period and may choose to change to the traditional benefit  
13 option during subsequent open enrollment periods.

14 (C) Employees who select the Modified Benefit Option must  
15 commit to work a minimum of 1,560 hours per calendar year.

16 (D) In order to receive the benefits and wage differential of the  
17 MBO, the employee must specifically choose the Option.

18 (2) Modified Benefit Option Wage Differential.

19 (A) Employees who select the MBO shall receive a wage  
20 differential of 4% above the base rate of pay. The wage differential shall be paid on all  
21 paid hours (e.g., REG, PTO, etc.).

22 (B) The wage differential shall be considered as part of the base  
23 hourly rate when calculating the following: County contribution to the employee's  
24 Retirement Medical Trust (RMT) account, County match to employee's contribution to  
25 457(b) Deferred Compensation Plan, County match to employee's contribution to  
26 County's 401(k) Defined Contribution Plan, differentials paid on a percentage basis (e.g.,  
27 Retention Pay, POST), sick leave conversion cash-out pursuant to Subsections  
28 13.0613(g)(1)(l) and 13.0613(k)(4), and other leave cash-outs if any. Provided below is

1 an example of how the County's contribution to the RMT would be calculated:

2 Example: Employee with 17 years of continuous County service and  
3 an 80-hour per pay period schedule selects the MBO. The employee's base hourly rate  
4 is \$70 per hour. This employee is eligible for a County contribution to the RMT equal to  
5 3.75% of the employee's base bi-weekly salary. The County contribution to the RMT is  
6 calculated as follows:

7  $80 \text{ hours} \times (\$70.00 \text{ per hour} \times 1.04 \text{ MBO Wage Differential}) = \$5,824$   
8 base bi-weekly salary for purposes of County contribution to the RMT

9  $\$5,824 \times 3.75\% \text{ Contribution Rate} = \$218.40$

10 The County will contribute \$218.40 to the RMT on behalf of the  
11 employee that pay period.

12 (3) Benefits and Leaves. Except as provided in this Subsection,  
13 employees who select the MBO shall receive the same benefits and leaves that  
14 employees who select the traditional benefit option receive.

15 (A) Medical Coverage. Employees who select the MBO shall  
16 have the same medical plan options as employees who select the traditional benefit  
17 option (e.g., Blue Shield HMO, Kaiser HMO, Blue Shield Access + HMO, Kaiser Choice  
18 HMO, and Blue Shield PPO).

19 (B) Medical Premium Subsidy (MPS).

20 (I) Employees who select the MBO shall receive MPS in  
21 the following amounts per pay period:

22 Effective July 15, 2023, the MPS amounts for employees who  
23 select the MBO shall increase to the following amounts per  
24 pay period:

Effective February 10, 2024 through July 11, 2026, the MPS amounts for employees enrolled in the MBO will be based on a percent of the MPS amounts for the Traditional Benefit Option (i.e., 71% Employee Only; 82% Employee + 1; 82% Employee + 2).

(C) Dental Premium Subsidy (DPS). Employees who select the MBO and are enrolled in both County-sponsored medical and dental coverage whose premium costs for medical and dental exceeds the MPS shall be eligible to receive DPS up to \$9.46 per pay period, but not to exceed the combined total of the employee’s out-of-pocket premium expenses.

(4) Paid Time Off (PTO).

(A) Definition. Employees who select the MBO shall be granted Paid Time Off (PTO) in lieu of any other Vacation or Sick accrual leave provisions. However, employees shall continue to be eligible to receive Administrative Leave as provided in Subsection 13.0613(p). Additionally, employees shall receive holiday pay in accordance with Subsection 13.0613(g)(3), except that employees shall not be eligible for the floating holiday.

(B) Accumulation. Employees who select the MBO shall accrue PTO each pay period as provided in the chart below and shall be eligible for prior service credit in accordance with Subsection 13.0613(g)(2)(D). Employees who have standard hours of less than eighty (80) hours per pay period shall accumulate PTO on a pro-rata basis; provided, however, that the maximum combined vacation and PTO accrual that may be carried over to future calendar years shall not be prorated. PTO shall be available for use on the first day following the pay period in which it is earned.

For example, if employee's grandfathered maximum vacation accrual balance is 600 hours, the maximum combined vacation and PTO accrual that may be carried over to a future calendar year shall be 706 hours (600 vacation hours plus 106 PTO hours). As indicated in Subsection 13.0613(g)(2)(B), the grandfathered maximum vacation accrual balance shall be adjusted annually at the end of each calendar year and shall never be increased.

Any PTO accrual balance at the end of the calendar year in excess of employee's maximum PTO accrual that may be carried over to a future calendar year shall be automatically cashed out and paid in accordance with Subsection 13.0613(ss)(4)(E)(II). Additionally, any combined vacation/PTO accrual balance at the end of the calendar year in excess of the employee's allowed maximum combined vacation/PTO balance, in which vacation accruals do not exceed employee's allowed maximum vacation accrual balance, shall be cashed out in PTO hours paid in accordance with Subsection 13.0613(ss)(4)(E)(II). For example, if an employee with a maximum combined accrual balance of 586 has 480 vacation hours (i.e., employee's vacation maximum accrual balance) and 200 PTO hours for a combined accrual balance of 680 hours, 94 PTO hours shall be automatically cashed out in accordance with Subsection

1 13.0613(ss)(4)(E)(II).

2 (C) Administration.

3 (I) PTO for Vacation Leave Purposes. When PTO has  
4 been requested for vacation leave purposes, PTO shall be administered according to  
5 Subsection 13.0613(g)(2)(C).

6 (II) PTO for Sick Leave Purposes. When PTO has been  
7 requested for sick leave purposes, PTO shall be administered according to Subsection  
8 13.0613(g)(1)(D).

9 (D) Separation. Employees separating from County employment  
10 shall have any unused PTO administered in the same manner that Vacation Leave is  
11 administered at separation according to Subsection 13.0613(g)(2)(C)(IV).

12 Exempt employees who are subsequently hired into a position in a  
13 bargaining unit that does not contain the MBO, shall carry over their existing PTO balance  
14 and begin accruing vacation, floating holiday, and sick leave immediately.

15 (E) PTO Cash-Out.

16 (I) Elective Conversion. An employee may sell back PTO  
17 at the base hourly rate of the employee as hereinafter provided, upon approval of the  
18 appointing authority. Eligible employees may exercise these options under procedures  
19 established by the Director of Human Resources. In lieu of cash, the employee may  
20 designate that part or all of the value of PTO be contributed to the County's 401(k) Defined  
21 Contribution Plan or 457(b) Deferred Compensation Plan. In order to sell back PTO prior  
22 to termination or retirement, an employee may exercise the following options:

23 Option 1. Future Accruals. An employee must make an  
24 irrevocable election during the month of December, specifying the number of PTO hours  
25 to be sold back from the next calendar year's PTO accrual. Such election must be made  
26 in increments of not less than ten hours and may not exceed 160 hours. All designated  
27 hours remaining in the last period of the calendar year will automatically be converted into  
28 cash in the last period of the calendar year.

1                   Option 2. Existing Accruals. Existing PTO accruals may be  
2 cashed out in whole hour increments with a minimum cash out of ten hours and will be  
3 subject to a ten percent penalty.

4                   (II) Automatic Conversion. At the end of the last pay  
5 period of the calendar year, an employee shall automatically have any PTO accruals in  
6 excess of the employee's maximum PTO accrual balance converted to cash. Such  
7 automatic PTO cash out shall be paid in pay period 1 of the next calendar year.

8                   (F) Accrual Carryover Following Benefit Change.

9                   (I) Traditional Benefit Option to Modified Benefit Option.

10                   (i) Employees who convert from the traditional  
11 benefit option to the MBO shall carry over and may utilize their existing vacation, holiday,  
12 and sick leave balances; provided, however, that the employee shall no longer accrue  
13 vacation leave, sick leave, and a floating holiday after converting to the MBO. After  
14 converting to the MBO the employee shall be immediately eligible to accrue PTO.

15                   Any vacation leave accrual balance carried over to the  
16 MBO that is in excess of the employee's allowed maximum vacation leave accrual  
17 balance at the end of the calendar year shall be cashed out and paid in accordance with  
18 Subsection 13.0613(g)(2)(E)(II). For example, an employee with a maximum vacation  
19 leave accrual balance of 480 hours begins MBO in pay period 16 and carries over 572  
20 vacation hours. This employee then uses 20 vacation hours and has 552 vacation hours  
21 at the end of the last pay period of the calendar year. In this example, 72 vacation hours  
22 shall automatically cash out in pay period 1 of the next calendar year such that 480  
23 vacation hours carries over to the next calendar year (552 hours – 72 hours = 480 hours).

24                   (ii) Vacation Cash-Out. Employees who met the  
25 eligibility requirements for the vacation cash-out prior to selecting the MBO, and  
26 pre-designated to cash-out vacation leave during the required pre-designation period while  
27 in the traditional benefit option, shall remain eligible to cash-out vacation leave. However,  
28 employees enrolled in the MBO shall not be eligible to pre-designate to cash-out vacation



1 leave while enrolled in the MBO unless employee intends to convert to the traditional  
2 benefit option during next calendar year's open enrollment period and start accruing  
3 vacation that calendar year.

4 Additionally, employees who select the MBO will  
5 continue to have the option to cash-out existing vacation accruals according to  
6 Subsection 13.0613(g)(2)(E).

7 (II) Modified Benefit Option to Traditional Benefit Option.

8 (i) Employees who convert from the MBO to the  
9 traditional benefit option shall carry over and may utilize their existing PTO balance (if  
10 any) and begin accruing vacation, floating holiday, and sick leave immediately; however,  
11 the maximum combined PTO and vacation accrual that may be carried over to a future  
12 calendar year shall not exceed this employee's allowed maximum vacation accrual  
13 balance at the end of the calendar year as established in Subsection 13.0613(g)(2)(B).  
14 Any combined excess leave hours at the end of the calendar year shall be cashed out as  
15 PTO hours and paid in accordance with Subsection 13.0613(ss)(4)(E)(II). For example,  
16 an employee with a maximum vacation accrual balance of 480 hours begins the traditional  
17 benefit option in pay period 16 and carries over 150 PTO hours and 375 Vacation Leave  
18 hours and accrues an additional 68 vacation hours through pay period 26 (i.e., total  
19 combined leave at the end of calendar year equals 593 hours). In this example, 113 PTO  
20 hours shall automatically cash out in pay period 1 of the next calendar year such that 480  
21 total combined vacation/PTO hours carries over to the next calendar year (593 hours –  
22 113 hours = 480 hours). If employee has a grandfathered maximum vacation accrual  
23 balance, the grandfathered vacation accrual balance shall be the maximum combined  
24 vacation and PTO balance that may be carried over.

25 (ii) PTO Cash-Out. Employees who met the  
26 eligibility requirements for the PTO cash-out prior to converting from the MBO to the  
27 traditional benefit option and predesignated to cash-out PTO during the required pre-  
28 designation period while in the MBO, shall remain eligible to cash-out PTO. However,

1 employees enrolled in the traditional benefit option shall not be eligible to pre-designate  
2 to cash-out PTO while enrolled in the traditional benefit option unless employee intends  
3 to convert to the MBO during next calendar year's open enrollment period and start  
4 accruing PTO that calendar year.

5 Additionally, employees who convert from the MBO to  
6 the traditional benefit option will continue to have the option to cash-out existing PTO  
7 according to Subsection 13.0613(ss)(4)(E)(I).

8 ~~(tt) The Director of Human Resources shall have the authority, with the~~  
9 ~~approval of the County's Chief Executive Officer, to provide Exempt Group employees~~  
10 ~~who participated in major COVID-19 initiatives up to the 40 hours of COVID Leave~~  
11 ~~consistent with the COVID leave provided to the represented bargaining units.~~

12 ~~(uu) The Director of Human Resources shall have the authority, with the~~  
13 ~~approval of the County's Chief Executive Officer, to provide Exempt Group employees~~  
14 ~~who provide proof of vaccination up to 32 hours of COVID Vaccine Leave Incentive~~  
15 ~~consistent with the COVID Vaccine Leave Incentive provided to the represented~~

17 ~~(vv) The Director of Human Resources shall have the authority, with the~~  
18 ~~approval of the County's Chief Executive Officer, to provide Exempt Group employees~~  
19 ~~with COVID-19 Premium Pay consistent with COVID-19 Premium Pay provided to the~~  
20 ~~majority of represented bargaining units.~~

21 ~~(wwtt)~~ The Director of Human Resources may, in appropriate circumstances,  
22 provide an employee who is separating from County employment up to six months of the  
23 employee's annual salary and benefits in the form of administrative leave or a lump sum  
24 payment. The Director of Human Resources, in consultation with County Counsel, is  
25 authorized to approve the administrative leave or payment; provided, however, no  
26 administrative leave may be granted or salary paid if allegations of conduct involving  
27 misappropriation of public funds or property, misuse or destruction of public property, acts

9 provides that salary is re-evaluated, and adjusted if necessary, every year.

10 (b) Benefits—County-Wide Elected Officials.

11 (1) Notwithstanding any other provisions of the County Code, County-  
12 wide elected officials shall receive the same benefits provided to Exempt Group  
13 employees in Benefit Group A, or as otherwise specified, in Subsections (f), (j), (k), (l),  
14 (o), ~~(p)~~, (q), ~~(s)~~, (t), (cc), ~~and (gg)~~, ~~(uu)~~, ~~and (vv)~~ of Section 13.0613, and as otherwise  
15 specified by law or the County Code and as modified below.

16 (A) County-wide elected officials are not required to enroll in  
17 County-sponsored medical and dental coverage as described in Subsection  
18 13.0613(f)(1). A County-wide elected official who does not participate in a County-  
19 sponsored medical plan will receive an amount of \$161.54 per pay period.

20 (B) County-wide elected officials shall not receive the benefits  
21 described in Subsection 13.0613(f)(6) related to short term disability.

22 (C) County-wide elected officials shall not receive the benefits  
23 described in Subsection 13.0613(k)(1)(B)(III) related to eligibility for MPS and DPS while  
24 on leave.

25 (D) County-wide elected officials shall not receive the benefits  
26 described in Subsections 13.0613(k)(4)(A) and 13.0613(k)(4)(B) related to sick leave  
27 conversion to Retirement Medical Trust Fund (RMT). County-wide elected officials shall  
28 be eligible to participate in the RMT upon taking office. The County will contribute to the

1 RMT as follows for County-wide elected officials:

16 or more years	3.75%

5 \*For purposes of the RMT contribution, base salary is as defined in the RMT plan document.

6 (E) The County-wide elected officials receive ~~In addition to~~ the  
7 benefits described in Subsection 13.0613(o)(1) related to automobiles with the following  
8 exceptions;

9 (I) The County-wide elected officials who shall be entitled  
10 ~~to~~ have a Category I County vehicle assigned to them for use on County business ~~and~~  
11 ~~they~~ will not be required to reimburse the County for occasional personal use. County-  
12 wide elected officials shall be taxed for any such personal use in accordance with state  
13 and federal tax law and regulation.

14 (II) County-wide elected officials who do not have a  
15 Category I County vehicle assigned to them shall ~~not~~ receive ~~the an~~ automobile allowance  
16 ~~described in Subsection 13.0613(o)(3) and will receive the of~~ \$561.54 per biweekly pay  
17 period.

18 (III) The District Attorney and Sheriff-Coroner is are eligible  
19 to have a Category I County vehicle assigned and for an automobile allowance of \$750  
20 per biweekly pay period.

21 (IV) The District Attorney is eligible for an automobile  
22 allowance of \$750 per biweekly pay period.

23 (F) The County-wide elected officials receive the benefits  
24 described in § 13.0613 (cc) related to the portable communication device allowance with  
25 the exception that they will receive an allowance of \$150.00 per biweekly pay period.

26 (G) In lieu of other benefits provided to Exempt Group employees,  
27 County-wide elected officials shall have five percent of their base salary contributed by  
28

1 the County on their behalf on a biweekly basis to either (1) the County's 457(b) Deferred  
2 Compensation Plan, or (2) the County's 401(a) Defined Contribution Plan.

3 (HH) Tier 1 County-wide elected officials shall have \$442.53  
4 contributed by the County on their behalf on a biweekly basis to either (1) the County's  
5 457(b) Deferred Compensation Plan, or (2) the County's 401(a) Defined Contribution  
6 Plan.

7 (I) Should Article III of the County Charter be modified through  
8 additions or amendments that impacts County-Wide Elected Officials as defined in  
9 Section 13.0613(b), the benefits described in Subsection 13.0613(p) and Subsection  
10 13.0614(b)(1)(e)(3) shall not apply.

11 (c) Employment Status. A County employee in a regular County position  
12 becoming an elected official of San Bernardino County shall be compensated, at the time  
13 of termination from regular employment to the time of assuming office, for unused  
14 vacation, holidays, and sick leave conversion, if eligible. Should such an elected official  
15 return to County employment in a regular position, such employee shall be treated as a  
16 new employee and receive a new benefit date except as hereinafter provided. A person  
17 that has served as an elected official of the County and who returns or has returned to  
18 County employment in a regular position within 90 days after leaving an elected office of  
19 the County, shall be entitled for purposes of vacation accrual rates to count all prior  
20 County employment, including the time as an elected official of the County. The effective  
21 date of any vacation accrual rate adjustment shall not precede the effective date of this  
22 amendment

23 (fd) Salary Adjustments. The County Administrative Office, in concurrence with  
24 County Counsel, shall conduct the compensation and salary surveys required in Section  
25 308 of Article III of the County Charter, and shall report to the Auditor-  
26 Controller/Treasurer/Tax Collector and the Board of Supervisors concerning appropriate  
27 adjustments to be implemented as required by Section 308 of Article III of the County  
28 Charter. The Auditor-Controller/Treasurer/Tax Collector shall implement any required

1 adjustments effective December 1 of the applicable year based on the report of the  
2 County Administrative Office.

3 SECTION 3. Section 13.0660 of the San Bernardino County Code is amended, to  
4 read:

5 **13.0660 Public Service Employees.**

6 The class of Public Service Employee (PSE) is hereby established. Positions in  
7 the PSE class may be assigned to entry level duties in a variety of fields and occupations.  
8 Positions may only be allocated as extra-help or recurrent and, as such, are in the  
9 unclassified service. For layoff purposes, PSE positions are deemed to be the same  
10 classification as those positions performing substantially the same duties.

11 A PSE range is established with a starting step at the state minimum wage per  
12 hour and steps progressing at \$0.25 per hour up to a maximum of \$25.00 per hour.

13 PSEs may be hired at any step within the pay range as determined by the  
14 appointing authority commensurate with their education and/or training and duties to be  
15 performed; provided, however, that the PSE salary is consistent with that of employees  
16 in regular positions of the same or similar type or nature and shall be subject to the review  
17 and approval of the Director of Human Resources or his/her designee. Notwithstanding  
18 any other provision in this code, step advances are at the discretion of the appointing  
19 authority after completion of not less than 1,040 hours worked for each step.

16 to seven and one-half percent of the employee's maximum covered wages for Social  
17 Security purposes. The employee's contributions to PST deferred compensation shall be

19 forms approved by Human Resources. This subdivision shall not apply to any employee
