Rogers to continue to provide support services to the Fourth District as a Deputy Chief of Staff, adding the dental premium subsidy, effective June 17, 2023, for an estimated annual cost of \$139,813 (Salary \$104,013, Benefits \$35,800).

FINANCIAL IMPACT

Approval of these employment contracts will not require the use of additional Discretionary General Funding (Net County Cost). Sufficient appropriation exists within the Fourth District's 2022-23 budget to fund the costs related to these employment contracts and will be included in future recommended budgets.

BACKGROUND INFORMATION

Staff services to members of the Board of Supervisors (Board) are provided through contractual arrangement, as required by the County Charter.

Approval of Recommendation No. 1 would engage Rebecca Boydston to provide support services as a Policy Advisor II for the Fourth District Supervisor, retroactively effective June 3, 2023, and contingent on the successful completion of the background process.

Approval of Recommendation No. 2 will amend Employment Contract No. 22-854 with Peter J. Rogers to continue to provide support services to the Fourth District as a Deputy Chief of Staff, updating benefits to add the dental premium subsidy, effective June 17, 2023. On February 14, 2017 (Item No. 99), the Board approved Employment Contract No. 17-68 with Peter J. Rogers to provide services as a District Director. On September 27, 2022 (Item No. 3), the Board approved Employment Contract No. 22-854 to engage Peter J. Rogers as a Deputy Chief of Staff.

Either party may terminate the contract at any time without cause with a 14-day prior written notice to the other party. The contract may be terminated for just cause immediately by the County. This item is being presented at this time as this is the first date available for presentation following the required operational, fiscal, and legal reviews.
