#### IT IS HEREBY AGREED AS FOLLOWS:

#### **Amendment No.1:**

Employment Contact No. 22-395, for Linda Ward "Contractor", the Public Health Laboratory Director, is hereby amended as follows:

### Section III. TERM is amended to read as follows:

This Contract shall be effective July 1, 2022 and is extended from its expiration date of December 31, 2023, to expire on December 31, 2024, subject to the termination provisions below. The Assistant Executive Officer of the Department Operation or the Director of Public Health is authorized to execute amendments to the Contract to extend the term of this contract for a maximum of a one-year period. Notwithstanding the fore going, either party may terminate this Contract at any time, without cause, with a fourteen (14) day prior written notice to the other party. This Contract may be terminated for just cause immediately by the County. Contractor shall serve at the pleasure of the appointing authority, who shall have the full authority and discretion to exercise County rights under this paragraph.

## Section IV. COMPENSATION OF CONTRACTOR is amended to read as follows:

#### A. SALARY RATE

Contractor shall be compensated for services at a rate of \$67.86 per hour. Contractor does not gain probationary or regular status during the term of this Contract. Payment for services shall be made biweekly during the term specified in Section III of this Contract, in accordance with procedures established by the County Auditor-Controller/Treasurer/Tax Collector, during the term specified in

Section III of this Contract. Contractor does not gain probationary or regular status during the term of this Contract.
