ORDINANCE NO. SD 25-05

An ordinance of San Bernardino County, State of California, acting as the governing body of all Board-Governed County Service Areas and their Zones amending Ordinance No. SD 25-03 to correct the annual service charge for road maintenance for CSA 70, Zone R-12 Baldwin Lake.

WHEREAS, on April 8, 2025 (Item No. 68), the Board of Supervisors adopted Ordinance No. SD 25-03, establishing fees and charges for Fiscal Year 2025-26 for all Board-governed County Service Areas and their Zones;

WHEREAS, Ordinance No. SD 25-03 set an annual service charge for road maintenance for parcels in CSA 70, Zone R-12 Baldwin Lake;

WHEREAS, due to an inadvertent error, Ordinance No. SD 25-03 incorrectly listed the annual service charge for road maintenance for CSA 70, Zone R-12 Baldwin Lake as \$38.23 per parcel instead of the correct intended amount of \$438.23 per parcel; and

WHEREAS, it is necessary to correct Section 3, subsection (a)(10), of Ordinance No. SD 25-03 to reflect the accurate annual service charge;

NOW, THEREFORE, the Board of Supervisors of the County of San Bernardino, State of California, ordains as follows:

SECTION 1. Effective October 23, 2025, Section 3, subsection (a)(10) of Ordinance No. SD 25-03, is amended to read as follows:

- (a) Service Charges for Road Maintenance: These service charges are collected annually on the tax roll at the same time and in the same manner as general ad valorem property taxes:
 - (10) CSA 70, Zone R-12 Baldwin Lake for road maintenance... \$438.23/parcel.
 - SECTION 2. This ordinance shall be effective on October 23, 2025.
