Statement

1. Please refer to the Interim Final Rule on DBE programs released by Caltrans on October 7, 2025 (Attachment #1 – Interim Final Rule on DBE programs) with updated guidance on this projects DBE requirements. This project has no DBE goal requirements for prospective bidders; the County has also removed the provisions requiring submission of DBE related paperwork and reports per these plans and specifications.
2. Effective immediately, the following revisions are made to this solicitation to comply with the U.S. Department of Transportation (DOT) Interim Final Rule issued September 30, 2025, and the October 7, 2025, advisory from the California Department of Transportation (Caltrans), Office of Civil Rights:

No Disadvantaged Business Enterprise Program (DBE) Contract Goal, Counting, or Requirements.

Bidders are advised that per the Disadvantaged Business Enterprise (DBE) Interim Final Rule (IFR) published to 49 CFR 26 on October 3, 2025, no DBE participation goal, target percentage, counting, or minimum DBE requirement is required for this project.
