Adoption/Donation Agreement

(hereinafter referred to as "WDFW") and the San Bernardino County Fire Protection District (hereinafter referred to as "Adopter") for the adoption and donation of four designated Working Dogs. The following sections of the Agreement have been amended, and by which the preceding Parties (WDFW and the Adopter) are bound.

- I. DELETE Recital 1, and REPLACE with a new Recital 1, which shall read as follows:
 - 1. WDFW agrees to provide four K-9 Service Dogs. Microchip ID numbers on file with Adopter and WDFW to the Adopter at no cost with the express agreement that the canines will be utilized as Support K9s on the Adopter's Peer Support Team.

All other terms of the Adoption/Donation Agreement shall remain the same and in full force and effect.
