IT IS HEREBY AGREED AS FOLLOWS:

THIS CONTRACT is entered into in the State of California by and between San Bernardino County, hereinafter called the County, and US Imaging, Inc., hereinafter called Contractor.

Amendment No. 2 to Agreement No. 19-381

It is hereby agreed to amend Contract No. 19-381, effective May 24, 2022, as follows:

1. Amend Section D. Term of Contract to read as follows:

This Contract is effective as of July 1, 2019, and is extended from its expiration date of June 30, 2022, to expire on June 30, 2024, but may be terminated earlier in accordance with the provisions of this Contract.

2. Amend Section E. Fiscal Provisions Paragraph E.1 to read as follows:

The maximum amount of payment under this Contract shall not exceed \$8,920,000, and shall be subject to availability of funds to the County. The consideration to be paid to Contractor, as provided herein, shall be in full payment for all Contractor's services and expenses incurred in the performance hereof, including

travel and per diem. Final payment will be made only after the County has accepted the final product and any other materials required to complete the contract deliverables.

3. Add Section L. to read as follows:

L. Electronic Signatures

This Agreement may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterparts shall together constitute one and the same agreement. The parties shall be entitled to sign and transmit signature of this Contract (whether by facsimile, PDF, or other email transmission), which signature shall be binding on the party whose name is contained therein. Each party providing an electronic signature agrees to promptly execute and deliver to the other party an original signed Agreement upon request.

All other terms and conditions of the contract remain in full force and effect.
