## **AMENDMENT NO. 2**

It Is hereby agreed to amend Contract No. 24-961, effective September 23, 2025 as follows:

#### SECTION 2. , VENDOR SERVICES, FEES, AND RELEVANT DATES

# Amend Section 2., Paragraph D. to read as follows:

D. The term of this agreement shall be extended from the original contract term of October 8, 2024 through October 7, 2025, to a revised contract end date of June 30, 2026. The County acknowledges that it will not unreasonably withhold approval of the Vendor's requests for extensions of time in which to complete the work required. The Vendor shall not be responsible for performance delays caused by others or delays beyond the Vendor's reasonable control (excluding delays caused by non-performance or unjustified delay by Vendor, his/her/its employees, or subcontractors), and such delays shall extend the time for performance of the work by the Vendor.

### **SECTION 3., STANDARD TERMS AND CONDITIONS**

# Amend Section 3., Paragraph X to read as follows:

X. <u>Electronic Signature</u> — This Amendment may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterparts shall together constitute one and the same Contract. The parties shall be entitled to sign and transmit an electronic signature of this Amendment (whether by facsimile, PDF or other email transmission), which signature shall be binding on the party whose name is contained therein. Each party providing an electronic signature agrees to promptly execute and deliver to the other party an original signed Amendment upon request.

All other terms and conditions of Contract No. 24-961 remain in full force and effect.
