IT IS HEREBY AGREED AS FOLLOWS:

Amendment No. 1

IN THAT CERTAIN Contract No. 17-121 by and between San Bernardino County (County), a political subdivision of the State of California, and Garda CL West, Inc. to provide armored car service for County department locations requiring secure transportation and timely deposits of cash and other monetary instruments which contract first became effective March 8, 2017, the following changes are hereby made and agreed to effective September 14, 2021.

Schedule A, section (I) Term is amended to read:

(I) Term
The Agreement shall be in full force and effect from March 8, 2017 until September 25, 2022. Either party may cancel by giving the other party written notice thereof sixty (60) days in advance.

Section IX is added to read:

SECTION IX. ELECTRONIC SIGNATURES

This Agreement may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterparts shall together constitute one and the same Agreement. The parties shall be entitled to sign and transmit an electronic signature of this Agreement (whether by facsimile, PDF or other mail transmission), which signature shall be binding on the party whose name is contained therein. Each party providing an electronic signature agrees to promptly execute and deliver to the other party an original signed Agreement upon request.

All other terms, conditions and covenants remain in full force and effect.
