RESOLUTION OF THE BOARD OF SUPERVISORS OF SAN BERNARDINO COUNTY TO ESTABLISH "NO PARKING" ZONE OF COMMERICIAL VEHICLES HAVING A GROSS WEIGHT RATING EXCEEDING 10,000 POUNDS ON VARIOUS ROADS IN THE ROSENA RANCH COMMUNITY

On Tuesday, December 5, 2023, on motion of Supervisor Hagman, duly seconded by Supervisor Baca, Jr., and carried, the following resolution is adopted by the Board of Supervisors of San Bernardino County, State of California.

WHEREAS, the Department of Public Works completed a traffic engineering investigation on Sycamore Creek Drive and Clearwater Parkway and all adjacent local streets within the Rosena Ranch community; and,

WHEREAS, the map and list of the affected roads is shown on Exhibit A and Exhibit B, respectively; and,

WHEREAS, the Board of Supervisors is authorized to establish parking restrictions on County roads pursuant to County Code 52.0128(a); and,

WHEREAS, the Board of Supervisors desires to establish parking restrictions for commercial vehicles having a gross weight rating exceeding 10,000 pounds on Sycamore Creek Drive and Clearwater Parkway and all adjacent local streets within the Rosena Ranch Community as shown on Exhibit A and listed on Exhibit B.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of San Bernardino County as follows:

- Due to conditions affecting the welfare of the public in Rosena Ranch community utilizing the roads identified on Exhibit A and Exhibit B, the Board of Supervisors, pursuant to an engineering and traffic survey, finds and hereby deems it necessary to:
 - a. Establish a "No Parking" of commercial vehicles having a gross weight rating exceeding 10,000 pounds on Sycamore Creek Drive and Clearwater Parkway and all adjacent local streets in the Rosena Ranch community as shown on Exhibit A and listed on Exhibit B, pursuant to County Code § 52.0128(a).
- 2) The County Road Commissioner is hereby directed to place appropriate signs specifying applicable prohibitions on such streets or entrances to the limited access residential communities thereof and to perform such acts as are necessary to establish the parking restrictions above and implement the terms of this resolution.
