

## **ORDINANCE NO.**

**An ordinance of San Bernardino County, State of California, to amend Tables 82-4, 82-5A, 82-5B, 82-5C, 82-7, 82-9A, 82-9B, 82-9C, 82-11, 82-13A, 82-13B, 82-14A, 82-14B, 82-15A, 82-15B, 82-17, 82-19A, 82-19B, 82-20A, 82-20B, 82-21A and 82-21B of Division 2; to amend Tables 83-5 and 83-15 of Division 3; to amend Chapter 84.01 and to add Chapter 84.36 to Division 4, all of Title 8 of the San Bernardino County Code relating to accessory dwelling units and junior accessory dwelling units regulations.**

The Board of Supervisors of the County of San Bernardino, State of California, ordains as follows:

**SECTION 1.** The Board of Supervisors of San Bernardino County finds that:

19 (b) Properly noticed public hearings have been held before the Planning  
20 Commission and the Board of Supervisors pursuant to the Planning and Zoning Law of  
21 the State of California and the San Bernardino County Development Code.

22 (c) This ordinance is exempt from the California Environmental Quality Act  
23 pursuant to Public Resources Code Section 21080.17.

- (8) A CUP shall be required for this use in the Phelan planning area.
- (9) These uses are regulated and approved by the Public Utilities Commission. See alternate review procedures in § 85.02.050.
- (10) Supportive housing or transitional housing that is provided in single-, two-, or multi-family dwelling units, group residential, parolee-probationer home, residential care facilities, or boarding house uses shall be permitted, conditionally permitted or prohibited in the same manner as the other single-, two- or multi-family dwelling units, group residential, parolee-probationer home, residential care facilities, or boarding house uses under this Code.

23           **Section 84.01.010 Purpose and Severability.**

24           This Chapter establishes the regulations and criteria that determine the location of compatible accessory structures and uses within various land use zoning districts. The purpose of this Chapter is also intended to provide for the creation of accessory dwelling units and junior accessory dwelling units in accordance with applicable state law. If for

1 any reason any provision in this Chapter is declared invalid, then all other provisions shall  
2 remain valid and enforceable.

3 **Section 84.01.020 General Development Standards.**

4 (a) Land Use Zoning District Regulations Applicable. Unless otherwise  
5 provided, accessory structures and uses shall be subject to the same regulations as the  
6 primary structure or use, including projections into setbacks specified in section 83.02.080  
7 (Allowed Projections).

8 (b) Legally Established Primary Use. An accessory structure or use shall  
9 always exist in conjunction with, and never without, a legally established primary structure  
10 or primary use that has the same common owner. Where the primary use is a residence,  
11 it shall not be enclosed within an accessory structure. Where the primary use has not yet  
12 been established, an accessory structure may only be built subject to the issuance of a  
13 Temporary Use Permit in compliance with Chapter 84.25 (Temporary Structures and  
14 Uses).

15 (c) Use of Accessory Structure. The use of an accessory structure may be for  
16 either a primary or an accessory use allowed by the applicable land use zoning district.

17 (d) Determination of Accessory Uses. In addition to the accessory uses  
18 specifically provided for by this Chapter or elsewhere within this Development Code, each  
19 land use shall be deemed to include other accessory uses that are necessarily and  
20 customarily associated with and are clearly incidental and subordinate to the primary land  
21 use. Whenever the accessory uses are questioned, the Director shall be responsible for  
22 determining if a proposed accessory use meets the criteria in this Chapter. Before making  
23 a determination, the Director shall give notice to contiguous property owners in

16 | Section 84.01.030 Agricultural Accessory Structures and Uses.

17 This Section provides standards for accessory structures and uses that are related  
18 to a primary agricultural use.

19 (a) Animal Keeping. Animal keeping activities are governed by Chapter 84.04  
20 (Animal Keeping) of this Code.

21 (b) Row Field Tree and Nursery Crop and Animal Product Sales Stand. The  
22 retail trade of plant or animal products primarily grown on the subject property shall be  
23 allowed when displayed from one stand with a floor area no larger than 200 square feet  
24 on parcels greater than 10,000 square feet in area. Standards for produce stands are  
25 provided in Chapter 84.03 (Agritourism Enterprises) of this Code.

26 (c) Caretaker Housing. The caretaker dwelling unit shall be subject to  
27 accessory dwelling unit development standards in ~~§ 84.01.060(e) Chapter 84.36~~

1       (d)    Seasonal Labor Quarters. Labor quarters for agricultural operations that are

3 product may utilize recreational vehicles as temporary labor quarters. A Site Plan Permit  
4 shall still be required to ensure proper services are supplied to the temporary laborers.  
5 Also, a Special Use Permit shall be required to monitor the use.

6 | Section 84.01.040 Commercial and Industrial Accessory Structures and Uses.

This Section provides standards for accessory structures and uses that are related to primary commercial and industrial uses.

12 (b) Caretaker Housing. The caretaker dwelling unit shall be subject to  
13 accessory dwelling unit development standards in ~~§ 84.01.060(e)~~Chapter 84.36  
14 (Accessory Dwelling Units).

15 (c) Seasonal Labor Quarters. Labor quarters for commercial or industrial  
16 operations that are limited to three months of the year may utilize recreational vehicles as  
17 temporary labor quarters. A Site Plan Permit shall still be required to ensure proper  
18 services are supplied to the temporary laborers. Also, a Special Use Permit shall be  
19 required to monitor the use. Failure to obtain both the Site Plan Permit and the Special  
20 Use Permit required under this subsection shall render the placement, use and/or  
21 occupancy of recreational vehicles or similar vehicles unlawful and subject to  
22 enforcement under Chapter 86.09 of this Code.

23 | Section 84.01.050 Residential Accessory Structures and Uses.

24 This Section provides standards for Accessory Structures and Uses that are  
25 related to residential single-family and multi-family dwelling units (e.g., play yards, pools,  
26 storage sheds, etc.) or that are residential in nature (e.g., guest housing, accessory  
27 dwelling units, etc.).

28 (a) Number of Accessory Residential Units. In addition to a single-family or

1 multi-family dwelling unit, unless indicated otherwise, a combination of two of the following  
2 additional accessory units may be allowed; on parcels less than five acres in size  
3 and a combination of three of the following may be allowed on parcels five acres or  
4 greater in size shall be allowed to have three of the following:

5 (1) Accessory Dwelling Unit. An accessory dwelling unit regulated by  
6 Chapter 84.36 (Accessory Dwelling Units). shall be located on the same parcel as the  
7 primary dwelling unit, may be attached to, or located within, or detached from the primary  
8 dwelling unit, and is no more than 1,200 square feet in size. Only one accessory dwelling  
9 unit shall be allowed per parcel. Additional accessory dwelling units may be allowed on  
10 parcels with multi-family dwelling structures pursuant to § 84.01.060 (g).

11 (2) Junior Accessory Dwelling Unit. A junior accessory dwelling unit  
12 regulated by Chapter 84.36 (Accessory Dwelling Units). shall be located on the same  
13 parcel as the primary dwelling unit, is attached to, or located within, the primary dwelling  
14 or accessory dwelling unit and is no more than 500 square feet in size. A junior accessory  
15 dwelling unit may include separate sanitation facilities, or may share sanitation facilities  
16 with the existing structure. Only one junior accessory dwelling unit shall be allowed per  
17 parcel.

18 (3) Guest House. Guest housing shall be located on the same parcel as  
19 the primary dwelling unit and shall be separated from it by at least 10~~ten~~ feet. Guest  
20 housing shall be for use by temporary guests of the occupants of the primary dwelling  
21 unit and shall not be rented or otherwise used as a separate dwelling; the guest house  
22 may be used as a short-term rental when in compliance with Chapter 84.28 (Short-Term  
23 Residential Rentals). Only one guest house shall be allowed provided the accessory  
24 structure does not exceed the maximum number of accessory units allowed on the parcel.

25 In the Single Residential (RS) or the Multiple Residential (RM) land use zoning districts  
26 on parcels less than 2.5 acres in size, the guest housing unit shall not extend in front of  
27 the primary structure. The provisions of section 84.21.030(i) shall apply to a manufactured  
28 home used as guest housing.

(b) Parking. Except as otherwise provided in this chapter, parking for accessory residential dwelling units guest housing shall comply with Chapter 83.11 (Parking and Loading Standards).

(c) Carport and/or Garage. Detached carports or garages shall be limited to 1,200 square feet when located on parcels that are less than 20,000 square feet in size.

(d) Other Residential Accessory Structures and Uses. See section 83.02.080 (Allowed Projections into Setbacks).

17       (e) Detached Storage Structures. Parcels that are one acre or less in size shall  
18 be limited to only one detached storage structure that exceeds 120 square feet and the  
19 storage structure shall not exceed 1,000 square feet. Except in the Mountain Region,  
20 detached storage structures shall not extend in front of the primary structure where the  
21 primary structure faces a right-of-way.

22 (f) Freight Containers and Similar Storage-Type Structures.

1 Screening such a structure from view from the street or the physical alteration of such a  
2 structure, such as painting or otherwise altering the structure, may be considered in the  
3 approval of the application. Such railroad car, container or similar storage-type structure  
4 shall be placed behind the primary structure and not prominently visible from the street.

5 (2) Freight containers, railroad cars, intermodal containers, and other  
6 similar storage-type structures shall be allowed as accessory structures in the Agriculture  
7 (AG) or Rural Living (RL) land use zoning districts provided that they shall be altered,  
8 either painted or structurally altered, to appear to be similar to, and compatible with, the  
9 appearance of the on-site primary structure and the surrounding neighborhood or to blend  
10 in with the surrounding environment. Such railroad car, container or similar storage-type  
11 structure shall be allowed provided that the container can be placed behind the primary  
12 structure and not prominently visible from the street.

13 (g) Animal Keeping. Accessory animal keeping shall be conducted as specified  
14 in Chapter 84.04 (Animal Keeping).

15 (h) Exterior Storage. Exterior storage shall be fully and solidly screened and  
16 kept below the level of the fence or other screening mechanism. Exterior storage shall  
17 comply with Title 3 (Health and Sanitation and Animal Regulations) of the County Code.  
18 Screening of exterior storage shall comply with section 83.02.060 (Screening and  
19 Buffering).

20 (i) Residential Crop Production. Accessory crop production shall be allowed  
21 on parcels of 10,000 square feet or more, with a temporary sales facility for plant or animal  
22 products grown on the subject property. The sales facility shall not be larger than 200  
23 square feet in area and shall display produce for sale for no longer than 72 hours in any  
24 calendar month. Standards for produce stands are provided in Chapter 84.03 (Agritourism  
25 Enterprises). This does not include wholesale or retail nurseries.

26 (j) Private Office. A private office shall be for the sole use of the dwelling unit  
27 occupants within a primary structure and shall have no external advertising or signs.

28 (k) Compatibility. In the RS (Single Residential) and RM (Multiple Residential)

1 land use zoning districts, the appearance of an accessory structure shall be similar to,  
2 and compatible with, the appearance of the primary structure and the surrounding  
3 neighborhood and setting.

4 (l) Storage of Firewood. The storage of firewood shall comply with Chapter  
5 84.09 (Firewood Storage).

6 **Section 84.01.060 Accessory Dwelling Units and Junior Accessory Dwelling Units.**

7 (a) General Provision. Accessory dwelling units and junior accessory dwelling  
8 units shall comply with all provisions of this Chapter as well as the underlying zoning  
9 district.

10 (b) Location Criteria. Accessory dwelling units and junior accessory dwelling  
11 units shall be permitted where allowed in compliance with Division 2 (Land Use Zoning  
12 Districts and Allowed Land Uses) and on any lot that contains a proposed or an existing  
13 dwelling. Accessory dwelling units and junior accessory dwelling units shall not be  
14 permitted in those areas where a development moratorium has been imposed, including  
15 a moratorium for water or sewer connection, whether imposed by the County or another  
16 public agency.

17 (c) Common Ownership and Rental Terms. Accessory dwelling units and  
18 junior accessory dwelling units are not intended for sale separate from the primary  
19 residence but may be rented separately from the primary residence in all regions of the  
20 County for a term longer than 30 days, or in the Mountain and Desert Regions for a term  
21 less than 30 days provided the short-term rental complies with Chapter 84.28 (Short-Term  
22 Residential Rentals) and is not a unit constructed pursuant to subdivision (g), below.

23 (d) Types of Units.

24 (1) Attached unit. An accessory dwelling unit may either be attached to,  
25 or located within, the proposed or existing primary dwelling or an accessory structure,  
26 including garage, storage area or similar use. A junior accessory dwelling unit shall be  
27 located entirely within a proposed or existing primary dwelling or accessory dwelling unit.  
28 Attached units may have a separate entrance or share a common entrance with the

1 primary dwelling.

2 (2) Detached Unit. An accessory dwelling unit may be detached from the  
3 proposed or existing primary dwelling. The detached accessory dwelling unit shall be  
4 considered the primary unit if it is a larger size than the primary dwelling.

5 (e) Development Standards for Accessory Dwelling Units and Junior Accessory  
6 Dwelling Units. The development standards for an accessory dwelling unit and junior  
7 accessory dwelling unit shall comply with the following additional requirements:

8 (1) Except as otherwise provided in this Chapter, the accessory dwelling  
9 units and junior accessory dwelling units shall comply with all development standards of  
10 the land use zoning designation in which the lot is located.

11 (2) Written confirmation from the sewer district having jurisdiction of the  
12 availability of sewer service for the accessory dwelling unit or written approval from the  
13 Division of Environmental Health Services for use on an existing or new septic system  
14 shall be obtained. Holding tanks shall not be permitted for accessory dwelling units.

15 (3) Written confirmation from the water district having jurisdiction of the  
16 availability of water service for the accessory dwelling unit or written approval from the  
17 Division of Environmental Health Services for use of an existing or new well shall be  
18 obtained.

19 (4) In addition to the requirements of § 84.01.020 (General Development  
20 Standards), the minimum accessory dwelling unit size will be determined by the current  
21 edition of the California Residential Code or as certified by California Department of  
22 Housing and Community Development. In no event shall the minimum square footage  
23 for either an attached or detached accessory dwelling unit prohibit an efficiency unit as  
24 defined in Section 17958.1 of the Health and Safety Code.

25 (5) Approval for setbacks from the applicable Fire Department shall be  
26 required prior to the issuance of a building permit for an accessory dwelling unit.

27 (6) Approval for site drainage, egress, and exit requirements from the  
28 Building and Safety Division shall be required prior to the issuance of a building permit

1 for an accessory dwelling unit.

2 (f) Development Standard Exemptions. An accessory dwelling unit and junior  
3 accessory dwelling unit are exempt from the following development standards:

4 (1) Lot Coverage. Lot coverage requirements shall not preclude the  
5 construction or either an attached or detached accessory dwelling units that is at least  
6 800 square feet in size.

7 (2) Setbacks.

8 (A) No setback shall be required for an existing living area or  
9 accessory structure or a structure constructed in the same location and to the same  
10 dimensions as an existing structure that is converted to an accessory dwelling unit or to  
11 a portion of an accessory dwelling unit or junior accessory dwelling unit.

12 (B) A setback of more than 4 feet or rear and interior side yards  
13 shall be required for an accessory dwelling unit not otherwise constructed in accordance  
14 with subparagraph (A), above.

15 (3) Fire Sprinklers. Accessory dwelling units and junior accessory  
16 dwelling units are not required to provide fire sprinklers if they are not required for the  
17 primary dwelling.

18 (4) Utility Connections. Unless an accessory dwelling unit is constructed  
19 with a new single family dwelling, an applicant is not required to install new or separate  
20 utility connections and shall not be subject to separate utility connection fee or capacity  
21 charge for an accessory dwelling unit described in paragraph (1) of subdivision (g), below.

22 (5) Parking. The parking requirements for accessory dwelling units, as set  
23 forth in Chapter 83.11 (Parking and Loading Standards), shall not apply in any of the  
24 following instances:

25 (A) The unit is considered a junior accessory dwelling unit.

26 (B) The accessory dwelling unit is located within one half mile  
27 walking distance of public transit.

28 (C) The accessory dwelling unit is located within an architecturally

1 and historically significant historic district.

2 (D) The accessory dwelling unit is part of the proposed or existing  
3 primary residence or a converted accessory structure.

4 (E) When on street parking permits are required but not offered  
5 to the occupant of the accessory dwelling unit.

6 (F) When a car share vehicle located within one block of the  
7 accessory dwelling unit.

8 (G) When a garage, carport or covered parking structure is  
9 demolished in conjunction with the construction of an accessory dwelling unit or converted  
10 into an accessory dwelling unit, the off street covered parking does not need to be  
11 replaced.

12 (g) By Right Permitting Exemptions. Notwithstanding anything to the contrary,  
13 an application for a building permit for a use authorized by Division 2 (Land Use Zoning  
14 Districts and Allowed Land Uses) shall be approved to create any of the following:

15 (1) One accessory dwelling unit or junior accessory dwelling unit per lot  
16 with a proposed or existing single family dwelling if all of the following apply:

17 (A) The accessory dwelling unit or junior accessory dwelling unit  
18 is within the proposed space of a single family dwelling or existing space of a single family  
19 dwelling or accessory structure and may include an expansion of not more than 150  
20 square feet beyond the same physical dimensions as the existing accessory. An  
21 expansion beyond the physical dimensions of the existing accessory structure shall be  
22 limited to accommodating ingress and egress.

23 (B) The space has exterior access from the proposed or existing  
24 single family dwelling.

25 (C) The side and rear setbacks are sufficient for fire and safety.

26 (D) The junior accessory dwelling unit, if applicable, complies with  
27 the requirements of Section 65852.22 of the Government Code.

28 (2) One detached, new construction, accessory dwelling unit that does not exceed

27 **Section 84.36.010 Purpose.**

28 The purpose of this Chapter is to implement Chapter 13 (commencing with Section

1 66310) of Division 1 of Title 7 of the Government Code by establishing regulations for the  
2 permitting and development of accessory dwelling units and junior accessory dwelling  
3 units.

4 **Section 84.36.020 Applicability.**

5 The standards of this Chapter shall apply to accessory dwelling units and junior  
6 accessory dwelling units where allowed in compliance with Division 2 (Land Use Zoning  
7 Districts and Allowed Land Uses) of this Development Code.

8 **Section 84.36.030 Definitions.**

9 The definitions of specific terms in this Chapter are intended to supplement the  
10 definitions in Government Code Section 66313. To the extent an inconsistency exists, the  
11 definitions in Government Code Section 66313 shall prevail unless it is determined from  
12 the context of this Chapter that the definition was intended to be more restrictive. For  
13 purposes of this Chapter:

14 (a) “Accessory dwelling unit” means an attached or detached residential  
15 dwelling unit, not considered to exceed the allowable density of the parcel, that provides  
16 complete independent living facilities for one or more persons with permanent provisions  
17 for living, sleeping, eating, cooking, and sanitation on the same parcel that the single-  
18 family or multifamily proposed or existing dwelling is situated. An accessory dwelling unit  
19 can include an efficiency unit, as defined in Section 17958.1 of the Health and Safety  
20 Code, and a manufactured home, as defined in Section 18007 of the Health and Safety  
21 Code.

22 (b) “Existing primary dwelling” means a legally permitted and constructed  
23 primary single-family residence.

24 (c) “Junior accessory dwelling unit” means a unit that is no more than 500  
25 square feet of interior livable space in size and contained entirely within a single-family  
26 residence. A junior accessory dwelling unit may include separate sanitation facilities or  
27 may share sanitation facilities with the proposed or existing structure and shall comply  
28 with the requirements set forth in Section 66333 of the Government Code.

(d) “Livable space” means a space in a dwelling intended for human habitation, including living, sleeping, eating, cooking, or sanitation.

(e) “Primary dwelling” means the single-family dwelling that serves as the primary residence for the lot.

(f) "Proposed primary dwelling" means a structure that is the subject of an active building permit application that meets the requirements for permitting a single-family residence or has received building permit approval but has not yet received an occupancy permit.

## **Section 84.36.040 Types of Units Allowed.**

(a) Accessory Dwelling Units on Single-Family Lots. The following types of accessory dwelling unit are authorized on a lot where allowed in compliance with Division 2 (Land Use Zoning Districts and Allowed Land Uses) of this Development Code.

(1) Attached Unit. An accessory dwelling unit that structurally abuts and is attached to an existing or proposed primary dwelling. An attached unit may be constructed on the side, top, or below the existing or proposed primary dwelling.

(2) Detached Unit. An accessory dwelling unit that is physically separated from the existing or proposed primary dwelling. A detached accessory dwelling unit shall be deemed the primary dwelling if its floor area exceeds that of the existing primary dwelling.

(3) Converted Existing Structure or Space. An accessory dwelling unit that is created from an existing space within an existing or proposed primary dwelling (e.g., basement, attic, attached garage, storage area, or similar area) or an existing space of an accessory structure (e.g., detached garage, shed, storage structure, or other similar existing accessory structure) on the same lot as the primary dwelling. This may include an existing primary dwelling that is converted to an accessory dwelling unit when a larger primary dwelling is established, though the converted dwelling shall still be limited in size to 1,200 square feet.

**(b) Junior Accessory Dwelling Unit on Single-Family Lots.** A junior accessory

1 dwelling unit contained entirely within the walls of an existing or proposed single-family  
2 residence.

3 (c) Multifamily Accessory Dwelling Unit. An accessory dwelling unit that may  
4 be allowed on a lot zoned for multifamily residence and is either attached, detached, or  
5 located within the portions of an existing multifamily dwelling that are not used as livable  
6 space (e.g., storage rooms, boiler rooms, passageways, attics, basements, garages).

7 **Section 84.36.050 Process and Review Procedures.**

8 (a) Ministerial Review. A permit for an accessory dwelling unit or junior  
9 accessory dwelling unit is considered and approved ministerially, without discretionary  
10 review or hearing, notwithstanding the need for a variance or special use permit.

11 (b) Processing Times. Within 15 business days of submission, the Department  
12 will assess whether an application for an accessory dwelling unit or junior accessory  
13 dwelling unit is complete and, if incomplete, provide notice of this determination and a  
14 detailed list of missing items based on the submittal criteria. Upon resubmittal of required  
15 materials, the Department shall have 15 business days to review the resubmittal and  
16 determine whether the application is complete. The Department shall approve or deny  
17 the application for an accessory dwelling unit or junior accessory dwelling unit within 60  
18 days of the date the Department received a complete application if there is an existing  
19 primary dwelling or multifamily dwelling on the lot. If an application to create an accessory  
20 dwelling unit or junior accessory dwelling unit is submitted concurrently with a permit to  
21 create a new primary dwelling or multifamily dwelling on the lot, the 60-day review period  
22 can be delayed until the primary dwelling or multifamily dwelling receives approval or if  
23 the delay is requested in writing by the applicant.

24 (1) Pre-Approved Plans. The Director, in consultation with the Building  
25 Official, shall adopt and maintain a preapproved building plan for a detached accessory  
26 dwelling unit consistent with the current triennial California Building Standards Code  
27 rulemaking cycle. The preapproved plan, along with the contact information of an  
28 applicant that obtained approval of an accessory dwelling unit using a preapproved plan,

1 shall be posted on the Department's website in accordance with Section 65852.27 of the  
2 Government Code.

3 (A) An application for a detached accessory dwelling unit that  
4 utilizes a preapproved plan adopted by the Director within the current triennial California  
5 Building Standards Code rulemaking cycle, or a plan identical to a plan approved by the  
6 Director within the current triennial California Building Standards Code rulemaking cycle,  
7 shall be ministerially approved or denied within 30 days of the date the Department  
8 receives a complete application.

9 (B) An applicant shall pay the same permitting fees that the  
10 County charges an applicant seeking approval for the same-sized accessory dwelling unit  
11 when reviewing and approving the submission of a preapproved accessory dwelling unit  
12 plan.

13 (c) Nonconforming Conditions. The Department shall not require, as a  
14 condition of ministerial approval of a permit application for the creation of an accessory  
15 dwelling unit or junior accessory dwelling unit, the correction of nonconforming conditions.  
16 An application for an accessory dwelling unit or junior accessory dwelling unit submitted  
17 to correct nonconforming zoning conditions, building code violations, or unpermitted  
18 structures that do not present a threat to public health and safety and are not affected by  
19 the construction of the accessory dwelling unit or junior accessory dwelling unit shall not  
20 be denied. Nonconforming zoning condition means a physical improvement on a property  
21 that does not conform to current zoning standards.

22 (d) Unpermitted Junior and Accessory Dwelling Units. The Department shall  
23 not deny a permit for an unpermitted accessory dwelling unit or junior accessory dwelling  
24 unit that was constructed before January 1, 2020, for the reasons set forth in Government  
25 Code Section 66332, subdivision (a). Notwithstanding the above, the Department may  
26 deny a permit for an accessory dwelling unit or junior accessory dwelling unit if the  
27 Building Official makes a finding that correcting the violation is necessary to comply with  
28 the standards specified in Section 17920.3 of the Health and Safety Code or the

1 accessory dwelling unit or junior accessory dwelling unit is attached or within a building  
2 that is deemed substandard pursuant to Section 17920.3 of the Health and Safety Code.

3 (e) Legal Nonconforming Accessory Dwelling Unit. The expansion of a legal  
4 nonconforming structure or use associated with an accessory dwelling unit shall be  
5 subject to the provisions of Division 2 (Land Use Zoning Districts and Allowed Land Uses)  
6 and Section 84.17.080 (Alteration of Nonconforming Uses) of this Development Code.

7 (f) Sewer. Written confirmation from the sewer district having jurisdiction of the  
8 availability of sewer service for the accessory dwelling unit or junior accessory dwelling  
9 unit, or written approval from Environmental Health Services for use on an existing or new  
10 septic system, shall be obtained prior to the issuance of a permit for the creation of an  
11 accessory dwelling unit or junior accessory dwelling unit. Holding tanks shall not be  
12 permitted for an accessory dwelling unit or junior accessory dwelling unit.

13 (g) Water. Written confirmation from the water district having jurisdiction of the  
14 availability of water service for the accessory dwelling unit or junior accessory dwelling  
15 unit, or written approval from Environmental Health Services for use of an existing or new  
16 well, shall be obtained prior to the issuance of a permit for the creation of an accessory  
17 dwelling unit or junior accessory dwelling unit.

18 (h) Fire Safety. Written confirmation from the applicable fire district or fire  
19 authority having jurisdiction shall be required prior to the issuance of a permit for the  
20 creation of an accessory dwelling unit or junior accessory dwelling unit.

21 (i) Grading. Approval of site drainage, ingress, and egress requirements from  
22 the Department shall be required prior to the issuance of a permit for the creation of an  
23 accessory dwelling unit or junior accessory dwelling unit.

24 (j) Garage Demolitions. Review and issuance of a demolition permit for a  
25 detached garage that is to be replaced with an accessory dwelling unit shall be reviewed  
26 and issued at the same time with the application for the creation of an accessory dwelling  
27 unit.

28 (k) Flood Protection. An accessory dwelling unit or junior accessory dwelling

1 unit located within a floodplain safety overlay shall comply with Chapter 82.14 (Floodplain  
2 Safety Overlay), including but not limited to elevating the lowest finished floor to the  
3 required elevation.

4 **Section 84.36.060 Rental Terms, Occupancy, and Common Ownership.**

5 (a) Rental Terms. An accessory dwelling unit and junior accessory dwelling unit  
6 may be rented separately from the primary dwelling or multifamily dwelling in all regions  
7 of the County, subject to the following criteria:

8 (1) Long-Term Rentals. In all regions of the County, an accessory  
9 dwelling unit may be rented for a term longer than 30 consecutive days. The rental of a  
10 junior accessory dwelling unit shall be for a term longer than 30 consecutive days in all  
11 regions of the County.

12 (2) Short-Term Rentals. In the Mountain and Desert Regions of the  
13 County, an accessory dwelling unit may be rented for a term less than 30 consecutive  
14 days, provided the short-term rental unit complies with Chapter 84.28 (Short-Term  
15 Residential Rentals) and is not a unit constructed pursuant to section 84.36.080(b).

16 (b) Occupancy. Owner occupancy shall not be required for an accessory  
17 dwelling unit. A junior accessory dwelling unit shall require owner-occupancy in the  
18 existing or proposed single-family residence in which the junior accessory dwelling unit  
19 will be permitted. The owner may reside in either the remaining portion of the single-family  
20 residence or the newly created junior accessory dwelling unit. Owner-occupancy shall not  
21 be required if the junior accessory dwelling unit has separate sanitation facilities, or if the  
22 owner is another governmental agency, land trust, or housing organization. The  
23 recording of a deed restriction, which shall run with the land, shall be filed with the  
24 County Recorder's Office for an application associated with a junior accessory dwelling  
25 unit and shall include both of the following:

26 (1) A prohibition on the sale of the junior accessory dwelling unit  
27 separate from the sale of the existing or proposed primary dwelling, including a statement  
28 that the deed restriction may be enforced against future purchasers.

(2) A restriction on the size and attributes of the junior accessory dwelling unit that conforms with this Chapter.

(c) Separate Conveyance. The separate sale or conveyance of an accessory dwelling unit of any type is prohibited except when authorized in accordance with Section 66431 of the Government Code.

## **Section 84.36.070 Development Standards.**

(a) Except as otherwise provided in this Chapter, the development standards for an accessory dwelling unit and junior accessory dwelling unit shall comply with the requirements set forth in Table 84-0 (ADU Building Form) and the restrictions provided herein.

(1) Land Use Zoning District Regulations. An accessory dwelling unit or junior accessory dwelling unit shall comply with all development standards of the land use zoning district in which it is located.

(2) Multifamily Structure Modification. A modification of the footprint of an existing multifamily dwelling that has less than four-foot side and rear setbacks shall not be required for the construction of an accessory dwelling unit.

(3) Location. An accessory dwelling unit may be located in front of the primary dwelling when constructed in compliance with applicable setback standards.

21 **Section 84.36.080 Development Standards Exemptions.**

22 (a) Development Standards Exemptions. An accessory dwelling unit and a  
 junior accessory dwelling unit are exempt from the following standards:

23 (1) Fire Sprinklers. Fire sprinklers shall not be required for an accessory  
 dwelling unit and junior accessory dwelling unit if they are not required for the primary  
 dwelling.

24 (2) Utility Connections. Unless an accessory dwelling unit or junior  
 accessory dwelling unit is constructed with a new primary dwelling, new or separate utility

1 connections shall not be required and shall not be subject to a separate utility connection  
2 fee or capacity charge if constructed from existing space of the primary dwelling or  
3 accessory structure. This shall not apply to lots served by a septic system and an  
4 individual domestic well.

5 (3) Parking. The parking requirements for an accessory dwelling unit, as  
6 set forth in Table 84-0 (ADU Building Form), shall not apply in any of the following  
7 instances:

8 (A) The unit is considered a junior accessory dwelling unit.

9 (B) The accessory dwelling unit is located within one-half mile  
10 walking distance of public transit.

11 (C) The accessory dwelling unit is located within an architecturally  
12 and historically significant historic district that is listed in the National Register of Historic  
13 Places, State Register of Historic Places, or is listed on the official county registry of such  
14 places.

15 (D) The accessory dwelling unit is part of the proposed or existing  
16 primary dwelling or a converted accessory structure.

17 (E) When on-street parking permits are required but not offered  
18 to the occupant of the accessory dwelling unit.

19 (F) When a car share vehicle is located within one block of the  
20 accessory dwelling unit.

21 (G) When a garage, carport, or covered parking structure is  
22 demolished in conjunction with the construction of an accessory dwelling unit or converted  
23 into an accessory dwelling unit, the off-street covered parking does not need to be  
24 replaced.

25 (H) When a permit application for an accessory dwelling unit is  
26 submitted with a permit application to create a new primary dwelling or a new multifamily  
27 dwelling on the same lot, provided that the accessory dwelling unit or parcel satisfies any  
28 of the criteria listed in this subdivision.

(b) *By-Right Permitting Exemptions.* Notwithstanding anything to the contrary, an application for a building permit for an accessory dwelling unit or junior accessory dwelling unit authorized by Division 2 (Land Use Zoning Districts and Allowed Land Uses) shall be approved to create any of the following:

(1) One accessory dwelling unit and one junior accessory dwelling unit per lot with a proposed or existing primary dwelling if all of the following apply:

(A) The accessory dwelling unit or junior accessory dwelling unit is within the proposed space of a primary dwelling or existing space of a primary dwelling or accessory structure. This may include an expansion of not more than 150 square feet beyond the same physical dimensions as the existing accessory structure. An expansion beyond the physical dimensions of the existing accessory structure shall be limited to accommodating ingress and egress.

(B) The space has exterior access from the proposed or existing primary dwelling.

(C) The side and rear setbacks are sufficient for fire and safety.

(D) The junior accessory dwelling unit complies with the requirements of Article 3 (commencing with Section 66333), Chapter 13, Division 1, Title 7 of the Government Code.

(2) One detached, new construction, accessory dwelling unit that does not exceed four-foot rear and interior side setbacks for a lot with a proposed or existing primary dwelling, provided the total floor area is not more than 800 square feet of livable space and a height limitation as provided in subparagraph (A), (B), or (C) of paragraph (4) of subdivision (b) of Section 66321 of the Government Code, as applicable of 16 feet. An accessory dwelling unit permitted pursuant to this subdivision may be combined with a junior accessory dwelling unit.

(3) Multiple accessory dwelling units within the portions of existing multifamily dwelling structures that are not used as livable space, including, but not limited to, storage rooms, boiler rooms, passageways, attics, basements, or garages, if each unit

1 complies with state building standards for dwellings:

2                   (A) At least one accessory dwelling unit shall be allowed.

3                   (B) The maximum number of units shall not exceed 25 percent of  
4 the existing dwelling units.

5                   (4) Multiple accessory dwelling units on a lot with a proposed or existing  
6 multifamily dwelling, but are detached from that multifamily dwelling and are subject to a  
7 height limitation in subparagraph (A), (B), or (C) of paragraph (4) of subdivision (b) of  
8 Section 66321 of the Government Code, as applicable, and rear yard and side setbacks  
9 of no more than four feet:

10                  (A) On a lot with an existing multifamily dwelling, not more than eight  
11 detached accessory dwelling units. However, the number of accessory dwelling units  
12 shall not exceed the number of existing units on the lot.

13                  (B) On a lot with a proposed multifamily dwelling, not more than two  
14 detached accessory dwelling units.

15 **Section 84.36.090 Severability.**

16                  The Director, in consultation with County Counsel, shall have the authority to waive  
17 any provision of this Chapter to the extent the Director determines that any section,  
18 sentence, clause, phrase, or portion thereof is inconsistent with Chapter 13 (commencing  
19 with Section 66310) of Division 1 of Title 7 of the Government Code, as may be amended  
20 from time to time, as applied to an application for an accessory dwelling unit or junior  
21 accessory dwelling unit. If, for any reason, any portion of this Chapter is determined by  
22 the Director to be inconsistent with Chapter 13 (commencing with Section 66310) of  
23 Division 1 of Title 7 of the Government Code, then the applicable State law shall provide  
24 the controlling development standard and all other provisions of this Chapter shall remain  
25 valid and enforceable.

26  
27                  SECTION 14. This ordinance shall take effect 30 days from the date of adoption.
