Replace Article 1. The Project, Subsection 1.2 Total Contract amount with the following:

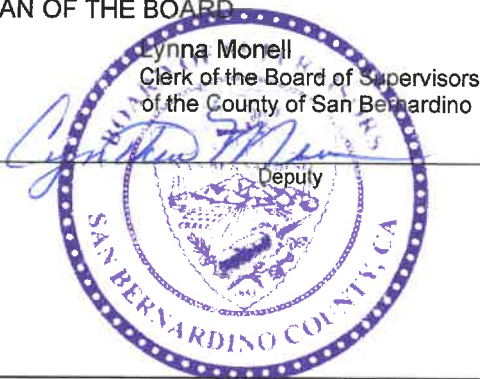

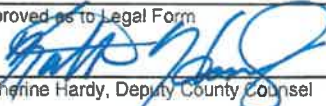
