IT IS HEREBY AGREED AS FOLLOWS:

AMENDMENT No. 5

Contract No 18-640 to provide law enforcement service in the form of a Deputy Sheriff, acting as a School Resource Officer to the Redlands Unified School District is hereby amended, effective July 1, 2022 as follows: (1) by replacing the first sentence of Section V. TERM AND TERMINATION, with the sentence below to change the contract end date from June 30, 2022 to June 30, 2023; (2) by replacing Section VII.A, with the new Section VII. A. ELECTRONIC SIGNATURES, below to allow for the continued use of digital signatures for this Contract and subsequent amendments; and (3) to replace the Schedule A referred to in Sections I.A and II.A with the Schedule A attached hereto and incorporated herein by reference.

V. TERM AND TERMINATION

The term of this contract shall be for a period of time commencing September 1, 2018 through June 30, 2023.

VII. FULL UNDERSTANDING

A. ELECTRONIC SIGNATURES

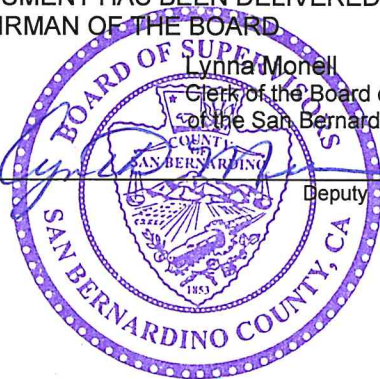
