### AMENDMENT NO. 2:

It is hereby agreed to amend Contract No. 22-198, effective May 7, 2024, as follows:

### SECTION VII. TERM

**Amend Section VII. Term to read as follows:**

This Contract is effective as of March 15, 2022 and is extended from the original expiration date of May 31, 2023, to expire May 31, 2026, but may be terminated earlier in accordance with the provisions of this Contract.


All other terms and conditions of Contract 22-196 remain in full force and effect.
