

**RESOLUTION NO. 2024-76**

**RESOLUTION OF THE BOARD OF SUPERVISORS  
OF SAN BERNARDINO COUNTY OF  
ADOPTION OF THE COUNTY MAINTAINED ROAD SYSTEM**

On Tuesday May 21, 2024, on motion of Supervisor Hagman, duly seconded by Supervisor Baca, Jr., and carried, the following resolution is adopted by the Board of Supervisors of San Bernardino County, State of California.

WHEREAS, pursuant to the California Streets and Highways Code the Board of Supervisors, through the County's Department of Public Works, has established a County Maintained Road System (CMRS) which also serves as the Record of County Highways; and

WHEREAS, the road system was established in 1949; and

WHEREAS, since 1949 the County has been adding new roads to the CMRS as necessary for the public convenience; and

WHEREAS, in 1955, Streets and Highways Code section 941 was amended to require appropriate action by the Board of Supervisors, or its designee, to include a road in the CMRS; and

WHEREAS, since that time the Board of Supervisors has established a practice whereby roads are included in the CMRS by resolution duly adopted at a regular meeting of the Board of Supervisors; and

WHEREAS, pursuant to Streets and Highways Code section 908, the County has maintained a Record of County Highways since 1935; and

WHEREAS, on August 30, 2005, the Board of Supervisors adopted Resolution No. 2005-289, which resolved that all of the roads identified in the Record of County Highways were in the CMRS, whether or not formal action of the Board was taken to include them in the past; and,

WHEREAS, the Board of Supervisors desires to ensure, as well as document, on an annual basis that all roads included in the Record of County Highways are included in the CMRS.

NOW THEREFORE, the Board resolves as follows:

- (1) That all of the roads included in the Record of County Highways as of April 30, 2024, (on file with the Clerk of the Board) are hereby deemed necessary to the public convenience and are included in the CMRS pursuant to section 941 of the Streets and Highways Code; and
- (2) That this Resolution is not intended to affect the date upon which these roads were included in the Record of County Highways and the CMRS.
