Any increase in the rates will be in the form of an amendment to this contract, signed by both parties. Rates for sworn personnel providing direct services to LIVE NATION includes 41.96% overhead rate which recovers the County's indirect costs, including the cost of sworn staff above the rank of Sergeant and all professional staff.
