IT IS HEREBY AGREED AS FOLLOWS:

AMENDMENT NO. 1

Employment Contract No. 23-938 with Luther Snoke (Contractor) to provide services in the position of Chief Executive Officer is hereby amended, effective June 25, 2024, as follows:

III. TERM AND TERMINATION

- A. The Term of this Contract shall commence on August 26, 2023 and shall continue in effect through December 22, 2028, unless terminated earlier as hereinafter provided. The Board of Supervisors may extend the term of this Contract. The Board of Supervisors shall provide Contractor with a minimum of six (6) months written notice prior to the end of the contract term, informing the Contractor that the County will not extend the Contract. If such notice is not provided, this Contract will be extended by an additional twelve (12) months from the end of the Contract termination date at that time.

IV. COMPENSATION OF CONTRACTOR

Contractor shall be considered a Contract employee in the County's Unclassified Service. Contractor shall receive only the benefits and compensation specifically set forth in this Contract. This Contract

provides for the full compensation to Contractor for the services required hereunder. This Contract supersedes any prior employment contract between County and Contractor, including Contract No. 22-1183.

M. SALARY SAVINGS PLAN

In lieu of a match to the County's 401(k) Deferred Compensation Plan, Contractor shall have an amount at the maximum allowable by IRS Contribution limits contributed on Contractor's behalf to the Contractor's County 401(k) plan on a bi-weekly basis. In lieu of a match to the County's 457(b) Deferred Compensation Plan, Contractor shall have an amount at the maximum allowable by IRS contribution limits contributed on Contractor's behalf to the Contractor's County 457(b) plan on a bi-weekly basis.

V. GENERAL PROVISIONS RELATING TO CONTRACTOR

A. TOUR OF DUTY

1. The parties agree that submission of hours worked shall be 80 regular hours per pay period for payroll purposes on the County's Employee Management and Compensation System during the full term of this Contract.
2. In the performance of his duties under this Contract, Contractor shall be required to work such hours as necessary to carry out the duties specified in this Contract under the direction of the Board of Supervisors and the Chair of the Board of Supervisors, and such hours may be varied so long as the work requirements and efficient operation of the County are assured.

Except as amended above, all other terms and conditions of the Contract remain as stated therein.
