WESTERN JOSHUA TREE HAZARD MANAGEMENT PERMIT APPLICATION

Western Joshua Tree Hazard Management Permit

Information

Western Joshua tree hazard management permits are issued to property owners for the purpose of removing or trimming dead western Joshua tree(s) or trimming living western Joshua tree(s) provided that the dead western Joshua tree(s) or any limb(s) to be removed meet one of the following conditions:

- A) Has fallen over and is within 30 feet of a structure;
- B) Is leaning against an existing structure; or
- C) Creates an imminent threat to public health and safety.

A western Joshua tree is considered “dead” if it meets at least one of the following criteria¹:

- 1) Has not burned and has no green leaves, no new growth on the main stem, and no basal sprouts;
- 2) Has partially or fully burned at least 18 months prior, has no green leaves, no new growth on the main stem and no basal sprouts; or
- 3) Has fallen and is completely detached from its roots or has fallen and its roots are no longer in contact with the soil.






