

RESOLUTION NO. 2023-114

RESOLUTION OF THE BOARD OF SUPERVISORS OF SAN BERNARDINO COUNTY, STATE OF CALIFORNIA, ACTING IN ITS CAPACITY AS THE GOVERNING BOARD OF COUNTY SERVICE AREA 70, ZONE R-52 (GREEN VALLEY LAKE), FIXING THE SPECIAL TAX RATE FOR FISCAL YEAR 2023-24

On Tuesday, June 13, 2023, on motion of Supervisor Baca, Jr., duly seconded by Supervisor Hagman and carried, the following resolution is adopted by the Board of Supervisors of San Bernardino County, State of California.

SECTION 1. The Board of Supervisors of San Bernardino County, acting in its capacity as the governing board of County Service Area 70, Zone R-52, therefore, hereby finds and determines:

(a) That on August 7, 2007, the electors of County Service Area 79, Zone R-1, duly authorized a special tax levy for financing road maintenance services.

(b) That on July 12, 2022, the Board of County Service Area 79, Zone R-1 is dissolved and County Service Area 70, Zone R-52 is formed.

(c) That the amount of such tax shall be \$352 per parcel, with an annual 2.5% inflationary factor increase each year thereafter.

SECTION 2. The Board of Supervisors of San Bernardino County, acting in its capacity as the governing board of County Service Area 70, Zone R-52, therefore, hereby resolves and orders:

(a) That in order to meet the proposed appropriations, the special tax for Fiscal Year 2023-24 shall be set at \$522.57 per parcel.

(b) That following the adoption of this resolution, the Clerk of the Board shall cause a copy of same to be published once in a newspaper of general circulation within the district.

(c) That this resolution shall be effective on July 1, 2023.
