### AMENDMENT NO. 2

2. All references to "County of San Bernardino" in the Agreement shall be amended to read as "San Bernardino County".
3. All other terms and conditions of the Agreement shall remain in full force and effect.
4. This Amendment No. 2 may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterparts shall together constitute one and the same Amendment. The parties shall be entitled to sign and transmit an electronic signature of this Amendment (whether by facsimile, PDF or other email transmission), which signature shall be binding

on the party whose name is contained therein. Each party providing an electronic signature agrees to promptly execute and deliver to the other party an original signed Amendment upon request.


