**RESOLUTION OF THE BOARD OF SUPERVISORS
OF SAN BERNARDINO COUNTY TO
ACCEPT CATABA ROAD, EL CENTRO ROAD, AND COYOTE TRAIL
IN THE OAKS HILLS AREA
INTO THE COUNTY MAINTAINED ROAD SYSTEM**

On Tuesday March 28, 2023, on motion of Supervisor Baca, Jr., duly seconded by Supervisor Hagman and carried, the following resolution is adopted by the Board of Supervisors of San Bernardino County, State of California.

WHEREAS, section 941 of the Streets and Highways Code provides that no public or private road shall become a County highway until and unless accepted by appropriate action of the Board of Supervisors, or the Board's designee; and

WHEREAS, Cataba Road from El Centro Road to Ranchero Road, El Centro Road from Cataba Road to Coyote Trail, and Coyote Trail from El Centro Road to Ranchero Road in the Oak Hills area has been evaluated by Department of Public Works, Operations Division and has been constructed, inspected and approved to County standards; and

WHEREAS, right-of-way for Cataba Road from El Centro Road to Ranchero Road, El Centro Road from Cataba Road to Coyote Trail, and Coyote Trail from El Centro Road to Ranchero Road in the Oak Hills area has been dedicated to San Bernardino County; and

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of San Bernardino County that the accepted limits in the Oak Hills area (listed below) are necessary to the public convenience and, therefore, are accepted into the County Maintained Road System.
