IT IS HEREBY AGREED AS FOLLOWS:

Amendment No. 1 to Contract No. 23-509

Effective January 25, 2025, San Bernardino County (County) and Rebecca Boydston (CONTRACTOR) agree that Contract No. 23-509 is hereby amended as follows:

REPLACE SECTION IV. COMPENSATION OF CONTRACTOR, Paragraph F. AUTO ALLOWANCE, with the following:

F. AUTO ALLOWANCE

CONTRACTOR shall receive a bi-weekly auto allowance of \$100 without mileage reimbursement for mileage on County business in a privately owned automobile. With written approval of the Fourth District Supervisor, the CONTRACTOR shall be subject to adjustments to the bi-weekly automobile allowance (increases or decreases), but any adjustment shall be on a prospective basis only and any increase shall not exceed the maximum amount allowable for the Exempt Group B level benefit, pursuant to the terms and conditions set forth in the San Bernardino County Exempt Group Working Conditions Ordinance.

This Amendment No. 1 may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterparts shall together constitute one and the same Amendment No. 1. The parties shall be entitled to sign and transmit an electronic signature of this Amendment No. 1 (whether by facsimile, PDF or other email transmission), which signature shall be binding on the party whose name is

contained therein. Each party providing an electronic signature agrees to promptly execute and deliver to the other party an original signed Amendment No. 1 upon request.

All other terms and conditions of this Contract No. 23-509 remain unchanged and are incorporated herein by this reference.
