

RESOLUTION NO. 2024-18

**RESOLUTION OF THE BOARD OF SUPERVISORS
OF SAN BERNARDINO COUNTY
TO ESTABLISH PARKING RESTRICTIONS ON PHILLIPS BOULEVARD, CHINO AREA**

On Tuesday February 6, 2024, on motion of Supervisor Baca, Jr, duly seconded by Supervisor Hagman and carried, the following resolution is adopted by the Board of Supervisors of San Bernardino County, State of California.

WHEREAS, the Department of Public Works completed a traffic engineering investigation of Phillips Boulevard (652300) in the Chino area; and,

WHEREAS, the Board of Supervisors is authorized to establish parking restrictions on County roads; and,

WHEREAS, the Board of Supervisors desires to establish a parking restriction on Phillips Boulevard along the north side of Phillips Boulevard from Roswell Avenue easterly for a distance of 735 feet, and along the south side of Phillips Boulevard from Roswell Avenue easterly for a distance of 1,150 feet, in the Chino area.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of San Bernardino County as follows:

1. Due to conditions affecting the safety of the public utilizing Phillips Boulevard (652300) in the Chino area, the Board of Supervisors, pursuant to a traffic engineering investigation deems it necessary and hereby resolves to:
 - (a) Establish a "No Parking of Vehicles/Tow-Away Zone," pursuant to County Code Section 52.0132(a), along the north sides of Phillips Boulevard from Roswell Avenue easterly to 280 feet west of Cannery Row, for a distance of approximately 735 feet, in the Chino area.
 - (b) Establish a "No Parking of Vehicles/Tow-Away Zone" pursuant to County Code Section 52.0132(a) along the south sides of Phillips Boulevard from Roswell Avenue easterly to 300 feet west of Pipeline Avenue, for a distance of approximately 1,150 feet, in the Chino area.
2. The County Road Commissioner is hereby directed to perform such acts as are necessary to establish the Parking Restrictions above on Phillips Boulevard (652300), in the Chino area.
