**IT IS HEREBY AGREED AS FOLLOWS:**

**AMENDMENT NO. 1**

San Bernardino County (County), In-Home Supportive Services Public Authority (IHSS PA), and Elisabet Moreno (Contractor) agree to amend Contract No. 22-186, as follows:

**SECTION III. TERM** is amended to read as follows:

The Contract shall be effective March 26, 2022, and shall remain in effect through March 25, 2026, subject to termination provisions below. The Executive Director of IHSS PA is authorized to execute amendments to the Contract to extend the term for a maximum of two (2) successive one (1) year periods. Notwithstanding the foregoing, either party may terminate this Contract at any time, without cause, with a fourteen (14) day prior written notice to the other party. This Contract may be terminated for just cause immediately by the County. Contractor shall serve at the pleasure of the appointing authority, who shall have the full authority and discretion to exercise County rights under this paragraph.




IHSS PA and San Bernardino County are requesting to execute Amendment No. 1, exercising the option to extend the contract an additional one year with no change to the annual contract amount (with the exception of increases for cost of living and appropriate step increases). The Executive Director of In-Home Supportive Services' signature is required for the extension of the employment contract with Elisabet Moreno, Accounting Technician, through the delegation of authority authorized by the Board on March 15, 2022 (Item No. 60). The estimated annual cost of the contract is \$70,886 (\$56,904 Salary, \$13,982 Benefits) for the period of March 26, 2025 to March 25, 2026.
