### AMENDMENT NO. 3

Section 1. Paragraph D of Contract No. 14-858 (the "Contract") is amended so that the first paragraph reads as follows:

### D. TERM OF CONTRACT

This Contract is effective as of November 1, 2014, and expires October 31, 2020, but may be terminated earlier in accordance with provisions of this Contract.

Section 2. Subparagraph 2 of Paragraph F of the Contract is amended so that the first two paragraphs read as follows:

### F. FISCAL PROVISIONS

- F.2 The maximum amount of payment by the County under this Contract shall not exceed \$2,232,000, and shall be billed in accordance with the following fee schedule:
  - eChecks: \$0.00 (free)
  - Credit Cards: 2.29% (\$1.95 minimum)
  - PIN Debit Cards: \$3.95 flat fee

The Tax Collector Division shall not incur any charges under this Contract for the payment of property taxes, as eChecks are free and credit/debit card processing fees are paid by the taxpayer. It is estimated that the Central Collections Division will incur costs of \$2,232,000, as eChecks are free and credit/debit card processing fees are paid on behalf of debtors. These costs are withheld from collections and recovered prior to distribution to clients. The consideration to be paid to Contractor, as provided herein, shall be in full payment for all Contractor's services and expenses incurred in the performance hereof, including travel and per diem.

Section 3. All other terms and conditions of the Contract shall remain in full force and effect.
