#### Amendment No. 3 to Contract No. 17-202

Effective January 25, 2025, San Bernardino County (County) and Karen Haughey (CONTRACTOR) agree that Contract No. 17-202 is hereby amended as follows:

ADD SECTION IV. COMPENSATION OF CONTRACTOR, Paragraph N. AUTO ALLOWANCE, to the Agreement, which shall read as follows:

## N. AUTO ALLOWANCE

CONTRACTOR shall receive a bi-weekly auto allowance of \$100 without mileage reimbursement for mileage on County business in a privately owned automobile. With written approval of the Fourth District Supervisor, the CONTRACTOR shall be subject to adjustments to the bi-weekly automobile allowance (increases or decreases), but any adjustment shall be on a prospective basis only and any increase shall not exceed the maximum amount allowable for the Exempt Group B level benefit, pursuant to the terms and conditions set forth in the San Bernardino County Exempt Group Working Conditions Ordinance.

This Amendment No. 3 may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterparts shall together constitute one and the same Amendment No. 3. The parties shall be entitled to sign and transmit an electronic signature of this Amendment No. 3 (whether by facsimile, PDF or other email transmission), which signature shall be binding on the party whose name is
