THIS Amendment No. 1 to Contract No. 21-78 is entered into in the State of California by and between the County of San Bernardino, hereinafter called the County, and InfoMC, Inc. referenced above, hereinafter called Contractor.

#### IT IS HEREBY AGREED AS FOLLOWS:

#### WITNESSETH:

IN THAT CERTAIN **Contract No. 21-78** by and between the County of San Bernardino, a political subdivision of the State of California, and Contractor for management information system services, which Contract first became effective July 1, 2020, the following changes are hereby made and agreed to, effective July 1, 2021:

- I. The contract amendment amount of \$235,872 shall increase the total contract amount from \$183,488 to \$419,360 for the contract term.
- II. This amendment hereby adds Exhibit A-1 Schedule of Payments, License, Maintenance and Support Fees for fiscal years 2021-22 and 2022-23. All previously approved Exhibit A remain in effect.
- III. ARTICLE 7.0, Term and Termination, Paragraph 7.1. Term and Renewal is hereby amended to read as follows:

Term and Renewal. The initial term of this Agreement shall be for three (3) years from July 1, 2020 through June 30, 2023 inclusive. The County may, but is not obligated to, extend awarded contract(s) for up to two (2) additional one-year periods contingent on the availability of funds and Contractor performance.

IV. All other terms, conditions and covenants in the Contract remain in full force and effect.

This Agreement may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterparts shall together constitute one and the same Agreement. The parties shall be entitled to sign and transmit an electronic signature of this Agreement (whether by facsimile, PDF or other email transmission), which signature shall be binding on the party whose name is contained therein. Each party providing an electronic signature agrees to promptly execute and deliver to the other party an original signed Agreement upon request.
