ORDINANCE NO.

An ordinance of San Bernardino County, State of California, to repeal Ordinance No. 1642 and to grant Bear Valley Electric Service, Inc., its successors and assigns, a franchise for construction, use of property, and to transmit electricity.

The Board of Supervisors of the County of San Bernardino, State of California, ordains as follows:

SECTION 1. The Board of Supervisors of San Bernardino County finds as follows:

- (a) Bear Valley Electric Service, Inc. ("BVES"), is a California corporation and public utility transmitting and distributing electricity by means of poles, wires, conduits and appurtenances, subject to the Public Utilities Code of the State of California; and
- (b) BVES has applied for a franchise from San Bernardino County to construct and use certain rights-of-way and property for its transmission and distribution of electricity.

SECTION 2. BVES is hereby granted a franchise for an initial term not to exceed ten (10) years from the date BVES files an acceptance of said franchise and subject to the "Terms and Conditions of Franchise Issued to Bear Valley Electric Service, Inc." and acceptance thereof by BVES, as attached hereto and incorporated herein by this reference.

SECTION 3. San Bernardino County Ordinance No. 1642, passed and adopted on May 24, 1971, is hereby repealed in its entirety.

SECTION 4. The Clerk of the Board is directed to publish this ordinance in the manner and within the time prescribed by law.

SECTION 5. This ordinance shall take effect thirty (30) days from the date of adoption.
