(c) The findings set forth in the Report/Recommendation to the Board and Record of Action, adopted by this Board on November 15, 2022, concerning the Bloomington Business Park Specific Plan and amendment to the San Bernardino County Code are incorporated herein by reference and are hereby adopted by the Board.

SECTION 5.
