IT IS HEREBY AGREED AS FOLLOWS:

**AMENDMENT NO. 2 TO MEMORANDUM OF UNDERSTANDING AGREEMENT NO. 22-399
BETWEEN
THE SAN BERNARDINO COUNTY FIRE PROTECTION DISTRICT
AND
SAN BERNARDINO COUNTY
FOR FIRE PROTECTION AND EMERGENCY MEDICAL SERVICES**

WHEREAS, on June 14, 2022 (Item No. 110) the Board of Supervisors of San Bernardino County and the Board of Directors of the San Bernardino County Fire Protection District (Boards) approved Memorandum of Understanding No. 22-399 (the "MOU") to provide support to San Bernardino County Fire Protection District (DISTRICT) for the provision of fire protection and emergency medical services to San Bernardino County (COUNTY);

WHEREAS, on October 22, 2024 (Item No. 67) the Boards approved Amendment No. 1 to the MOU, increasing the total contract amount by \$1,200,000, from \$54,500,000 to \$55,700,000, for additional firefighting services, with no change to the term of July 1, 2022, through June 30, 2027;

WHEREAS, the DISTRICT and the COUNTY agree that the intent of the MOU is to maintain or enhance to the extent possible the current service levels to the citizens and businesses of the COUNTY;

WHEREAS, the DISTRICT and the COUNTY agree that the additional funding provided in this amendment to the MOU is to be used by the DISTRICT for the San Bernardino County Fire Hazard Abatement (FHA) Program as outlined in San Bernardino County Code Section 23.0301–23.0319 and that the primary function of the FHA Program is to reduce the risk of fires within communities by pro-actively establishing defensible space and reduction/removal of flammable materials on properties;

WHEREAS, the DISTRICT and the COUNTY agree to amend the MOU to increase the compensation amount by \$384,108 to the DISTRICT for providing FHA services; and

WHEREAS, this MOU is in addition to, and does not amend, terminate, or supersede any agreement between COUNTY and DISTRICT related to the “funding gap” associated with San Bernardino County Local Agency Formation Commission Order 3000, as this MOU has a different purpose.

NOW THEREFORE, effective as of July 1, 2026, the parties agree to amend the MOU as follows:

1. Section 4 of the MOU is amended to read as follows:

4. CONTRACT AMOUNT

COUNTY and DISTRICT agree to a total contract amount of \$56,084,108, as detailed in the annual schedule below, to support DISTRICT’s operations. The annual amount from COUNTY does not fund 100% of DISTRICT’s costs.

Amount provided to the DISTRICT under the agreement will be as follows:

COUNTY shall pay the annual amount to the DISTRICT no later than December 31st of each year.

2. All other terms of the MOU shall remain in full force and effect.

This Amendment No. 2 to the MOU may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterparts shall together constitute one and the same MOU. The parties shall be entitled to sign and transmit an electronic signature of this Amendment No. 2 to the MOU (whether by facsimile, PDF or other email transmission), which signature shall be binding on the party whose name is contained therein. Each party providing an electronic signature agrees to promptly execute and deliver to the other party an original signed Amendment No. 2 to the MOU upon request.


