IT IS HEREBY AGREED AS FOLLOWS:

The City of Adelanto (CITY) and the San Bernardino County Fire Protection District (SBCFPD) agree to amend Agreement No. 18-397 as follows:

1. Section 9 is deleted and replaced with the following Section 9, which shall read as follows:

9. Fire Apparatus and Equipment Maintenance:

- A. CITY hereby leases to SBCFPD the fire apparatus and equipment, described in "Exhibit 3," for the sum of \$1 per year for the duration of this Agreement, under the terms and conditions set forth in this Agreement. CITY shall be listed as owner and SBCFPD shall be listed as the registered owner of fire apparatus. During the term of this Agreement, SBCFPD shall maintain in good repair the apparatus and equipment and shall be financially responsible for minor maintenance and repairs. The CITY agrees to be responsible for all major apparatus and equipment repairs and/or replacements unless the need for such repairs and/or replacements are the result of the negligence or willful misconduct of SBCFPD, in which case SBCFPD shall be responsible for promptly completing and paying for the costs of such repairs and/or replacements. Major apparatus and equipment repairs shall be defined as engine, transmission, drive train, pump, and tank repairs which exceed \$5,000 for fire apparatus and \$2,000 for staff vehicles per occurrence (including labor costs). Except as otherwise provided herein, CITY shall remain financially responsible for new and replacement equipment, apparatus, and staff vehicles and shall provide for such in the CITY's annual budget as approved by CITY's Board. Except as otherwise provided herein, failure to replace equipment on schedule may be cause for the SBCFPD to direct bill the CITY for maintenance related repairs to such identified vehicles. SBCFPD shall include these costs as an element of the compensation paid by CITY.

- B. SBCFPD shall also utilize the fire apparatus described in "Exhibit 4," attached hereto and incorporated into the Agreement by reference, which is owned and shall remain the property of SBCFPD. The City agrees to reimburse SBCFPD for its costs associated with the use of the fire apparatus described in "Exhibit 4" by paying the rate of \$44,155 per fiscal year for the duration of this Agreement, under the terms and conditions set forth in this Agreement. The payment for Fiscal Year 2021-22 shall be made in advance on or before August 1, 2021, with subsequent fiscal year payments being due on August 1st of that fiscal year. SBCFPD will be responsible for all maintenance and repair costs of the fire apparatus. Should the fire apparatus be deemed by SBCFPD's Fire Chief to be no longer operational for a period of 30 days, SBCFPD agrees to provide replacement fire apparatus of similar specifications and use.

This Agreement may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterparts shall together constitute one and the same Agreement. The parties shall be entitled to sign and transmit an electronic signature of this Agreement (whether by facsimile, PDF or other email transmission), which signature shall be binding on the party whose name is contained therein. Each party providing an electronic signature agrees to promptly execute and deliver to the other party an original signed Agreement upon request.

All other terms of Agreement No. 18-397 shall remain in full force and effect.

This Amendment No. 4 shall take effect on July 1, 2021.

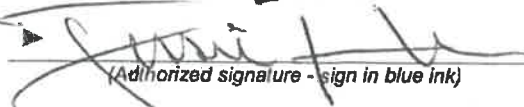
