IT IS HEREBY AGREED AS FOLLOWS:

Amendment No. 3

WITNESSETH:

IN THAT CERTAIN: Agreement No. 15-690 by and between the County of San Bernardino ("County") and Telios Training Solutions ("Contractor") for Independent Living Program Services, which first became effective September 15, 2015, the following changes are hereby made and agreed to effective August 1, 2020:

I. SECTION III TERM OF CONTRACT, the first paragraph is hereby amended to read as follows:

This Contract is effective as of September 15, 2015 and expires January 31, 2021 but may be terminated earlier in accordance with the provisions of this Contract.

II. SECTION IV FISCAL PROVISIONS, Paragraph B is hereby amended to read as follows:

B. The maximum amount of payment under this Contract shall not exceed \$495,000 and shall be subject to the availability of other funds to the County. The consideration to be paid to Contractor, as provided herein, shall be in full payment for all of Contractor's services and expenses incurred in the performance hereof, including travel and per diem.

III. SECTION XI ELECTRONIC SIGNATURES, is hereby added to read as follows:

This Contract may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterparts shall together constitute one and the same Contract. The County and Contractor shall be entitled to sign and transmit an electronic signature of this Contract (whether by facsimile, PDF or other email transmission), which signature shall be binding on the party whose name is contained therein. Each party providing an electronic signature agrees to promptly execute and deliver to the other party an original signed Contract upon request.

IV. All other terms, conditions, and covenants in Contract No. 15-690 remain in full force and effect.
