AMENDMENT No. 2 CONTRACT No. 16-24 Job Order Contracting Consultant Services

The following are amendments to Contract No. 16-24 with The Gordian Group, Inc. dba The Mellon Group for Job Order Contracting consultant services.

Section 1. Replace Section VI, Fiscal Provisions, Paragraph C, with the following:

V. FISCAL PROVISIONS

- C. The maximum amount of payment under this Contract shall not exceed Four Million Four Hundred Thousand Dollars (\$4,400,000), and shall be subject to availability of other funds to the County. The Consideration to be paid to Vendor, as provided herein, shall be in full payment for all Vendor's services and expenses incurred in the performance hereof, including travel and per diem.

Section 2. The new Contract Sum is \$4,400,000.

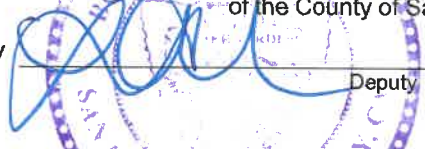
Section 3. The Agreement completion date remains January 11, 2021.

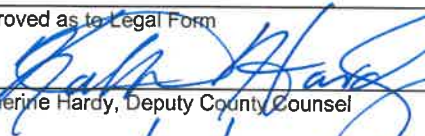

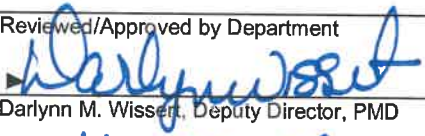
