AMENDMENT NO. 1

It is hereby agreed to amend Contract No. 22-1010, as follows:

SECTION B. ROLLING START, INC. RESPONSIBILITIES

Amend Item B.16. to read as follows:

- 16. Receive referrals from the Department of Aging and Adult Services, including, but not limited to Senior Information and Assistance line, Adult Protective Services, and other Aging programs.

SECTION C. COUNTY RESPONSIBILITIES

Amend Items C.7. and C.17. to read as follows:

- 7. Participate in a local ADRC Advisory Committee to engage with local consumers and other stakeholders.
- 17. Receive referrals from Rolling Start, Inc., through the Senior Information and Assistance line for any DAAS programs.

SECTION VIII. TERM

Amend Section VIII. Term to read as follows:

This Amendment is effective as of July 1, 2022, and is extended from the original expiration date of June 30, 2025 to expire on June 30, 2026, but may be terminated earlier in accordance with provisions of Section IX of this MOU.

All other terms and conditions of Contract No. 22-1010 shall remain in full force and effect.

This Amendment may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterparts shall together constitute one and the same Contract. The parties shall be entitled to sign and transmit an electronic signature of this Contract (whether by facsimile, PDF or other email transmission), which signature shall be binding on the party whose name is contained therein. Each party providing an electronic signature agrees to promptly execute and deliver to the other party an original signed Contract upon request.
