IT IS HEREBY AGREED AS FOLLOWS:

AMENDMENT NO. 1

It is hereby agreed to amend Contract No. 22-1008 with UC Davis Koret Shelter Medicine, effective September 1, 2023, as follows:

Section 3. Term is amended to read as follows:

This contract is effective as of September 1, 2022, and is being amended from its original expiration date of August 31, 2023, to a new amended expiration date of August 31, 2024.

Exhibit A, Scope of Work is amended to include:

San Bernardino County will reallocate original grant funds received into three projects:

1. The vet care fund for shelter animals. (Original grant scope)
2. Establish a veterinary care fund for owned/community pets

- a. Veterinary Care provided by contract veterinary practitioners or veterinary medical vouchers offered to pet owners to obtain necessary veterinary care.
- 3. Purchase of engraving machines, tags, collars to be shared with other shelters across San Bernardino County
 - a. Purchase fifteen (15) pet tag engraving machines and 15,000 pet collars and tags

All other terms and conditions of Contract remain in full force and effect.

This Agreement may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterparts shall together constitute one and the same Contract. The parties shall be entitled to sign and transmit an electronic signature of this Contract (whether by facsimile, PDF, or other email transmission), which signature shall be binding on the party whose name is contained therein. Each party providing an electronic signature agrees to promptly execute and deliver to the other party an original signed Contract upon request.
