ORDINANCE NO.

An ordinance of San Bernardino County, State of California, to repeal Chapters 1, 1.5, 2, 3, 4, 5, 13, 14, 15, 18, 19, 20 and 21 of Division 3 of Title 6 of the San Bernardino County Code, and to add Chapters 1, 1.5, 2, 3, 4, 5, 6, 13, 14, 15, 18, 19, 20 and 21 to Division 3 of Title 6 of the San Bernardino County Code, relating to adoption and amendment of the codes set forth in the 20222025 California Building Standards Code and the adoption of the 20212024 International Property Maintenance Code, and the 20212024 International Swimming Pool and Spa Code.

The Board of Supervisors of the County of San Bernardino, State of California, ordains as follows:

SECTION 1. The Board of Supervisors of San Bernardino County finds as follows:

(a) The purpose of this ordinance is to repeal current applicable chapters of Division 3 of Title 6 of the San Bernardino County Code, which adopt by reference certain codes and appendices set forth in the 20192022 California Building Standards Code, and to adopt by reference updated editions of these codes and appendices set forth in the 20222025 California Building Standards Code (Title 24 of the California Code of Regulations), including the California Wildland-Urban Interface Code, 2025 Edition, contained in Part 7 of Title 24 of the California Code of Regulations.

(b) The purpose of this ordinance is also to repeal current applicable chapters of Division 3 of Title 6 of the San Bernardino County Code, which adopt by reference the 20182021 International Property Maintenance Code and the 20182021 International Swimming Pool and Spa Code, and to adopt by reference updated 20212024 Editions of these codes.

(c) Only those appendices of the respective codes that are expressly identified and adopted by reference are adopted by San Bernardino County (County) pursuant to this ordinance.

(d) The adoption of amendments to some of these codes are reasonably necessary due to local climatic, geological, or topographical conditions, including, when applicable, environmental conditions. Where the Board of Supervisors (Board) finds that amendments are necessary, this ordinance makes express findings supporting the amendment, identifies the section of the applicable code being amended, and distinguishes the amended text from the text of the code not otherwise being amended.

(e) Adoption of such codes provide minimum requirements and standards for the protection of the public safety, health, property, and welfare in the unincorporated area of the County.

(f) This ordinance is adopted under the authority of Government Code section 50022.2 and Health and Safety Code sections 17958, 17958.5, 17958.7 and 18941.5, and is exempt from the California Environmental Quality Act (CEQA) in that, pursuant to CEQA Guidelines section 15061(b)(3), it can be seen with certainty that there is no possibility that the ordinance may have a significant effect on the environment.

SECTION 2. Chapters 1, 1.5, 2, 3, 4, 5, 13, 14, 15, 18, 19, 20 and 21 of Division 3 of Title 6 of the San Bernardino County Code are repealed.

SECTION 3. Chapter 1 is added to Division 3 of Title 6 of the San Bernardino County Code, to read:

1 **63.0101 Adoption of California Building Code.**

2 A copy of the ~~2021~~2024 Edition of the International Building Code, volumes 1 and
3 2, prepared and published by the International Code Council, with state amendments,
4 also known as the ~~2022~~2025 California Building Code, contained in Part 2 of Title 24 of
5 the California Code of Regulations, having been filed in the Office of the Clerk of the
6 Board of Supervisors of San Bernardino County, is hereby designated and adopted by
7 reference as the Building Code for the unincorporated area of San Bernardino County,
8 State of California, subject to those amendments and limitations as set forth in this
9 Chapter 1.

10 **63.0102 Express Findings.**

11 It is expressly found and determined that a less restrictive amendment to Appendix
12 J in the 2025 California Building Code and as reflected in County Code section 63.0104
13 is reasonably necessary due to local conditions, including administrative and
14 topographical conditions as they relate to grading in the unincorporated region of San
15 Bernardino County.

16 **63.01023 Adoption of Code Appendices.**

17 Appendices ~~C~~ C - "Group U - Agricultural Buildings," Appendix I - "Patio Covers,"
18 and Appendix J - "Grading" of the ~~2022~~2025 California Building Code are hereby adopted
19 by reference as part of the Building Code for the unincorporated area of San Bernardino
20 County, State of California, with Appendix J being subject to those amendments and
21 limitations as set forth in this Chapter 1.

22 **63.01034 Changes in the Appendices.**

23 (a) Appendix J - "Grading" is hereby amended by adding exemption 8 to
24 Section J103.2 entitled "Exemptions" to read:

25 8. The sum of the total excavation and fill not exceeding 100 cubic
26 yards.

27 **63.01045 Relocation Permits.**

28 (a) *Relocation Building Permit Required.* A person shall not move onto any

premises, other than a commercial storage yard authorized for such use, any building or structure, except a contractor's tool shed, storage building or similar structure which is moved as construction requires, until he or she first secures a relocation building permit as hereinafter provided.

(b) *Application.* An applicant for a relocation permit shall submit photographs of at least two separate elevations, one of which shall be the front, and a certificate from a pest control agency or operator licensed under the Structural Pest Control Act of California, showing freedom from termite infestation, for each building or structure to be moved, when application for a relocation permit is filed.

(c) *Structural Observation Report Fee.* An applicant for a relocation permit shall pay a structural observation report fee at the time of submittal. The fee shall be in accordance with Chapter 2 of Division 6 of Title 1 of the San Bernardino County Code (Schedule of Fees).

(d) *Building and Relocation Site Inspection Report.* Upon receipt of an application for permit to relocate a building or structure, a detailed structural observation report by a civil or structural engineer, or an architect licensed by the State of California to practice as such, shall be submitted. The report shall describe any structural deficiencies and all non-structural code-related deficiencies and be stamped and signed by the reporting engineer or architect. This report shall be approved or disapproved by the Building Official. If approved for moving, the report shall contain the requirements necessary to make the building or structure comply with Chapter 14 of the 20222025 California Existing Building Code and any additional requirements necessary to assure that such relocation shall not have detrimental effect by size, design, or age on the living environment and property values in the area into which the building or structure is to be moved.

(e) *Report Validity.* Additional corrections may be added to the report whenever the structure has been vandalized, damaged during transportation, or altered in any manner after the structural observation report has been submitted for review.

1 (f) *Changes.* The applicant shall make all required changes within 180 days
2 and shall agree in writing to do so. This time limitation may be extended by the Building
3 Official upon receipt of evidence of just and proper cause; provided, however, that no
4 such extension shall be granted when, in his or her judgment, such an extension would
5 be detrimental to the public welfare for any cause or reason.

6 (g) *Declaration of Public Nuisance.* When any relocated building or structure
7 or portion thereof remains unfinished or unfit for occupancy after expiration of the time
8 limit herein specified, any and all permits pertaining thereto shall expire by limitation and
9 such building or structure or portion thereof is hereby declared a public nuisance and shall
10 be abated as authorized by the County Code and as provided by law.

11 **63.01056 Appeals Boards.**

12 (a) *Building and Safety Appeals Board.* In order to hear and decide appeals of
13 orders, decisions or determinations made by the Building Official relative to the
14 application and interpretation of the California Building Standards Code, and its
15 amendments, the County Code and the building requirements of the County, or other
16 applicable law, the Building and Safety Appeals Board is hereby established pursuant to
17 Section 1.8.8 of the California Building Standards Code, as adopted herein.

18 (1) *Membership.* The Building and Safety Appeals Board shall include
19 five regular members and three alternate members. Members shall be appointed at large.
20 No County employees shall be members of this board. All members - regular and
21 alternate - must have knowledge, experience and training to review and reach decisions
22 on matters pertaining to building construction and applicable building codes, regulations,
23 and ordinances. Members shall serve a term of four years. In addition to the board
24 members and the alternate members, the Building Official shall be an ex-officio member
25 and shall act as secretary to the board. The members of the appeals board shall be
26 appointed by the Board of Supervisors and shall hold office at its pleasure. Terms of
27 office shall be staggered. Three of the initial appointments for regular members and one
28 of the initial appointments for alternate members to the board shall be for two-year terms.

1 A member whose term has expired shall continue to serve in that capacity until a new
2 appointment is made by the Board of Supervisors. Upon recommendation of the County
3 Chief Executive Officer or his or her designee, members may be removed by a majority
4 vote of the Board of Supervisors.

5 (2) *Meetings.* A quorum shall be a meeting of at least three members.
6 Alternate members may sit on the board in the absence of any regular members and shall
7 be counted towards the quorum of three if there is an insufficient number of regular
8 members available. A regular meeting shall be held at least once annually at a date and
9 time established by a resolution of the Board of Supervisors. Rules for notice and conduct
10 of the Building and Safety Appeals Board meetings, including without limitation all regular,
11 adjourned regular and special meetings, shall be pursuant to the terms of this section and
12 shall be in accordance with the provisions of the Ralph M. Brown Act (Government Code
13 section 54950 et seq.). The members shall be reimbursed as provided by County Code
14 section 13.0618(b).

15 (3) *Responsibilities and Authority.* The Building and Safety Appeals
16 Board shall conduct hearings on appeals of orders, decisions, and determinations made
17 by the Building Official relative to the applications and interpretation of the California
18 Building Standards Code, and other regulations governing the use, maintenance, and
19 change of occupancy. The Building and Safety Appeals Board shall have no authority to
20 waive requirements of the California Building Standards Code or the County Code. All
21 decisions of the Building and Safety Appeals Board shall be rendered in writing. The
22 Building and Safety Appeals Board shall meet as necessary in order to abide by the
23 scheduling provisions of County Code section 63.01056(c)(4). An application for appeal
24 shall be based on a claim that the Building Code, as adopted herein, or the County Code,
25 or the rules legally adopted thereunder, have been incorrectly interpreted, or do not fully
26 apply, or that an equally good or better form of construction is proposed. The Building
27 and Safety Appeals Board shall also function as the "local appeals board" and the
28 "housing appeals board" specified in the California Health and Safety Code sections

17920.5 and 17920.6.

(b) *Physically Disabled Access Appeals Board.* For the purpose of considering written appeals to the actions taken by the Building Official in the exercise of its or his or her responsibility and authority as specified herein and to ratify certain exemption actions of the Building Official in enforcing the accessibility requirements of Title 24 of the California Code of Regulations for privately funded construction, and to serve as an advisor to the Building Official on disabled access matters, there is hereby established the Physically Disabled Access Appeals Board.

(1) *Membership.* The Physically Disabled Access Appeals Board shall consist of five regular members as follows: a minimum of two physically disabled members; two members experienced in the professions or disciplines of construction; and one member of the public. The Building Official shall be an ex officio member and shall act as secretary to the board. The two members experienced in the professions or disciplines of construction shall be regular or alternate board members from the Building and Safety Appeals Board, and shall be so designated by majority vote of that board. The two physically disabled members and the one public member may, but are not required to be, members of the Building and Safety Appeals Board. The Physically Disabled Access Appeals Board shall also have a panel of three alternate members. Said alternate panel must consist of one physically disabled member, one member experienced in the professions or disciplines of construction as designated by the Building and Safety Appeals Board, and one member of the public. A regular member may only be substituted by an alternate member of the same classification. The members of the Physically Disabled Access Appeals Board shall be appointed by the Board of Supervisors and shall hold office at its pleasure. Terms of office shall be for four years, and for members appointed to both the Building and Safety Appeals Board and the Physically Disabled Access Appeals Board said terms shall be served concurrently. However, as to one of the initial appointments for an individual with a disability, the initial appointment shall be for two years to allow for the terms of office to be staggered. A member whose term has

1 expired shall continue to serve in that capacity until a new appointment is made by the
2 Board of Supervisors. Upon recommendation of the County Chief Executive Officer or
3 his or her designee, members may be removed by majority vote of the Board of
4 Supervisors.

5 (2) *Meetings.* All meetings of the Physically Disabled Access Appeals
6 Board, including without limitation, regular, adjourned regular and special meetings, shall
7 be conducted pursuant to the terms of this section and called, noticed, held and
8 conducted in accordance with the provisions of the Ralph M. Brown Act (Government
9 Code section 54950 et seq.). The members shall be reimbursed as provided by County
10 Code section 13.0618(b).

11 (3) *Responsibilities and Authority.* The Physically Disabled Access
12 Appeals Board shall serve as the "local appeals board" specified in Section 19957.5 of
13 the California Health and Safety Code in appeals relating to accommodations for the
14 physically disabled. The authority of the Physically Disabled Access Appeals Board shall
15 consist of the conducting of appeals for the purpose limited to that expressed in California
16 Health and Safety Code sections 19955 through 19959. All decisions of the Physically
17 Disabled Access Appeals Board shall be rendered in writing.

18 (c) *Appeal.* Unless otherwise provided, reference to "Appeals Board" shall
19 refer to the Building and Safety Appeals Board or Physically Disabled Access Appeals
20 Board, whichever is applicable.

21 (1) *Timing and Form of Appeal.* The Building Official shall have the right
22 to appeal to the Appeals Board, provided that a written application for appeal is filed within
23 20 days after the decision, determination, or notice and order was served. An application
24 for appeal shall be based on a claim that the true intent of the applicable code or rules
25 legally adopted thereunder have been incorrectly interpreted, or that the provisions of the
26 applicable code or rules legally adopted thereunder do not fully apply or that the
27 requirements of the applicable code or the rules legally adopted thereunder are
28 adequately satisfied by other means. The appeal shall be made in writing and filed along

1 with the appeal fee with the appropriate County office. The written appeal shall contain:

2 (A) A heading containing the words "Before the Building and
3 Safety Appeals Board of San Bernardino County" or "Before the Physically Disabled
4 Access Appeals Board of San Bernardino County," whichever is applicable.

5 (B) A caption reading: "Appeal of ... " giving the names of all
6 appellants participating in the appeal;

7 (C) A brief statement setting forth the legal interest of each of the
8 appellants;

9 (D) A brief statement in ordinary and concise language of the
10 specific order or action protested, together with any material facts claimed to support the
11 contentions of the appellant;

12 (E) A brief statement in ordinary and concise language of the
13 relief sought and the reasons why it is claimed the protested order or action should be
14 reversed, modified, or otherwise set aside;

15 (F) The signatures of all parties named as appellants and their
16 official mailing addresses; and

17 (G) The verification (by declaration under penalty of perjury) of at
18 least one appellant as to the truth of the matters stated in the appeal.

19 (2) *Processing of Appeal.* Upon receipt of any appeal and the applicable
20 fee filed pursuant to this section, the Building Official shall present it at the next regular
21 or special meeting of the Appeals Board.

22 (3) *Limitation to Appeal.* Limit of one appeal hearing per property or
23 parcel relative to the same notice and order or action of the Building Official may be heard
24 by an Appeals Board. If appellants consist of both property owners and any interested
25 parties of record, appellants must jointly file an appeal, and the appeal hearing must be
26 conducted jointly amongst all appellants.

27 (4) *Scheduling and Noticing of Appeal Hearing.* As soon as practicable
28 after receiving the written appeal and appeal fee, the Appeals Board shall fix a date, time,

1 and place for the hearing of the appeal by the board. Such date shall not be less than 10
2 days nor more than 60 days from the date the appeal was filed with the Building Official,
3 subject to any stay pending a decision to grant or deny an appeal fee hardship waiver
4 request. Written notice of the time and place of the hearing shall be given at least 10
5 days prior to the date of the hearing to each appellant and any interested parties of record
6 discovered through reasonable diligence, through either personal service or first class
7 mail, each appellant at the address shown on the appeal, and to the interested party of
8 record at the party's last known address. Notice by mail shall be deemed effective on the
9 date of deposit.

10 (5) *Open Hearing.* Hearings before the Appeals Board shall be open to
11 the public. The appellant, the appellant's representative, the Code Official and any
12 person whose interests are affected shall be given an opportunity to be heard.

13 (6) *Waiver of Appeal Fee for Financial Hardship.* Any appellant who is
14 financially unable to pay the required appeal fee may file a written request for an appeal
15 fee hardship waiver. The written request must be filed prior to or contemporaneous with
16 the filing of the appeal. The written request shall be filed with the Building Official. The
17 appellant requesting the appeal fee hardship waiver shall indicate on the written appeal
18 that an appeal fee hardship waiver request has been filed.

19 (7) *Appeal Fee Hardship Waiver Evaluation Procedures.* Hardship
20 waivers shall be granted based on the grounds provided by County Code section 16.0231
21 or other applicable authority in the County Code or law. Requests will only be considered
22 if the appellant requesting the waiver submits a sworn affidavit, together with any
23 supporting documents or materials, reasonably demonstrating the appellant's actual
24 financial inability to submit the appeal fee. A written decision to grant or deny the request
25 shall be made not less than 10 days nor more than 60 days after submission of the
26 request. If the request is denied, the written decision shall explain the reason for denial
27 and shall state the due date - not less than 10 days nor more than 60 days from the date
28 of the decision - for payment of the appeal fee. The written decision shall be sent via first

1 class mail to the appellant and shall be final. An appeal hearing shall not be scheduled
2 until the appeal fee is received. If the request is denied and the appeal fee is not remitted
3 within the time indicated in the written decision, the right to an appeal shall be deemed
4 waived and the notice and order or the action of the Building Official shall become final.

5 (8) *Effect of Failure to Appeal.* Failure of any person or entity to file an
6 appeal in accordance with the provisions of Section 63.010~~56~~(c)(1) shall constitute a
7 waiver of the right to an appeal hearing and the Building Official or the Code Official's
8 notice and order or action shall become final.

9 (9) *Scope of Hearing on Appeal.* Only those matters or issues
10 specifically raised by the appellant shall be considered in the hearing of the appeal.

11 (10) *Stay Pending Appeal.* Except for vacation orders issued by the
12 Building Official because of conditions that represent an immediate threat to life, limb,
13 property, or safety of the public or adjacent properties, enforcement of any notice and
14 order of the Building Official shall be stayed during the pendency of an appeal therefrom
15 which is properly and timely filed.

16 (11) *Hearing and Decision.* The decision of the Appeals Board shall be
17 final; there is no further administrative appeal.

18 (d) *Procedures for Conduct of Hearing of Appeals.*

19 (1) *Hearing Examiners.* The Appeals Board may designate one or more
20 of its members to serve as a hearing examiner to conduct the hearing of an appeal to the
21 board. The examiner hearing the case shall exercise all powers relating to the conduct
22 of hearings until it is submitted to the Appeals Board for decision. Decisions and actions
23 of the Building Official regarding the enforcement of the requirements of Health and
24 Safety Code sections 19955 through 19959 shall be appealed to the Physically Disabled
25 Access Appeals Board. Appeals to the Physically Disabled Access Appeals Board must
26 be heard in front of that board as a whole.

27 (2) *Record.* A record of the entire proceedings shall be made by
28 electronic recording or by any other means of tangible recording determined to be

appropriate by the Appeals Board. A transcript of the recording will be made available to any party that requests a transcript in writing accompanied with the transcription fee established by the County Fee Ordinance. If no transcription fee has been established by the County Fee Ordinance, then the fee shall be the full actual cost of transcribing the requested recordings into print form as established by a transcription service, and shall be paid prior to transcription services being rendered.

(3) *Continuances and Postponements.* The Appeals Board may grant a continuance for good cause shown. If a hearing examiner has been assigned to a hearing, the examiner may grant a continuance for good cause shown so long as the matter remains before the examiner.

(4) *Oaths—Certification.* In any proceedings under this chapter, the Appeals Board, any board member, or the hearing examiner has the power to administer oaths and affirmations and to certify official acts.

(5) *Reasonable Dispatch.* The Appeals Board and its representatives shall proceed with reasonable dispatch to conclude any matter before it. Due regard shall be shown for the convenience and necessity of any parties and/or their representatives.

(6) *Form of Notice of Hearing.* The notice to appellant shall be substantially in the following form, but may include other information:

“You are hereby notified that a hearing will be held before (the Building and Safety Appeals Board, Physically Disabled Access Appeals Board or name of hearing examiner, whichever is applicable) at _____ on the day _____ of _____, 20____, at the hour of _____. You may be present at the hearing. The hearing will proceed as noticed in absentia if you elect not to be present. You may be, but need not be, represented by counsel, even if you elect not to be present. You may present any relevant evidence and will be given full opportunity to cross-examine all witnesses testifying against you. You may request the issuance of subpoenas to compel the attendance of witnesses and the production of books, documents, or other

1 things by filing an affidavit therefore with (Building and Safety Appeals
2 Board, Physically Disabled Access Appeals Board or name of hearing
3 examiner, whichever is applicable).”

4 (7) *Subpoenas.*

5 (A) *Filing of Affidavit.* A subpoena may be issued for the
6 attendance of witnesses or the production of other evidence at a hearing upon the request
7 of a member of the Appeals Board or a hearing examiner, or upon the written demand of
8 any party. The subpoena must be accompanied by an affidavit that states the name and
9 address of the proposed witness and/or specifies the exact things sought to be produced
10 and the materiality thereof, and states that the witness has the desired things in
11 possession or under control. A subpoena need not be issued when the affidavit is
12 defective.

13 (B) *Cases Referred to Hearing Examiner.* In cases where a
14 hearing is referred to an examiner, all subpoenas shall be obtained through the examiner.

15 (C) *Penalties.* Any person who refuses without lawful excuse to
16 attend any hearing or produce material evidence which the person possesses or controls,
17 as required by any subpoena served upon such person as provided herein, shall be guilty
18 of a misdemeanor.

19 (8) *Conduct of Hearing.*

20 (A) *Rules.* Hearings need not be conducted according to the
21 technical rules of evidence. The following rules shall apply:

22 (I) *Oral Evidence.* Oral evidence shall be taken only on
23 oath or affirmation.

24 (II) *Hearsay Evidence.* Hearsay evidence may be used for
25 the purpose of supplementing or explaining any direct evidence, but shall not be sufficient
26 in itself to support a finding unless it would be admissible over objection in civil actions in
27 a court of competent jurisdiction in this state.

28 (III) *Admissibility of Evidence.* Any relevant evidence shall

1 be admitted if it is the type of evidence that responsible persons are accustomed to relying
2 on in the conduct of serious affairs, regardless of the existence of any common law or
3 statutory rule which might make improper the admission of such evidence over objection
4 in civil actions in courts of competent jurisdiction in this state.

5 (IV) *Exclusion of Evidence.* Irrelevant and unduly
6 repetitious evidence shall be excluded.

7 (B) *Rights of Parties.* Each party shall have these rights, among
8 others:

9 (I) To call and examine witnesses on any matter relevant
10 to the issues of hearing;

11 (II) To introduce documentary and physical evidence;

12 (III) To cross-examine opposing witnesses on any matter
13 relevant to the issues of the hearing;

14 (IV) To impeach any witness regardless of which party first
15 called the witness to testify;

16 (V) To rebut evidence; and

17 (VI) To be represented by anyone who is lawfully permitted
18 to do so.

19 (9) *Official Notice.*

20 (A) *What may be noticed.* The Appeals Board or hearing
21 examiner may take official notice of any matter that may be judicially noticed by the courts
22 of this state or any official records of the County or any department and ordinances of the
23 County or rules and regulations of the County.

24 (B) *Parties to be notified.* Parties present at the hearing shall be
25 informed of the matters to be noticed, and these matters shall be noted in the record,
26 referred to therein, or appended thereto.

27 (C) *Opportunity to refute.* Parties present at the hearing shall be
28 given a reasonable opportunity, upon the request of a party, to refute any officially noticed

1 matters with the manner of such refutation to be determined by the Appeals Board or
2 hearing examiner.

3 (10) *Inspection of the premises.* The Appeals Board or the hearing
4 examiner may inspect any building or premises involved in the appeal during the course
5 of the hearing, provided that:

6 (A) Notice of such inspection shall be given to the parties before
7 the inspection is made;

8 (B) The parties are given an opportunity to be present during the
9 inspection; and

10 (C) The Appeals Board or the hearing examiner shall state for the
11 record upon completion of the inspection, the material facts observed and the conclusions
12 drawn therefrom. Each party then shall have a right to rebut or explain the matters so
13 stated by the Appeals Board or hearing examiner.

14 (11) *Method and Form of Decision.*

15 (A) *Hearing before the Board itself.* When the Appeals Board
16 hears an appeal, a member thereof who did not hear the evidence or has not read the
17 entire record of the proceedings shall not vote on or take part in the decision.

18 (B) *Hearing before the Examiner.* If a contested case is heard by
19 a hearing examiner alone, the examiner shall within a reasonable time (not to exceed 90

25 record. A copy of the report shall be mailed to each party on the date it is filed with the
26 Appeals Board.

27 (C) *Consideration of Report by Board — Notice.* The Appeals
28 Board shall fix the time, date, and place to consider the examiner's report. Notice thereof

1 shall be mailed to each interested party not less than five days prior to the date fixed,
2 unless it is otherwise stipulated by all of the parties.

3 (D) *Exceptions to Report.* Not later than two days before the date
4 set to consider the report, any party may file written exceptions to any part or all of the
5 examiner's report and may attach thereto a proposed decision together with written

1 damage, or by other means, 50 feet does not provide sufficient separation to prevent
2 contamination of nearby wells from the leaking contents.

3 (d) Geologic conditions within the County make increasing the minimum
4 separation between a well and a soil absorption portion of a sewage disposal system
5 discharging 5,000 gallons per day or more from 100 feet to 200 feet reasonably necessary
6 for the protection of water quality in water supply wells. Local soils are generally porous
7 so that where large volumes of sewage effluent are discharged closer than 200 feet, the
8 cone of depression created by pumping a well may intercept significant amounts of

Chapters 4 through 6 of the ~~2021~~2024 International Swimming Pool and Spa Code is hereby deleted in its entirety, and Chapters 1 through 3 and Chapters 7 through 11 of the ~~2021~~2024 International Swimming Pool and Spa Code is hereby amended, deleted, or added to as follows:

Amend Section 101.1 as follows:

101.1 Title. These regulations shall be known as the International Swimming Pool and Spa Code for the unincorporated area of San Bernardino County, State of California, hereinafter referred to as "this code."

Delete Sections 101.2 through 102.10 of Part 1-Scope and Application.

Amend Section 103.1 in its entirety to read as follows:

103.1 Administration. For administrative issues please reference the ~~2022~~2025 California Administrative Code adopted herein.

2 **Delete Sections 103.2 through 108 of Part 2-Administrative and Enforcement.**

4 **Add Section 301.1.2 as follows:**

5 301.1.2 In the event of a conflict between the provisions of the Swimming Pool
6 Safety Act, the International Swimming Pool and Spa Code, ~~2021~~2024 Edition, the
7 ~~2022~~2025 California Building Code, or the ~~2022~~2025 California Residential Code, the
8 Building Official shall implement the most restrictive measures cited.

9
10 SECTION ~~16~~17. References in County forms, documents, and regulations to the
11 former ~~2019~~2022 California Building Standards Code adopted in Title 6 of the San
12 Bernardino County Code, shall be construed to apply to the most current and adopted
13 corresponding provisions contained within Title 6 of the San Bernardino County Code.
14 San Bernardino County Ordinance No. ~~4375~~4452 and all other ordinances or parts of
15 ordinances in conflict herewith are hereby superseded and expressly repealed.

16
17 SECTION ~~17~~18. The Board of Supervisors declares that it would have adopted
18 this ordinance and each section, sentence, clause, phrase, or portion of it irrespective of
19 the fact that any one or more sections, subsections, clauses, phrases or portions of it be
20 declared invalid or unconstitutional. If for any reason any portion of this ordinance is
21 declared invalid or unconstitutional, then all other provisions of it shall remain valid and
22 enforceable.

24 SECTION ~~18~~19. This ordinance shall take effect ~~January 5, 2023~~January 1, 2026.
