IT IS HEREBY AGREED AS FOLLOWS:

Amendment No. 3 to Contract No. 22-853

Effective January 25, 2025, San Bernardino County (County) and Suzette Dang (Contractor) agree that Contract No. 22-853 is hereby amended as follows:

- 1. ADD Subsection S., PORTABLE COMMUNICATIONS ALLOWANCE to SECTION IV., COMPENSATION OF CONTRACTOR, to reflect the following:
 - S. PORTABLE COMMUNICATION DEVICE ALLOWANCE

 CONTRACTOR shall receive a bi-weekly portable communication device allowance of \$92.31. With written approval of the Fourth District Supervisor, the CONTRACTOR shall be subject to adjustments to the bi-weekly portable communication device (increases or decreases), but any increase shall not exceed the maximum amount allowable for the Exempt Group B level benefit, pursuant to the terms and conditions set forth in the San Bernardino County Exempt Group Working Conditions Ordinance.

This Amendment No. 3 may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterparts shall together constitute one and the same Amendment No. 3. The parties shall be entitled to sign and transmit an electronic signature of this Amendment No. 3 (whether by facsimile, PDF or other email transmission), which signature shall be binding on the party whose name is
