### IT IS HEREBY AGREED AS FOLLOWS:

#### **Amendment No. 2 to Contract No. 18-502**

The County of San Bernardino ("County") and Golden West Arbor Services, Inc. ("Contractor" or "Vendor"), agree to amend Contract No. 18-502 as follows:

1. DELETE paragraph B.1. in Article IV., "FISCAL PROVISIONS," and REPLACE it with a revised paragraph B.1., which shall now read as follows:

#### **B. Contract Amount**

1. The amount of this Agreement shall not exceed \$2,250,000.
2. All other terms and conditions of Contract No. 18-502 shall remain unchanged
3. This Amendment No. 2 shall take effect on the date it is last signed by both County and Contractor.
4. This Amendment may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterparts shall together constitute one and the same Amendment. The parties shall be entitled to sign and transmit an electronic signature of

this Amendment (whether by facsimile, PDF or other email transmission), which signature shall be binding on the party whose name is contained therein. Each party providing an electronic signature agrees to promptly execute and deliver to the other party an original signed Amendment upon request.
